On May 12, 2022, I received notice of a FEC Complaint filed against me for a possible violation of the Federal Election Campaign Act of 1971 as amended.

Summary: On April 7, 2021, I announced my campaign for Illinois Secretary of State and my associated committee, was Citizens for Pat Dowell.

On January 5, 2022, I announced that I was suspending my race for Illinois Secretary of State and launched a federal campaign for Congress in the Illinois' First District on January 6, 2022, my associated committee is Pat Dowell for Congress (C00799659).

I did not continue to use nonfederal political funds to pay for routine campaign expenditures for my Congressional campaign through March 31, 2022. I did not spend \$169,024,06 on campaign expenses from my nonfederal account Citizens for Pat Dowell after my announcement that I was no longer running for Illinois Secretary of State.

I respectfully request that no action be taken against me related to this MUR because as the affidavit attached from my accountant will show that a dismissal would be appropriate because the seriousness of the alleged conduct is not sufficient to justify the likely cost of an investigation to determine whether there is probable cause to believe a violation in fact occurred, or the evidence is sufficient to support a reason to believe finding but the violation is minor and has already been remedied.
