Hello Kathryn,

As you the additional items in question:

Complaint 1: Camero purchase I have no relocation of a Cameo purchase.

Complaint 2: Mrs Wirth rode along with a friend attending a dinner in northern Kentucky. Mrs. Wirth was an additional passenger incurring no extra cost.

Complaint 3: Mr. Rogers had a broken washing machine to which Mrs Wirth paid to help replace. This was a personal matter, strictly outside the campaign.

Complaint 4: Disclaimer was wrongly printed by the newspaper, a very small rural newspaper unfamiliar with proper disclosures and believed the disclosure as written was sufficient.

Complaint 5: Facebook page transfer. Facebook fan page had zero monetary value and was not being used. Mrs. Wirth changed the name of her own page. The 'Thank You Trump' page both started and ended well before Mrs. Wirth's campaign.

Please note, all these complaints came from TJ Roberts, which surrounded Mrs. Claire and verbally berated her alone in a parking lot. TJ Roberts (who is 6'3") along with his friends shouted down Mrs Wirth, which is 5'2" weighting 105 lbs.

Below is confirmation that this committee has been terminated. Please advise when I can put this matter behind me, this has been a terrible experience with political adversaries like TJ Roberts' threatening and menacing demeanor toward my wife - only to be continually attacked through baseless claims.
