III. BACKGROUND:**Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)**

The Republican Party of Arkansas (“the Committee”) amended its 2020 30-Day Post-General Report to disclose additional receipts totaling \$3,247,109.59 and additional disbursements totaling \$3,247,109.59, which were not disclosed in the original report (Attachment 2). The Committee also amended its 2020 Year-End Report to disclose additional receipts totaling \$281,829.43 and additional disbursements totaling \$281,829.43, which were not disclosed in the original report (Attachment 2).

2020 30-Day Post-General Report

On December 2, 2020, the Committee filed the original 2020 30-Day Post-General Report covering the period from October 15, 2020 through November 23, 2020. The report disclosed \$0.00 in receipts on Line 12 (Transfers from Affiliated/Other Party Committees) of the Detailed Summary Page (Image 202012029337409128, Attachment 2). The report also disclosed \$0.00 in disbursements on Line 22 (Transfers to Affiliated/

Other Party Committees) of the Detailed Summary Page (Image 202012029337409129, Attachment 2).

On March 12, 2021, the Committee filed an Amended 2020 30-Day Post-General Report. The report disclosed \$3,247,109.59 in receipts on Line 12 of the Detailed Summary Page, an increase of \$3,247,109.59 from the original report (Image 202103129440474431, Attachment 2). The report also disclosed \$3,247,109.59 in disbursements on Line 22 of the Detailed Summary Page, an increase of \$3,247,109.59 from the original report (Image 202103129440474432, Attachment 2). Additionally, the report included memo text stating:

“Report is being amended to reflect the JFC Transfers for Trump Victory and the subsequent transfers to Republican National Committee on October 15, 2020, October 23, 2020, October 30, 2020 and November 4, 2020” (Image 202103129440474434).

On April 15, 2021, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2020 30-Day Post-General Report, received March 12, 2021. The RFAI referenced the memo text attached to the report and requested additional clarification regarding the substantial increase in receipts and disbursements disclosed in the Amended 2020 30-Day Post-General Report (Images 202104150300115987-88).

2020 Year-End Report

On January 12, 2021, the Committee filed the original 2020 Year-End Report covering the period from November 24, 2020 through December 31, 2020. The report disclosed \$0.00 in receipts on Line 12 of the Detailed Summary Page (Image 202101129398406413, Attachment 2). The report also disclosed \$0.00 in disbursements on Line 22 of the Detailed Summary Page (Image 202101129398406414, Attachment 2).

On March 12, 2021, the Committee filed an Amended 2020 Year-End Report. The report disclosed \$281,829.43 in receipts on Line 12 of the Detailed Summary Page, an increase of \$281,829.43 from the original report (Image 202103129440474708, Attachment 2). The report also disclosed \$281,829.43 in disbursements on Line 22 of the Detailed Summary Page, an increase of \$281,829.43 from the original report (Image 202103129440474709, Attachment 2). Additionally, the report included memo text stating:

“Report is being amended to reflect the JFC Transfers for Trump Victory and the subsequent transfers to Republican National Committee on November 24, 2020” (Image 202103129440474711).

On April 15, 2021, an RFAI was sent to the Committee referencing the Amended 2020 Year-End Report, received March 12, 2021. The RFAI referenced the memo text attached to the report and requested additional clarification regarding the substantial increase in receipts and disbursements disclosed in the Amended 2020 Year-End Report (Images 202104150300115989-90).

On May 19, 2021 the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAs referencing the Amended 2020 30-Day Post-General and Amended 2020 Year-End Reports, both received March 12, 2021, which stated, in part:

“This submission responds to your Requests for Additional Information (RFAs) dated April 15, 2021. The RFAs requested clarification on increases in activity on the Republican Party of Arkansas’ Amended 2020 30-Day Post-General Report, filed 3/12/21, and Amended 2020 Year End Report, filed 3/12/21. Both reports were amended to disclose incoming transfers from Trump Victory and outgoing transfers to the Republican National Committee. The transfers were inadvertently not disclosed on the original reports due to clerical errors” (Image 202105199446967413).

On June 9, 2021, the Reports Analysis Division (RAD) Analyst left a message for Alisha Curtis, the Committee’s Treasurer, with Ashley Wells, the Committee’s Finance Director. The Analyst requested a return phone call to discuss the outstanding matters noted on the RFAs referencing the Amended 2020 30-Day Post-General and Amended 2020 Year-End Reports, received March 12, 2021 (Attachment 3).

On June 14 and 15, 2021, the RAD Analyst attempted to contact Ms. Curtis. However, Ms. Curtis’ voice mailbox was full; therefore, the Analyst could not leave a voicemail message (Attachment 3).

Also on June 15, 2021, the RAD Analyst called John Daniels, a representative of the Committee, regarding the outstanding matters noted on the RFAs referencing the Amended 2020 30-Day Post-General and Amended 2020 Year-End Reports, received March 12, 2021. The Analyst explained that the outstanding matters may be referred to another Commission office for potential further action. Mr. Daniels stated that he understood and confirmed the contact information of the Committee’s Treasurer (Attachment 3).

Later, on that same day, the RAD Analyst attempted to contact Ms. Curtis. However, Ms. Curtis’ voice mailbox was full; therefore, the Analyst could not leave a voicemail message (Attachment 3).

On June 16, 2021, the RAD Analyst called Ms. Curtis regarding the outstanding matters noted on the RFAs referencing the Amended 2020 30-Day Post-General and Amended 2020 Year-End Reports, received March 12, 2021. The Analyst explained that the outstanding matters noted on the Amended 2020 30-Day Post-General and 2020 Year-End Reports may be referred to another Commission office for potential further action. The Analyst told Ms. Curtis that the Committee could provide additional clarification on the public record via an FEC Form 99 if the Committee chose to do so. Ms. Curtis asked the Analyst to also call Ms. Wells to inform her of the potential referral (Attachment 3).

Later, on that same day, the RAD Analyst called Ms. Wells regarding the outstanding matters noted on the Amended 2020 30-Day Post-General and Amended 2020

Year-End Reports received March 12, 2021. The Analyst explained that the outstanding matters may be referred to another Commission office for potential further action. The Analyst noted that the Commission had received the FEC Form 99, filed on May 19, 2021, but informed Ms. Wells that the Committee could provide additional clarification on the public record via an additional FEC Form 99 if it chose to do so. Ms. Wells stated that the Committee would not be providing any additional clarification at this time (Attachment 3).

To date, no further communications have been received from the Committee regarding these matters.
