Sinram, Acting Secretary and Clerk of the Federal Election Commission having reviewed the audio recording of the executive session of the Federal Election Commission for May 12, 2022, do hereby certify that on May 12, 2022, the Commission took the following actions in the above-captioned matter:

1. Failed by a vote of 1-5 to amend a pending motion with a substitute to:

Send the entire matter to the Alternative Dispute Resolution Office.

Commissioner Trainor voted affirmatively for the motion. Commissioners Broussard, Cooksey, Dickerson, Walther, and Weintraub dissented.

2. Failed by a vote of 3-3 to:

- a. Open a MUR in RAD Referral 21L-52.
- b. Find reason to believe that the Republican Party of Arkansas and Alisha Curtis in her official capacity as treasurer violated 52 U.S.C. § 30104(b)(2), (4) and 11 C.F.R. § 104.3(a), (b) by misreporting receipts and disbursements.
- c. Approve the Factual and Legal Analysis, as recommended in the Revised First General Counsel's Report dated February 7, 2022, subject to the edits circulated by Commissioner Cooksey's Office on May 11, 2022 at 9:42 a.m.

- d. Authorize pre-probable cause conciliation with the Republican Party of Arkansas and Alisha Curtis in her official capacity as treasurer.
- e. Approve the Proposed Conciliation Agreement, as recommended in the Revised First General Counsel's Report dated February 7, 2022, subject to the edits circulated by Commissioner Cooksey's Office on May 11, 2022 at 9:42 a.m
- f. Approve the appropriate letters.

Commissioners Broussard, Walther, and Weintraub voted affirmatively for the motion.

Commissioners Cooksey, Dickerson, and Trainor dissented.
