**III. BACKGROUND:**

**Failure to Provide Supporting Schedules (Failure to Timely File 24-Hour Reports)**

Black Voters Matter Action PAC (“the Committee”) failed to timely file eight (8) 24-Hour Reports to support thirty-seven (37) independent expenditures totaling \$538,197.71 disclosed in the 2021 30-Day Post-Runoff Report, made after the 20th day but more than 24 hours before the day of the 2021 Runoff and 2021 Special-Runoff Elections held in the state of Georgia (Attachment 2).

On February 4, 2021, the Committee filed its 2021 30-Day Post-Runoff Report covering the period from December 17, 2020 through January 25, 2021. The report included a Schedule E (Itemized Independent Expenditures) disclosing seventy-two (72) independent expenditures, totaling \$1,582,123.20, made in support or opposition of four (4) federal candidates (Images 202102049427030636-71).

On the same day, the Committee filed nine (9) 24-Hour Reports to support forty-eight (48) independent expenditures, totaling \$754,154.88, disseminated between December 23, 2020 and January 3, 2021. Six (6) of these reports were new 24-Hour

Reports, while three (3) were amended reports (Images 202102049425039865-68, 202102049425039885, 202102049425039899-902, 202102049425039909, 202102049425039918-20, and 202102049425073658-68).

On April 15, 2021, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2021 30-Day Post-Runoff Report, received February 4, 2021. Among other items, the RFAI noted that the Committee may have failed to timely file one (1) or more of the required 24-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying the thirty-seven (37) independent expenditures, totaling \$538,197.71, for which 24-Hour Reports had not been timely filed (Images 202104150300115798-803).<sup>2</sup>

On June 25, 2021, the Reports Analysis Division (RAD) Analyst called Victoria Perrone, the Committee's representative, to follow-up on the outstanding RFAI regarding the 2021 30-Day Post-Runoff Report, for which there had been no response, and Ms. Perrone indicated that the Committee would file the amendments (Attachment 3).

On July 1, 2021, the RAD Analyst followed-up with Ms. Perrone, but received no answer. The Analyst left a voicemail asking Ms. Perrone to call back (Attachment 3).

Later on the same day, Ms. Perrone returned the Analyst's call. The Analyst walked Ms. Perrone through some questions she had about the RFAI regarding the 30-Day Post-Runoff Report and explained how best to resolve the outstanding issues. The Analyst advised that the Committee provide a Form 99 or memo text that explains why the other 24-Hour Reports were filed late. Ms. Perrone asked about potential fines related to the late-filed 24-Hour Reports, but the Analyst indicated that they could not speak on that matter. The Analyst did explain that the Committee's outstanding matters may be referred to another Commission office for potential further action (Attachment 3).

On July 28, 2021, the Committee filed an Amended 2021 30-Day Post-Runoff Report (Images 202107289452143217-252). The report disclosed no changes to Schedule E, but did include memo text that stated:

"The Committee has filed all applicable 24-Hour Reports of Independent Expenditures (the Reports). Due to inadvertent lapses in the Committee's procedures for reporting independent expenditures, some Reports were filed more than 24 hours after the dissemination of the independent expenditures in question. However, the Committee filed all such Reports promptly upon discovering its error" (Image 202107289452143194).

On October 27, 2021, the Analyst called Ms. Perrone to remind her that the Committee's referable matter regarding the failure to timely file 24/48-Hour Reports

The RFAI should have only referenced the independent expenditures totaling \$538,197.71 made in support of T. Jonathan Ossoff and Raphael Warnock that were not timely reported.

To date, no further communications have been received from the Committee regarding this matter.
