III. BACKGROUND:

Excessive, Prohibited and Other Impermissible Contributions (Failure to Refund or Redesignate General Election Contributions within the Permissible Timeframe)

Kristine Schanbacher for Congress (“the Committee”) received 2020 General Election contributions from thirteen (13) individuals that were not refunded or redesignated within the permissible timeframe from the date the candidate Kristine Schanbacher (“the Candidate”) lost the primary election. The contributions total \$36,250.00 as disclosed on the 2019 October Quarterly, 2019 Year-End, 2020 12-Day Pre-Primary, and 2020 July Quarterly Reports (Attachment 2).

2019 October Quarterly Report

On October 15, 2019, the Committee filed the 2019 October Quarterly Report covering the period from June 21, 2019 through September 30, 2019. This report disclosed the receipt of \$20,450.00 in 2020 General Election contributions from eight (8) individuals (Image 01910159164891914, Attachment 2).

2019 Year-End Report

On January 31, 2020, the Committee filed the 2019 Year-End Report covering the period from October 1, 2019 through December 31, 2019. This report disclosed no 2020 General Election contributions (Image 202001319184631172).

On March 5, 2020 the Committee filed an Amended 2019 Year-End Report, which disclosed the receipt of \$1,800.00 in 2020 General Election contributions from one (1) individual (Image 202003059203756526, Attachment 2).

2020 12-Day Pre-Primary Report

On March 5, 2020 the Committee filed the 2020 12-Day Pre-Primary Report covering the period January 1, 2020, through February 26, 2020. This report disclosed the receipt of \$9,400.00 in 2020 General Election contributions from four (4) individuals ((Image 202003059203756763, Attachment 2).

On April 1, 2020, the Committee filed an Amended 2020 12-Day Pre-Primary Report, which disclosed no changes to the above 2020 General Election contributions (Image 202004019216574129).

2020 April Quarterly Report

On March 17, 2020, the Candidate lost the primary election for Illinois' 7th Congressional District.

On April 1, 2020 the Committee filed the 2020 April Quarterly Report covering the period from February 27, 2020 through March 31, 2020. This report disclosed the receipt of \$4,600.00 in 2020 General Election contributions from two (2) individuals (Image 202004019216574304), Attachment 2).

On June 24, 2020, a Request for Additional Information ("RFAI") was sent to the Committee referencing the 2020 April Quarterly Report, received April 1, 2020. Among other issues, the RFAI noted the Committee's receipt of 2020 General Election contributions during the 2019-2020 election cycle and requested that the Committee refund or redesignate the contributions since the Candidate would not participate in the 2020 General Election.

On July 1, 2020, the Committee filed an Amended 2020 April Quarterly Report, which disclosed no changes to the above 2020 General Election contributions but added \$33,450.00 in debt owed to twelve (12) individuals,¹ each with the purpose "General election contribution to be refunded" (Image 202007019244227727).

¹ The Committee appears to have inadvertently omitted the 9/16/2019 contribution from Jordan H. Hankins, totaling \$2,800.00.

On August 6, 2020, the Reports Analysis Division (RAD) analyst called Stella Black, the Treasurer of the Committee, to notify her of the potential referral. Later the same day, the RAD analyst spoke with a representative of the Candidate, Emily Wurth, and subsequently the Candidate herself, who stated she was told by her staff that spending the general contributions is permissible and that she did not have the funds to refund the general contributions (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
