**RE: Violation of Federal Election Laws. No disclaimer on a mailing advocating for one candidate or another. Corrected Complaint to one originally sent June 2.**

Dear Sirs:

Last week this campaign flyer came to my home via the mail. This mailer is related to the Republican Primary for Virginia's 2<sup>nd</sup> Congressional District. There no disclaimer on the piece as required by federal law. My complaint is in two parts.

My first complaint is the piece seems to be directed towards advocating for one candidate, Mr. Jarome Bell and a disclaimer is required

The commission may adjudicate that the piece advocates equally for both candidates. If this is the case then my second complaint is that the piece is advocating for these two candidates at the expense of the other two candidates in the race, Mr. Altman and Mr. Baan. This would also require a disclaimer.

I do not believe Mr. Bell's campaign is the source of this mailer but I have no direct proof. In the upper left-hand corner of the mailer on the side containing the mailing address is a small logo. The logo is very small but says, "Allied Printing Trade Council, Union Label, Washington." I believe that the company that printed and mailed the document was Mt. Vernon Printing. I do not know who paid for this document.

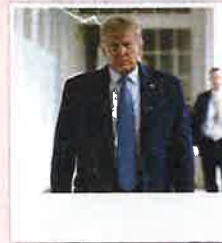

Opposed funding for new police vehicles and voted against providing raises and one-time bonuses to State Police, Correctional Officers, and Sheriffs.<sup>6</sup>

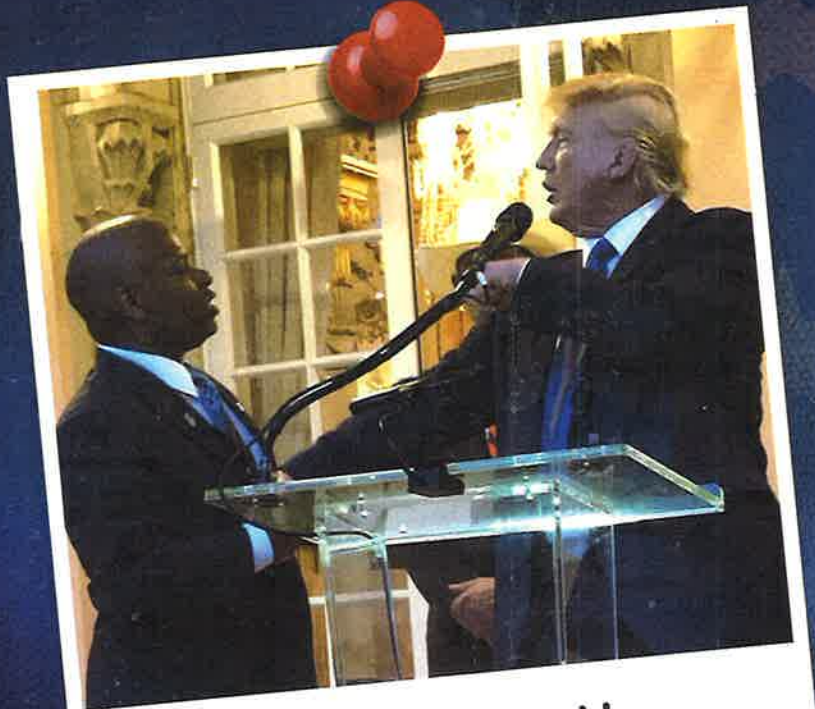
