PATRIOTS PAC, LLC'S AND MEI SERVICES, INC.'S RESPONSE TO COMPLAINT

COMES NOW, PATRIOTS PAC, LLC (the "PAC") and MEI SERVICES, INC. ("MEI"; collectively, the "Respondents"), by and through undersigned counsel, file this their joint response to the Complaint as follows:

1.

This matter arose because of various contributions made by MEI to the PAC (the "Contributions").

2.

A complaint was filed on July 5, 2022 (the "Complaint") with the Federal Election Commission (the "FEC") alleging that the Contributions violated the Federal Election Campaign Act of 1971, as amended ("FECA").

3.

The crux of the Complaint alleges that the Respondents violated FECA because the Contributions came from MEI, a federal contractor.

4.

After the filing of the Complaint, the PAC reviewed all the relevant materials and due to the lack of experience by the undersigned and the PAC treasurer, the PAC did identify that there are problems that needed to be addressed.

5.

Consequently, the PAC has since taken action to rectify the issues alleged in the Complaint.

6.

Specifically, the PAC promptly refunded all the Contributions to MEI after being notified of these issues.

7.

As a result of these issues, the PAC has since implemented better compliance procedures to avoid further complications.

7.

Moreover, as the PAC is in the process of winding down, it is unlikely that there will be further violations in the future.

8.

Accordingly, the Respondents asked that the FEC consider the cooperation and swift action taken by the Respondents in its ultimate decision.
