SUBJECT: MUR 8022 (MEI Services, Inc.)
Recommendation to Accept Signed Conciliation Agreement

On February 9, 2023, the Commission found reason to believe that MEI Services, Inc. violated 52 U.S.C. § 30119(a) and 11 C.F.R. § 115.2(a) by making prohibited federal contractor contributions and authorized an investigation limited to a document request seeking records in MEI Services, Inc.'s possession reflecting any refunds that it received from Patriots PAC, LLC during the period relevant to the transactions at issue.¹ On July 13, 2023, the Commission authorized the Office of General Counsel to engage in pre-probable cause conciliation with the Committee.²

3 In addition, at the time the Commission found reason to believe as to MEI Services, Inc.,
4 it took no action as to the recipient committee, Patriots PAC, LLC and Melvin Johnson in his
5 official capacity as treasurer (“Committee”).⁵ The record in this matter contains no information
6 regarding any Committee solicitation of MEI. Further, the Committee, which has reported no
7 activity since its Amended October 2022 Quarterly Report reflecting the refunds to MEI, has
8 requested termination.⁶ Accordingly, we now recommend that the Commission dismiss the
9 allegation as to the Committee.

10 We recommend that the Commission accept the signed agreement and close the file in
11 this matter.

17 2. Dismiss the allegation that Patriots PAC, LLC and Melvin Johnson in
18 his official capacity as treasurer violated 52 U.S.C. § 30119(a) and
19 11 C.F.R. § 115.2(c) by knowingly soliciting a federal contractor contribution;
