MUR 8024**AFFIDAVIT OF PATRICIA A. DAVIS****I. STATEMENT OF FACT**

"A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction." (11 C.F.R. § 111.4)

I reviewed First Quarter 2022 campaign contributions (FEC Schedule A, Itemized) to "GRASSO FOR CONGRESS 6," Republican candidate for US House of Representatives for the 6th Congressional District of Illinois, Committee ID C00799247. The candidate is Gary A. Grasso. The information is found at <https://docquery.fec.gov/cgi-bin/forms/C00799247/1585221/sa/ALL> FEC File No. 1585221

I, complainant Patricia A. Davis, allege that the above-named candidate and campaign committee received campaign contributions from four individuals who did NOT, in fact, donate to the candidate. The funds were provided by another individual.

Federal election law (52 C.F.R. § 30122) states: "**Contributions in name of another prohibited.** No person shall make a contribution in the name of another person or knowingly permit his name to be used to effect such a contribution and no person shall knowingly accept a contribution made by one person in the name of another person."

Three of these four individuals who listed their employment as "managers" of a restaurant in Burr Ridge, IL -- Capri by Gigi/Capri To Go aka "5 Brothers, Inc." 324 Burr Ridge Parkway, Burr Ridge, IL 60527 (630) 455-4003 – and each donated the individual limit, \$2900, to "GRASSO FOR CONGRESS 6" on March 30, 2022:

Antonia (Antonella) Rovito, the restaurant owner's wife and "manager," Capri Ristorante
Gina T. Cademartori, 5 Brothers Inc., "manager"
Virginia A. Moya-DeLeon, Capri On The Go (subsidiary), "manager"

I allege that each of these individuals were not the source of the donations. What restaurant hostess or manager can afford to give the individual maximum donation? I allege that the donations actually came from the restaurant's owner/operator, Filippo "Gigi" Rovito, Jr., who has donated to Mr. Grasso in substantial amounts both in local (mayoral) races as well as to Mr. Grasso's statewide race (2018 IL Attorney General). The fact that these individuals all supposedly "donated" to the same campaign, from the same source, on the same day and Mr. Rovito's name is suspiciously absent is, I believe, fraudulent. Mr. Rovito and candidate Grasso are close friends and confidants.

In addition to those three employees, Terese Dimaria is listed as a campaign contributor of \$2900 on March 30, 2022 as well. Dimaria listed her employer as "Metro Strategies Group," a consulting company in Downers Grove, IL. On April 19, 2022 I had a telephone conversation with Metro's founder and Chief Executive Officer, Ms. Seema Wadia, who confirmed to me that Terese Dimaria does NOT work there.

Further research proved Dimaria is actually employed as a banquet manager at Capri. I allege that Ms. Dimaria did not make that contribution and that the source is actually Mr. "Gigi" Rovito.



Ms. Dimaria is listed as a "banquet manager" for Capri Ristorante, 324 Burr Ridge Parkway, Burr Ridge, IL 60527, phone (630) 455-4003. Capri (corporate name "5 Brothers") is Mr. Grasso's favorite hangout and he is close friends with its owner/operator Filippo "Gigi" Rovito. A review of the FEC filings for Mr. Grasso's campaign shows several other Rovito "managers" donated the max amount to his campaign; those are also listed in the contributions link, above (Gina Cademartori, Virginia Moya-DeLeon, Antonia Rovito are the others). They all "gave" the same amount on the same day and all are affiliated with Capri Ristorante.



I, complainant Patricia A. Davis, allege that the above-named candidate and campaign committee received two in-kind donations of restaurant space, food, and drinks for two fundraisers at two different establishments and did not report these as required to the Federal Election Commission as in-kind donations on the candidate’s FEC Schedule A, Itemized for the First Quarter 2022.

Per Federal Election Commission rules: *“An in-kind contribution is a non-monetary contribution. Goods or services offered free or at less than the usual charge result in an in-kind contribution. Similarly, when a person or entity pays for services on the committee’s behalf, the payment is an in-kind contribution. An expenditure made by any person or entity in cooperation, consultation or concert with, or at the request or suggestion of, a candidate’s campaign is also considered an in-kind contribution to the candidate.”*

“The value of an in-kind contribution—the usual and normal charge—counts against the contribution limit as a gift of money does.”

The fundraisers were held at Topaz Café, 780 Village Center Drive, Burr Ridge, IL, 60527 (March 9, 2022) and at Capri Ristorante of Burr Ridge, 324 Burr Ridge Parkway, Burr Ridge, IL, 60527 (March 28, 2022). The candidate by and through his campaign committee, did NOT list these two fundraisers (in-kind donations of food, beverage, etc.) on his First Quarter FEC Schedule A, Line 11A as required by statute. 

COMPLAINT PART 3

AFFIDAVIT OF PATRICIA A. DAVIS

I. STATEMENT OF FACT

“A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction.” (11 C.F.R. § 111.4)

I reviewed the Financial Disclosure Report (FDR) for Gary Grasso, Republican candidate for US House of Representatives for the 6th Congressional District of Illinois, Committee ID C00799247 named as “GRASSO FOR CONGRESS 6.” This FDR is available here: https://disclosures-clerk.house.gov/public_disc/financial-pdfs/2022/10044440.pdf

I, complainant Patricia A. Davis, allege that the above-named candidate did not truthfully file his U.S. House of Representatives “Financial Disclosure Report” as he 1) has more income than he stated on his FDR; and 2) the candidate is married and he reports no financial assets of his wife, Janet Grasso.

Candidate Grasso requested, and received, two extensions to file his FDR. He finally did so, and submitted it to the House Ethics Committee, on June 15, 2022 – one full month late. His FDR does not truthfully state his income (FDR Schedule A “Assets and Unearned Income” and FDR Schedule C “Earned income”). On May 5, 2022, however, Mr. Grasso as mayor of Burr Ridge, IL, was required by the DuPage County Clerk to file a Statement of Economic Interest and on that form listed (Item 2) “Social Security” as part of his income over \$7,500. He did NOT report that income on his federal FDR. He also did not report any retirement funds such as 401k, IRA, KEOGH, SEP, etc. – and this man is an attorney. You bet he has disclosable assets.

Mr. Grasso has been married for 44 years to his wife, Janet, and on his campaign website boasts having raised six children and now has six grandchildren. Ms. Grasso was a flight attendant before receiving her J.D.. Surely she has investments, retirement accounts, and financial positions that are required to be reported. Mr. Grasso did NOT report any of his wife’s income or financial positions.

Lastly, Mr. Grasso’s First Quarter and Pre-Primary FEC filings indicate that he loaned his campaign \$250,000. How can a candidate who reports \$300,000 earned income as an attorney – stated on his FDR in Schedule C “Earned Income” – possibly afford to loan his campaign \$250,000?

Why did Mr. Grasso require TWO extensions to file his FDR, and then filed virtually a blank form? Why did he ask for his first extension on 3/17/2022 when the filing was not due until 5/15/2022? His second extension was granted on 5/23/2022 and the report was due 5/29/2022. He did not file it until 6/15/2022. Was candidate Grasso busy hiding his and his wife’s assets from disclosure?


