AFFIDAVIT OF PATRICIA A. DAVIS**I. STATEMENT OF FACT**

“A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction.” (11 C.F.R. § 111.4)

I hereby submit this supplement to MUR 8024, a formal complaint against House Committee #C00799247, “GRASSO FOR CONGRESS 6” and its candidate, Gary A. Grasso, for failing to disclose income to the Federal Election Commission as required by law.

I, complainant Patricia A. Davis, allege that the above-named candidate did not truthfully file his U.S. House of Representatives “Financial Disclosure Report” (FDR) specifically to disclose income from investments that he reported in 2021 and 2020 to the DuPage County, IL, clerk in his “Statement of Economic Interests” (SEI) which is required to be filed by all elected officials within the county. In 2021 and 2020, Mr. Grasso was mayor of Burr Ridge, IL, a position that he continues to hold today.

In my FEC complaint filed July 8, 2022 and given MUR 8024, I noted that Mr. Grasso failed to report any investment income. If he reported said investments to DuPage County in 2020 and 2021, I allege that -- as a man of 70+ years -- he certainly held those same reportable investments in 2022, but did not report these to the FEC. Mr. Grasso also failed to disclose his Social Security income to the FEC, but DID report it to the county in 2022. It is also notable that Mr. Grasso required TWO extensions to file a virtually blank Federal Disclosure Report on June 15, 2022. Was Mr. Grasso busy hiding his assets?

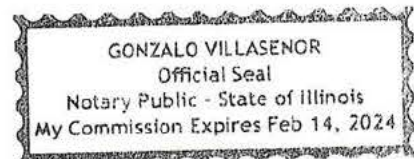
