To whom it may concern:

This is a formal complaint against the Bonneville County Republican Party Central Committee, a county political committee in the state of Idaho <u>and</u> Bryan Smith, 2022 candidate for congress in Idaho's second congressional district.

The BCRCC and Smith both violated the federal election laws by donating and accepting funds into Smith's campaign coffers that were from prohibited sources and coordinated various campaign activity, all in violation of federal election laws.

## The BCRCC.

The BCRCC raises money for local Idaho elections but does <u>not</u> do so under the federal rules that prohibit donations from certain sources like corporations nor does the BCRCC follow the federal laws that limit the amount of money that individuals can donate. Nevertheless, despite having received corporate money and money in excess of the federal limits, the public records on file at the Idaho Secretary of State's office prove the BCRCC contributed \$1000 to Smith's campaign on April 18, 2022. (See Attachment A, a public record).

The BCRCC also spent money to print and publish campaign materials endorsing and supporting Smith for Congress. These materials were presumably paid for with the non-federal money. These materials also did not have any of the disclaimers required by federal law, including any "Paid For By" statement. These endorsement pieces most likely would be considered in-kind and/or coordinated expenditures with the Smith campaign.(See Attachment B, posted to the BCRCC's Facebook page).

## Bryan Smith and his campaign.

Bryan Smith and his campaign accepted and spent the prohibited money provided by the BCRCC knowing exactly where it came from, yet still represented to the FEC that the money was from "federally permissible funds.". (See Attachment C, Smith's FEC filings, printed from www.fec.gov, a public record).

Further, at the time the BCRCC collected the excessive money from federally prohibited sources and at the time the BCRCC donated it to Smith's campaign, Smith was a Vice-Chair of the BCRCC. As Vice Chair he knew, or should have known, where the money

came from and that it was not allowed to be contributed to his campaign. As an officer of the BCRCC Smith was also presumably involved in the decision to expend non-federal money to print and mail the endorsement pieces.

I believe that the BCRCC and Smith should follow the same laws and rules as all other individuals, candidates and campaigns and when they do not, they should be held accountable.
