The complaint ("Complaint") in this matter alleges that "Axiom Strategies via Remington Research is conducting favorable polling for their client, Eric Schmitt." Although not stated explicitly in the Complaint, Schmitt for Senate (i.e., Schmitt's campaign committee) has not reported any payments for polling to either Axiom Strategies ("Axiom") or Remington Research Group ("RRG"). Apparently on this basis, the Complaint alleges "these polling services [were] in-kind contributions from either Axiom Strategies or Remington Research."

The Complaint's speculation is unfounded. As the public record indicates, RRG conducted the polls in question for another client: The Missouri Scout. The polls were publicly distributed by The Missouri Scout in its capacity as a press entity and therefore were not in-kind contributions to Eric Schmitt or Schmitt for Senate.

All of the RRG polls at issue were commissioned by The Missouri Scout, which is a private news service covering Missouri state politics<sup>2</sup> and is covered by the "press exemption." The poll results are all posted on RealClearPolitics.<sup>4</sup> Although the results are interchangeably posted as "Missouri Scout" and "Remington Research" polls, clicking on the links on the RealClearPolitics page results in downloads of Microsoft PowerPoint files that all identify the polls as "Survey conducted by Remington Research Group on behalf of The Missouri Scout." An example of one such document is attached as EXHIBIT A.

In short, RRG conducted the polls in question for another paying client and independently of Eric Schmitt and Schmitt for Senate. Therefore, the Federal Election


## Missouri Republican Primary Election




