III. BACKGROUND:

Excessive, Prohibited, and Other Impermissible Contributions (Failure to Refund, Redesignate, or Reattribute Excessive and Prohibited Contributions within the Permissible Timeframe)

DAN CRENSHAW FOR CONGRESS (“The Committee”) received excessive and apparent prohibited contributions totaling \$223,460.26 for the 2020 Primary Election and 2020 General Election from one hundred twenty-five (125) individuals, four (4) apparent corporations, three (3) limited liability companies (LLC), one (1) non-qualified political action committee, and one (1) qualified multicandidate committee. Of this amount, the Committee refunded \$205,143.76 outside of the permissible timeframe, with \$18,316.50 remaining unremedied.

2020 July Quarterly Report

On July 15, 2020 the Committee filed the 2020 July Quarterly Report covering the period of April 1, 2020 through June 30, 2020. The report disclosed excessive and apparent

impermissible² contributions totaling \$26,336.25 from twenty-one (21) individuals and one (1) qualified multicandidate political action committee (Image 202007159249961025, Attachment 2).

On October 13, 2020, a Request for Additional Information (“RFAI”) referencing the 2020 July Quarterly Report was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and impermissible contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202010140300087988, Attachment 2).

On April 15, 2021 the Committee filed the original 2021 April Quarterly Report covering the period of January 1, 2021 through March 31, 2021. This report disclosed refunds to twenty (20) individuals cited in the RFAI, totaling \$25,236.25. All of these remedies were made outside of the permissible timeframe (Image 202104159443448740, Attachment 2).

On September 27, 2021, the Committee filed an Amended 2021 April Quarterly Report. This report disclosed an additional \$100.00 refund to one (1) individual cited in the RFAI that was not itemized in the original report.³ This refund was made outside of the permissible timeframe (Image 202109279466981571, Attachment 2).

2020 October Quarterly Report

On October 15, 2020 the Committee filed the original 2020 October Quarterly Report covering the period of July 1, 2020 through September 30, 2020. The report disclosed excessive and apparent prohibited contributions totaling \$117,709.21 from sixty-one (61) individuals, one (1) limited liability company, and three (3) apparent corporations (Image 202010159295145602, Attachment 2).

On November 11, 2020, an RFAI referencing the 2020 October Quarterly Report was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions, as applicable (Image 202011110300091620, Attachment 2).

On December 16, 2020, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) referencing the 2020 October Quarterly Report and the 2020 12-Day Pre-General Report. The Form 99 stated, in part:

“We are in receipt of the letter from the Commission regarding the above referenced reports. Please see below for our complete response. The

contributions in question were temporarily excessive. All of the contributions have been either refunded or redesignated. Some of the redesignations and refunds were shown on the Post-General Report that has already been filed. The others will be reflected on the upcoming Year-End Reports. The contributions from companies were the subjects if [sic] research on the part of the campaign since the time the contribution was received. We were not able to verify that these funds were permissible and therefore these contributions have been refunded and these refunds will be included on the upcoming Year-End Report” (Image 202012169387363671).

On December 21, 2020, the Committee filed an Amended 2020 October Quarterly Report. The report disclosed no changes to the apparently excessive and prohibited contributions (Image 202012219393381701, Attachment 2).

On April 15, 2021 the Committee filed the original 2021 April Quarterly Report covering the period of January 1, 2021 through March 31, 2021. This report disclosed refunds to fifty-seven (57) individuals cited in the RFAI totaling \$106,495.87. All of these remedies were made outside of the permissible timeframe (Image 202104159443448740, Attachment 2).

On September 27, 2021, the Committee filed an Amended 2021 April Quarterly Report. This report disclosed additional refunds to four (4) individuals cited in the RFAI totaling \$413.34 that were not itemized in the original report.⁴ These refunds were made outside of the permissible timeframe (Image 202109279466981571, Attachment 2).

2020 12-Day Pre-General Report

On October 22, 2020, the Committee filed the original 2020 12-Day Pre-General Report covering the period from October 1, 2020 through October 14, 2020. The report disclosed apparent excessive and prohibited contributions totaling \$48,633.32 from thirty-seven (37) individuals and one (1) limited liability company (Image 202010229333239526, Attachment 2).

On November 11, 2020, an RFAI referencing the 2020 12-Day Pre-General Report was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions, as applicable (Image 202011110300091685, Attachment 2).

On December 16, 2020, the Committee filed an FEC Form 99 referencing the 2020 October Quarterly Report and the 2020 12-Day Pre-General Report. The Form 99 stated, in part:

The others will be reflected on the upcoming Year-End Reports. The contributions from companies were the subjects if [sic] research on the part of the campaign since the time the contribution was received. We were not able to verify that these funds were permissible and therefore these contributions have been refunded and these refunds will be included on the upcoming Year-End Report” (Image 202012169387363671).

On December 21, 2020, the Committee filed an Amended 2020 12-Day Pre-General Report. The report disclosed no changes to the apparently excessive and prohibited contributions (Image 202012219393386972, Attachment 2).

On April 15, 2021 the Committee filed the original 2021 April Quarterly Report covering the period of January 1, 2021 through March 31, 2021 (Image 202104159443448740). This report disclosed refunds to twenty-eight (28) individuals cited in the RFAI totaling \$41,083.66. All of these remedies were made outside of the permissible timeframe (Image 202104159443448740, Attachment 2).

On September 27, 2021, the Committee filed an Amended 2021 April Quarterly Report. This report disclosed additional refunds to seven (7) individuals cited in the RFAI totaling \$1,033.16 that were not itemized in the original report.⁵ These refunds were made outside of the permissible timeframe (Image 202109279466981571, Attachment 2).

2020 30-Day Post-General Report

On December 3, 2020, the Committee filed the original 2020 30-Day Post-General Report covering the period from October 15, 2020 through November 23, 2020. The report disclosed excessive and apparent prohibited contributions totaling \$32,981.48 from forty (40) individuals, one (1) limited liability company, one (1) apparent corporation, and one (1) non-qualified political action committee (Image 202012039339575780, Attachment 2).

On December 21, 2020, the Committee filed an Amended 2020 30-Day Post-General Report. The report disclosed no changes to the apparently excessive and prohibited contributions (Image 202012219393388831, Attachment 2).

On January 13, 2021, an RFAI referencing the Amended 2020 30-Day Post-General Report was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and prohibited contributions and requested that the Committee refund,

reattribute, or redesignate these contributions, as applicable (Image 202101130300100909).

On February 17, 2021, the Committee filed an FEC Form 99 referencing the Amended 2020 30-Day Post-General Report, received December 21, 2020. The FEC Form 99 stated, in part:

“We are in receipt of the letter from the Commission regarding the above referenced reports. Please see below for our complete response. The contributions in question were temporarily excessive. All of the contributions will be refunded and those refunds will be reflected on the upcoming April Quarterly Report. The contributions from companies were the subjects of research on the part of the campaign since the time the contribution was received. We were not able to verify that these funds were permissible and therefore these contributions have been refunded and these refunds will be included on the upcoming April Quarterly Report”
(Image 202102179428284110).

On April 15, 2021 the Committee filed the original 2021 April Quarterly Report covering the period of January 1, 2021 through March 31, 2021. This report disclosed a timely redesignation of \$2,200.00 for one (1) individual cited in the RFAI. The report also disclosed refunds to twenty-eight (28) individuals, one (1) limited liability company, one (1) apparent corporation, and one (1) non-qualified political action committee cited in the RFAI, totaling \$24,532.73. These refunds were made outside of the permissible timeframe (Image 202104159443448740, Attachment 2).

On May 4, 2021, the Reports Analysis Division (RAD) Analyst called and left a message for Paul Kilgore, the Committee’s Treasurer, to inform him the Committee would be referred to another Commission office for further action due to excessive and prohibited contributions not refunded within the permissible timeframe (Attachment 3).

On May 13, 2021, the RAD Analyst spoke with Mr. Kilgore to inform him the Committee would be referred to another Commission office for further action due to excessive and prohibited contributions not refunded within the permissible timeframe, received during the 2020 July Quarterly, October Quarterly, 12-Day Pre-General and 30-Day Post-General reporting periods. The Analyst stated that the Committee could file additional amendments and an FEC Form 99 if there was further information to disclose about the excessive and prohibited contributions (Attachment 3).

On September 10, 2021, the RAD Analyst called Paul Kilgore, the Committee’s Treasurer, and requested that the Committee itemize refunds on the 2021 April Quarterly Report that were previously unitemized. The Analyst also confirmed with Mr. Kilgore the Committee’s processes for verifying permissible contributions from partnerships (Attachment 3).

On September 27, 2021, the Committee filed an Amended 2021 April Quarterly Report. This report disclosed additional refunds to ten (10) individuals cited in the 2020

30-Day Post-General Report RFAI, totaling \$1,448.75, that were not itemized in the original report.⁶ These refunds were made outside of the permissible timeframe (Image 202109279466981571, Attachment 2).

To date, no further communications have been received from the Committee regarding this matter.
