## VERIFIED COMPLAINT

1. This complaint is filed pursuant to 52 U.S.C. $\S 30109(\mathrm{a})(1)$ and is based on information and belief that the Bonneville County Republican Central Committee ("BCRCC"), congressional candidate Bryan Smith ("Smith") and Mr. Smith's campaign committee for U.S. Congress, Bryan Smith for Idaho Inc. ${ }^{1}$, have violated the Federal Election Campaign Act ("FECA"), 52 U.S.C. § 30101, et seq., in connection with the 2022 Idaho GOP Primary Election held on May 17, 2022 for the United States House of Representatives.
2. Smith, a candidate for federal office and 4th Vice-Chair of the BCRCC, collaborated with the BCRCC to create, fund, and ensure the wide distribution of a "Sample Ballot" mailer ${ }^{2}$ that endorsed Smith's own candidacy for the U.S. House of Representatives in the 2022 Idaho Republican Primary Election.
3. The BCRCC also made financial contributions to Smith's federal campaign committee in an aggregate amount of $\$ 2,000(\$ 1,000$ in each of 2021 and 2022).

On information and belief, the funds used by the BCRCC for these purposes were not subject to the limitations, prohibitions, and reporting requirements of the FECA and there is sufficient to believe they were used in violation of 52 U.S.C. § 30125(b)(1), 11 C.F.R. § 300.32(a)(2), 11 C.F.R. § 300.33(c), 11 C.F.R. § 100.80, and 11 C.F.R. § 100.140 .
5. And the BCRCC itself, despite having become a "political committee" within the meaning of 11 C.F.R. § 100.5(c), did not file a Statement of Organization with the Federal Election Commission and or register as a political committee within 10 days thereafter, in apparent violation of 11 C.F.R. § 102.1(d).
6. For his part, Smith, acting in his role as 4th Vice-Chair of the BCRCC and as a federal candidate, participated in the BCRCC's own decisions to use non-Federal funds on Federal election activity in connection with his election to Congress and direct non-Federal funds to his Federal campaign committee in apparent violation of 52 U.S.C. § $30125(\mathrm{~b})(1), 11$ C.F.R. § 300.32(a)(2), 11 C.F.R. § 300.33(c), 11 C.F.R. § 100.80, and 11 C.F.R. § 100.140 .
7. Moreover, Smith, acting in his role as a federal candidate, both directly received and indirectly benefited from non-Federal funds in connection with his election to Congress, in the form of the BCRCC's financial contributions to the Smith Committee and the direct mail communications made by the BCRCC promoting his candidacy, in apparent violation of 52 U.S.C. § $30125(\mathrm{e})(1) ; 11$ C.F.R. § 300.61.
8. Finally, the mailer that the BCRCC created, paid for, and distributed with nonFederal funds advocated for Smith's election to federal office without including a clear and conspicuous disclosure identifying who had paid for the election communication, in apparent violation of 52 U.S.C. § 30120(a)(3) and 11 C.F.R. § 110.11(a)(2), (b), and (c)(1)-(2).

## FACTS

9. BCRCC is the Republican Party County Central Committee for Bonneville County, Idaho and was granted powers and obligations by the Rules of the Idaho Republican Party. According to the Federal Election Commission website, BCRCC registered as a political committee with the FEC on June 28, 1984, but that registration expired in 1988, and the BCRCC is no longer registered as a political committee.
10. At the time of the apparent violations, Smith was a candidate in the Republican Primary election for the U.S. House of Representatives. ${ }^{3}$ His authorized campaign committee was Bryan Smith for Idaho Inc. ${ }^{4}$ At the same time, Smith was also the 4th Vice-Chair and the Chair of the Campaign \& Operations Standing Committee for the BCRCC. ${ }^{5}$
11. The Idaho Republican Party bylaws clearly prohibit local county Republican organizations from endorsing federal and statewide candidates in primary elections; local county committees are permitted to endorse candidates in primary elections only for local office. ${ }^{6}$ Additionally, BCRCC bylaws prohibited the organization from favoring any Republican candidate engaged in a primary election.
12. As early as November 2021 and continuing through March 2022, BCRCC apparently violated those rules by contributing BCRCC funds to several Republican primary campaigns, including to Smith's federal campaign. ${ }^{7}$ On March 29, 2022, the Idaho Republican
[^1]Party informed BCRCC that their contributions had apparently violated state party rules and BCRCC bylaws and demanded that BCRCC correct their actions. ${ }^{8}$
13. BCRCC ignored the state Party's demand and instead chose to double down on its decisions. It ratified its past contributions, made still more contributions (including to Smith as a federal candidate), and further supported primary candidates by printing and mailing a communication advocating the election of specific endorsed candidates, including certain federal candidates for the May 17, 2022 Idaho Republican Primary Election. ${ }^{9}$
14. During a BCRCC executive meeting on April 5, 2022, a subcommittee was formed to "rate and vet" each Republican primary candidate for the purpose of recommending specific candidates, presenting those recommendations to the full BCRCC body for vote, and then creating a sample ballot that would be mailed out just before the Idaho Republican Primary Election to support or advocate for the election of the candidates appearing on the sample ballot. Per the minutes, Smith was present at the meeting. ${ }^{10}$
15. The subcommittee in charge of rating candidates was headed by Bryan Zollinger ("Zollinger"). Members of the subcommittee were chosen from among BCRCC committee members, businesspeople, and others.
16. Zollinger is an attorney who works at Smith's law firm, Smith, Driscoll, and Associates, a small firm in Idaho Falls, Idaho. ${ }^{11}$

[^2]17. In a BCRCC meeting on April 14, 2022, Smith personally moved to amend the BCRCC bylaws to allow contributions to and endorsements of any candidate in any primary or general election. The motion passed. ${ }^{12}$
18. Shortly thereafter, in the same meeting, and apparently in the presence of Smith, Zollinger moved to contribute $\$ 1,000$ to Smith's campaign. The motion passed, and BCRCC once again contributed $\$ 1,000$ to Smith's campaign. ${ }^{13}$
19. At the same April 14,2022 meeting, Zollinger spoke again about rating and vetting candidates and sending "a mailer to every Republican household in the county."14
20. On May 3, 2022, the BCRCC executive committee approved the final version of the "Sample ballot" mailer. Alpha Graphics, a local printing company, was chosen to print the mailer. Per the meeting minutes, Zollinger, was present at the meeting. ${ }^{15}$
21. On or around May 6,2022, BCRCC circulated a mailer containing a "sample ballot" from "the OFFICIAL Republican Party" that endorsed federal and state candidates in contested Republican primary elections. ${ }^{16}$ On information and belief, BCRCC circulated the mailer to voters and donors in Idaho through direct mail, social media, and door-to-door distribution. On information and belief, the identical mailer was sent in the United States mail to more than 500 people within a 30 -day period. Witnesses reported that many voters, as instructed in the mailer, took this document to the polls as they participated in early and day-of voting.
22. Smith was clearly endorsed as BCRCC's choice to be U.S. Representative on the mailer.

[^3]23. The mailer was a "mass mailing" and a "public communication" that unambiguously and intentionally promoted and supported the election of one or more clearly identified federal candidates. 11 C.F.R. §§ 100.26, 100.27.
24. The mailer lacked a clear and conspicuous disclaimer to indicate clearly and unmistakably who had paid for the advertisement as required by 11 C.F.R. § 110.11(a)(2), (b), and (c)(1)-(2).
25. On May 7, 2022, BCRCC spent $\$ 13,538.18$ at Alpha Graphics on federal election activity, ${ }^{17}$ from a non-Federal account containing funds that were not raised in compliance with Federal campaign finance limits and regulations. It is unclear from available records whether the $\$ 13,538.18$ fee was inclusive of postage costs, or whether additional amounts were expended to distribute the mailer.
26. That defiant decision to spend at least $\$ 13,538.18$ to distribute the "sample ballot" -- made in response to and directly in contravention of the instructions of the Chairman of the Idaho Republican Party -- converted the BCRCC into a federal "political committee," if it was not already. The amounts expended on the mailer in 2022 were in excess of the $\$ 5,000$ per calendar year threshold on activities exempted from the definition of a contribution under 11 C.F.R. § 100.80 and exempted from the definition of an expenditure under 11 C.F.R. § 100.140, above which a local committee of a political party becomes a political committee under 11 C.F.R. § 100.5(c).
27. On information and belief, all of the BCRCC contributions to Smith's federal campaign committee were made from a non-Federal account that contained funds that were not raised in compliance with Federal campaign finance limits and regulations, as was the payment

[^4]made to promote and support the election of Smith and the other clearly identified Federal candidates in the mailer.

## Apparent Violations of the Federal Election Campaign Act

## Count 1: Party "Soft Money" Expenditures

28. Federal law requires that any funds "expended or disbursed for Federal election activity by a State, district, or local committee of a political party ... shall be made from funds subject to the limitations, prohibitions, and reporting requirements of [the FECA]." 52 U.S.C. § 30125(b).
29. An expenditure for a mailer by a local party committee that "promotes" or "supports" a clearly identified candidate for Federal Office "must not be allocated between or among Federal, non-Federal, and Levin accounts. Only Federal funds may be used." 11 C.F.R. § 300.33(c).
30. BCRCC's disbursements for the direct mail communications promoted and supported Smith, and, therefore, appears to have constituted "Federal election activity" as defined in 52 U.S.C. § 30101 (20)(a)(iii).
31. Accordingly, because the direct mail communication constituted "Federal election activity" in the form of a public communication as defined by 11 C.F.R. $\S 100.26$ that promoted and supported the candidacy of clearly identified candidates for Federal office, BCRCC was required to fund it exclusively with funds subject to the limitations, prohibitions, and reporting requirements of the FECA. See 52 U.S.C. § 30125(b); 11 C.F.R. § 300.33(c).
32. According to the Idaho Secretary of State's website, the BCRCC recently received donations from several entities registered as corporations. ${ }^{18}$
33. On information and belief, BCRCC has not kept corporate and individual contributions separate because Idaho state campaigns may receive contributions from corporations ${ }^{19}$ and BCRCC bylaws and Idaho GOP rules previously forbade it from endorsing federal candidates.
34. Because the Idaho GOP has adopted rules that prohibit local county Republican organizations from endorsing candidates except at the county level, it is improbable that BCRCC would maintain a federal account. Furthermore, the relevant meeting minutes lack any reference to the use of separate funds for the mailer or BCRCC's contributions to Federal candidates. BCRCC had no need to maintain a federal account when it could only engage in local races. BCRCC likely lacked even the ability to comply with Federal laws and regulations limiting the sources and amounts of money used in connection with Federal election activities when it contributed funds to and made disbursements supporting the election of Smith.
35. Thus, when BCRCC apparently violated its bylaws and Idaho GOP rules by donating $\$ 2,000$ to Smith and using the mailer to promote and support the election of clearly identified Federal candidates, it likely failed to maintain a separate "Federal account" containing only money raised in accordance with the requirements of the FECA, and likely used funds from an account that commingles contributions from corporations and individuals, in apparent violation of 11 C.F.R. § 102.5(a)(1).

[^5]36. On information and belief, BCRCC's contributions to Smith's campaign and the payments it made for the mailer to promote and support the election of Smith and other clearly identified Federal candidates were not made with funds subject to the limitations, prohibitions, and reporting requirements of the FECA.
37. Even if BCRCC's mailers had not promoted and supported the election of Smith and other clearly identified federal candidates, it would still have been illegal for BCRCC to fund the mailers exclusively from a non-Federal account that contained funds that were not raised in compliance with Federal campaign finance limits and regulations. Disbursements for "exempt activities," including "slate cards," and "sample ballots" may not be "contributions" or "expenditures" (11 C.F.R. §§ 100.80, 100.140) but are nonetheless funds "disbursed" in connection with a Federal election activity and must be funded with funds subject to the limitations, prohibitions, and reporting requirements of the FECA under the plain language of 52 U.S.C. § 30125(b)(1).
38. If "exempt activities" like a slate card or sample ballot contain candidates for federal office, "the portion of" the costs of the sample ballot "allocable to Federal candidates must be made from funds subject to the limitations and prohibitions of the [FECA]." 11 C.F.R. §§ 100.80, 100.140.
39. BCRCC's defiant acts of making contributions to Smith's federal campaign and likely paying for the mailer using an account containing funds from corporate sources prohibited by the FECA and that were otherwise not subject to the limitations, prohibitions, and reporting requirements of the FECA constitute an apparent violation of 2 U.S.C. § 30125(b)(1), 11 C.F.R. § 300.32(a)(2), 11 C.F.R. § 300.33(c), 11 C.F.R. § 100.80, and 11 C.F.R. § 100.140.

## Count 2: Federal Candidate "Soft Money" Expenditures and Receipts

40. Federal law provides that any federal candidate, agent of a candidate, or entity directly or indirectly controlled by or acting on behalf of a candidate "shall not solicit, receive direct, transfer, or spend funds in connection with an election for Federal office, including [but not limited to] funds for any Federal election activity, unless the funds are subject to the limitations, prohibitions, and reporting requirements of [the FECA]." 52 U.S.C. § 30125(e)(1)(A).
41. That same section further prohibits the candidate, his agent, or any entity over which he exercises control or that acts on his behalf from receiving, directing, transferring or spending non-Federal funds in connection with any state or local election. 52 U.S.C. § 30125(e)(1)(B).
42. Smith was a federal candidate who concomitantly served in a leadership role in the BCRCC at the time it spent funds in a non-Federal account, containing non-Federal funds, on contributions to his federal campaign and on a mailer in connection with his federal election.
43. There is sufficient information for the Commission to find reason to believe that Zollinger was an agent of Smith.
44. There is sufficient information for the Commission to find reason to believe that BCRCC was an entity controlled by Smith or acting on Smith's behalf.
45. To the extent that Smith or his campaign, either by themselves or through Zollinger as an agent, solicited, received, directed, transferred, or spent funds in connection with Smith's election for Federal office, including [but not limited to] funds for any Federal election activity, that were not subject to the limitations, prohibitions, and reporting requirements of [the FECA], then there is sufficient reason to believe that they violated 52 U.S.C. § $30125(\mathrm{e})(1)(\mathrm{A})$.

## Count 3: Failure to Register as a Political Committee

46. FEC regulations define a local committee of a political party - like the BCRCC as a "political committee" if, among other things, the local committee makes payments exempted from the definition of "contribution" under 11 CFR $\S \S 100.80$ and exempted from the definition of "expenditure" under 11 CFR $\S \S 100.140$ in excess of $\$ 5,000$ during a calendar year. 11 CFR § 100.5(c).
47. The BCRCC qualifies as a political committee under federal law because it meets this threshold.
48. Because the mailer is a "sample ballot" and the funds spent on it by BCRCC are exempted from the definition of "contribution" under 11 C.F.R. $\S 100.80$ and from the definition of "expenditure" under 11 C.F.R. § 100.140 , BCRCC became a political committee at least when it spent in excess of $\$ 5,000$ during the 2022 calendar year to create, print, and distribute it.
49. Once the BCRCC became a political committee, it had to register as such with the FEC, which it has failed to do in apparent violation of 11 C.F.R. § 102.1(d).

## Count 4: Failure to Include Disclaimer

50. Federal law requires public communications authorized by a political party committee, that qualifies as exempt activity under 11 C.F.R. § 100.140 to comply with the disclaimer requirements of 11 C.F.R. § 110.11(a)(2), (b), and (c)(1)-(2).
51. Among other things, those sections require that public communications such as the BCRCC's "sample ballot" must include a disclaimer that clearly and conspicuously gives the reader adequate notice of the identity of the political committee that paid for it. And where the public communication is printed, the disclaimer "must be contained in a printed box set apart from the other contents of the communication." 11 C.F.R. § 110.11(c)(2).
52. The mailer lacked a clear and conspicuous disclaimer to indicate clearly and unmistakably who had paid for the advertisement as required by 11 C.F.R. § 110.11(a)(2), (b), and (c)(1)-(2).
53. At best, the information included in the mailer was ambiguous as to who paid for the mailer. The "OFFICIAL Republican Party" authorized to make endorsements of federal candidates in the Idaho primary elections is the Idaho Republican Party, not the Bonneville County Republican Central Committee, so readers of the mailer could easily be misled into believing the Idaho Republican Party paid for the mailer.
54. Moreover, to the extent disclaimer information was provided, it was not contained in a printed box set apart from the other contents of the communication.

## Prayer for Relief

1. Wherefore, the Commission should find sufficient reason to believe that BCRCC and Smith violated 52 U.S.C. § 30101, et seq., and conduct an immediate investigation under 52 U.S.C. § 30109(a)(2).
2. Further, the Commission should seek appropriate remedies and sanctions for any and all violations, including requiring Respondents to file true and accurate reports reflecting all contributions, make appropriate registrations, refund or disgorgement of excessive and prohibited contributions, and pay appropriate civil penalties, as well as any other such additional remedies as are necessary and appropriate to ensure compliance with the FECA.

## Bonneville County GOP, Primary Contributions

Chairman Mark Fuller and the Bonneville County Republican Central Committee,

According to State Party rules, Article 12, sections 1-2,"The State Republican Party shall exercise supervisory and judicial oversight of all Region Executive Committees, Region Central Committees, County Central Committees..." upon request from an aggrieved party. Further, "the State Republican Party may issue orders to compel performance, prohibit an act from being done, and to otherwise remedy violations of the Idaho Republican Party Rules."

Due to receiving several requests concerning a possible violation of the Bonneville County Republican Central Committee's (BCRCC) by-laws, and after offering an opportunity for affected parties to be heard, and reviewing the submitted grievances, here are the facts of this matter.

- The Bonneville County Republican Central Committee (BCRCC) made direct cash contributions to contested Republican races in the 2022 primary election. (SOURCE)
- The BCRCC by-laws, revised February 13, 2020, state in Article 2, Policy (D), "It shall be the policy of the committee to: (D) Take no position in favor of any Republican candidate engaged in a primary election contest." (SOURCE)
- The referenced Article 2, Policy (D) of the BCRCC by-laws were not amended prior to dispensing candidate contributions.
- Under Article 12 of the BCRCC by-laws, Procedures Not Covered Under These By-Laws, "The Idaho Code shall govern this organization in all cases for which it is applicable. The rules contained in Robert's Rules of Order, revised/latest edition, shall govern this organization in all cases for which they are applicable, and in which they are not inconsistent with these Central Committee's Bylaws."
- No actions were taken through Robert's Rules of Order (RORN) to suspend the rules as outlined in RORN, Section 25, subpart 1.
- The State Party may compel performance to remedy violations within County Republican Central Committees. (State Party rules, Article 12, sections 1-3) IDAHO REPUBLICAN PARTY



## Conclusion

The by-laws of the BCRCC clearly prohibit the county committee from supporting positions in favur of ahy Republican candidate engaged in a primary election contest. The BCRCC has, through its rules, clearly opted to NOT engage in the endorsement process during primary elections.

By unequally contributing in contested Republican primary races, the BCRCC took a position in favor of those candidates, thus violating the BCRCC by-laws, Article 2, Policy (D). Additionally, despite an established process, there were no amendments to the BCRCC by-laws $t 0$ match the standard maintained in State Party rules. (Article 9, sections 1-3).

Arting within my duty as Statc Party Chainman, in respohsé to a filed grnevance, to correct this by-law violation, I am proposing three fair and reasonable options. The expectation is that one of these options will be implemented immediately to correct the violation.

1. Request a refund from any candidate who received a direct cash contribution.
2. Donate an equal amount to all Republican candidates in the contested primary race,
3. Provide a solution that corrects the violation of the BCRCC Article 2, Policy (D) by-law provision to "take no position in favor of any Republican candidate engaged in a primary election contest."

## Closing Considerations

We may not always agree with the outcome, but we must have trust in the process and in each othêr to act with integrity. This decision would be the outcome for any county with specific provisions prohibiting a county committee from favoring a candidate in primary elections. We must apply our rules uniformly and in goud faith, and that is what I have done. I humbly ask the BCRCC to immediately correct this violation and allow us to move forward together.

At the next Central Committee meeting will vote on changing the bylaws and going back and ratifying all of the donations made previously
