I am filing this complaint to notify the FEC of violations made by the Onondaga County Republican Party Chairwoman, Benedicte Doran on behalf of the Steve Wells for Congress Campaign on Saturday, August 13th 2022.

Registered Republican Primary voters throughout the NY-22 Congressional District recieved mass mailings submitted from the Desk of Benedicte Doran encouraging them to get out and vote for Candidate, Steve Wells on Tuesday August 23rd.

Said mass mailers are an example of a public communication made for the purpose of influencing an election. None of these mailers included the FEC required "clear and conspicuous" disclaimer and thus is a violation of FEC regulations.



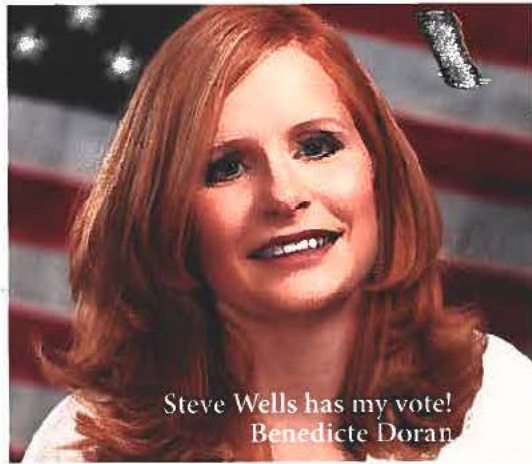
