Dear Mr. Keeys,

This response is submitted by the undersigned counsel on behalf of Steve Wells for Congress and Janna Rutland, in her capacity as Treasurer, and Benedicte Doran in MUR 8054. Mr. Wells was a candidate for the U.S. House of Representatives in New York's 22nd Congressional District. Mr. Wells lost his primary election on August 23, 2022.

The Complaint alleges that "Steve Wells for Congress Campaign" failed to include a disclaimer on a certain mailer. As a result of vendor error, the mailer in question lacked the appropriate "Paid for by Steve Wells for Congress" disclaimer. However, the mailer featured the Wells campaign logo on both sides along with a photo of Mr. Wells.

The mailer included with the Complaint was part of a program that allowed campaign supporters to select friends and associates from a database of registered voters to receive a personalized mailer from the Wells campaign. For example, the mailer included with the complaint includes a photo of Ms. Doran and a message "from her desk." (Ms. Doran served as paid staff for the Wells campaign.) The total cost of this program, including vendor services, printing/production, and postage was \$3,399.84. The program was managed by two vendors who do not normally produce mailers for federal campaigns and they neglected to include the "paid for by" disclaimer. The vendors have been made aware of this error, but corrective action is not possible at this time.

Nevertheless, the mailers at issue prominently featured the Steve Wells for Congress campaign logo on both sides, along with a photo of Mr. Wells. There was very little likelihood that anyone would be confused as to its source. This includes the complainant, who obviously was able to discern the source well enough to file a complaint. In similar circumstances, the Commission has dismissed complaints of this nature, generally as low rated matters not warranting additional Commission time and resources. *See, e.g.*, MUR 6896 (Margie Wakefield for Congress); MUR 6835 (Lesli Gooch for Congress); MURs 6799 and 6842 (Frank Scaturro for Congress); MUR 6677 (Charles Boustany Jr. MD for Congress); MUR 6336 (Moak for

Congress). In light of Commission precedent and the totality of the circumstances, we respectfully request similar treatment here.
