## 11 I. INTRODUCTION

12 These matters arise from Complaints alleging that Joseph R. Biden, Jr., became a  
 13 candidate for President in the 2024 election cycle prior to his April 2023 formal announcement  
 14 and failed to file a Statement of Candidacy with the Commission within 15 days of becoming a  
 15 candidate in violation of the Federal Election Campaign Act of 1971, as amended (the "Act").

16 The Complaint in MUR 7931 alleges that Biden surpassed the \$5,000 threshold for  
 17 candidacy via contributions received by his authorized committee, Biden for President and  
 18 Keana Spencer in her official capacity as treasurer (the "Biden Committee"), and Biden Victory  
 19 Fund and Monica Guardiola in her official capacity as treasurer (the "Victory Fund"), a joint  
 20 fundraising committee in which the Biden Committee is a participant, as well as via  
 21 disbursements made by the Biden Committee and the Victory Fund. The MUR 7931 Complaint  
 22 further alleges that both the Biden Committee and the Victory Fund have failed to make  
 23 necessary amendments to their Statements of Organization to reflect Biden's 2024 candidacy. In  
 24 addition, the Complainant in MUR 7931 has filed three supplements to its Complaint  
 25 documenting statements made by Biden and individuals associated with him and his  
 26 administration in support of the MUR 7931 Complaint's claim that Biden decided to run for  
 27 reelection long before his formal declaration of candidacy. The Complaint in MUR 8059  
 28 similarly alleges that Biden failed to timely file a Statement of Candidacy despite consistent

1 statements indicating that he had determined to run for reelection and that Biden crossed the  
2 \$5,000 statutory threshold because the Biden Committee had spent, at the time of that  
3 Complaint, more than \$5 million including for text messaging, email, and database services.

4 Respondents deny the allegations, asserting that, at the time the Responses were  
5 submitted, Biden had not yet conclusively determined to run for reelection in 2024, nor had he or  
6 his affiliated committees raised or spent \$5,000 or more in connection with the 2024 presidential  
7 election. Regarding contributions, Respondents state that all contributions received by the Biden  
8 Committee after the 2020 election were solicited and made prior to the election and that all funds  
9 raised by the Victory Fund for the Biden Committee were contributions solicited and made prior  
10 to Election Day. They state that other funds raised by the Victory Fund after Election Day 2020  
11 were not allocated or transferred to the Biden Committee. Regarding disbursements,  
12 Respondents state that all expenditures made by the Biden Committee after November 3, 2020,  
13 were associated with winding-down activities or maintenance of records or property, obligations  
14 incurred during the 2020 election cycle, and expenses incurred in connection with fundraising for  
15 the Democratic National Committee (the "DNC") in the 2022 election cycle, and that the Biden  
16 Committee has made no disbursements to influence the 2024 presidential election. Respondents  
17 state that expenditures made by the Victory Fund were to pay for services received prior to  
18 Election Day and for services to maintain the Victory Fund while it winds down its operations.

19 After the filing of the Responses, on April 25, 2023, Biden filed a Statement of  
20 Candidacy with the Commission indicating that he is running for reelection in 2024 and naming  
21 both the Biden Committee and the Victory Fund as authorized committees.

22 As discussed below, the available information indicates that although Biden appears to  
23 have made statements indicating that he had decided to become a candidate as early as March

1 2021, neither Biden nor the Biden Committee appears to have accepted any contributions for the  
2 2024 election cycle, and it is unclear as to whether they made expenditures in excess of \$5,000 to  
3 satisfy the statutory threshold for becoming a candidate. At the same time, the available  
4 information indicates that the Biden Committee did not accurately disclose all of its spending  
5 given that its disbursements to one vendor, Upland Software Inc., may have been for purposes  
6 different from or beyond those stated in the Biden Committee's Responses and its disclosure  
7 reports. Accordingly, we recommend the Commission: (1) take no action at this time with  
8 respect to the allegation that Biden violated 52 U.S.C. § 30102(e)(1) and 11 C.F.R. § 101.1 by  
9 failing to timely file a Statement of Candidacy and designate an authorized committee within 15  
10 days of becoming a candidate; and (2) find reason to believe the Biden Committee violated 52  
11 U.S.C. § 30104(b)(5)(A) and 11 C.F.R. § 104.3(b)(4)(i) by failing to properly disclose the  
12 purpose of its disbursements to Upland Software. We intend to conduct an investigation to  
13 resolve the reporting allegation and therefore recommend that the Commission approve  
14 compulsory process so that the Office of General Counsel may complete the factual record.

15 Additionally, because the available information indicates that the Victory Fund incurred a  
16 debt of \$100,000 in August 2020 that was not disclosed until it received and paid the associated  
17 invoice in 2021, we recommend that the Commission find reason to believe the Victory Fund  
18 violated 52 U.S.C. § 30104(b)(8) and 11 C.F.R. § 104.11(b) by failing to report a debt of greater  
19 than \$500 at the time it was incurred. We further recommend the Commission authorize pre-  
20 probable cause conciliation with the Victory Fund to resolve its debt reporting violation.

21 Finally, because neither the Biden Committee nor the Victory Fund had any obligation to  
22 amend their Statements of Organization to reflect the election cycle relevant to Biden's  
23 candidacy, we recommend the Commission find no reason to believe that either entity violated

1 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend their Statements of  
2 Organization.

## 3 II. FACTUAL BACKGROUND

### 4 A. Statements Made by Biden and His Surrogates Regarding a 2024 5 Presidential Candidacy

6 Joseph R. Biden, Jr., was elected the 46th President of the United States on November 3,  
7 2020.<sup>1</sup> He filed a Statement of Candidacy for the 2024 election on April 25, 2023.<sup>2</sup>

8 Beginning in early 2021, Biden and his surrogates made a number of public statements  
9 about whether Biden had made a decision to run for President in 2024, as referenced in the  
10 Complaints. As early as March 25, 2021, when asked whether he had “decided whether [he was]  
11 going to run for reelection in 2024,” Biden responded that “the answer is ‘yes.’ My plan is to  
12 run for reelection. That’s my expectation.”<sup>3</sup> Later that year, in November 2021, then-Press  
13 Secretary Jen Psaki was asked about “reports that President Biden was telling allies that he is  
14 going to run for reelection in 2024” and whether she could confirm whether he is “going to run  
15 in 2024,” to which Psaki responded that “[h]e is, that’s his intention.”<sup>4</sup> Two months later, on  
16 January 19, 2022, when asked whether Vice President Kamala Harris would be his Vice

1 President on the 2024 ticket and whether he thought she was doing a good job on voting rights  
2 policies, Biden responded “[y]es and yes,” indicating that he had determined to run in 2024 and  
3 again would select Harris as his running mate.<sup>5</sup>

4 Subsequent press reports have reiterated that Biden had made up his mind regarding the  
5 2024 election: *Intelligencer* reported on May 24, 2022, that “in [Biden’s] mind there’s no  
6 question he’s running. . . . ‘Yes!’ he told an interviewer . . . , sighing a little performatively at  
7 having to keep repeating it.”<sup>6</sup> The article went on to state that:

8 Every one of the would-be candidates has consistently maintained  
9 that their own presidential prospects are moot because Biden is  
10 running with their full support. As far as Biden’s camp is  
11 concerned, there isn’t any ambiguity about 2024 at all. He has said  
12 in private that he sees himself as the only thing standing between  
13 the country [the reelection of Donald Trump] and has instructed his  
14 aides to redouble their planning for a rematch. “People ask me  
15 with some regularity, ‘When is Biden going to come out and say  
16 what he’s going to do?’” an exasperated longtime Biden adviser  
17 told me recently. “And I say, ‘Well, he has!’”<sup>7</sup>

18 Biden was also later reported as being relieved that Senator Bernard Sanders would not challenge  
19 him in 2024, and the same press article states that aides argue that Biden is not just intending to  
20 run but also “laying the groundwork by building resources at the [DNC], restocking his operation

1 in battleground states[,] and looking to use his influence to shape the nomination process in his  
2 favor.”<sup>8</sup>

3 In addition to press accounts, individuals associated with Biden's campaign and the  
4 White House have repeatedly stated that he will run for reelection. On June 13, 2022, Press  
5 Secretary Karine Jean-Pierre stated at a Press Briefing, “Yes, he's running for reelection. I'm —  
6 I can't say more than that.”<sup>9</sup> The same day, Jean-Pierre tweeted, “To be clear, as the President  
7 has said repeatedly, he plans to run in 2024.”<sup>10</sup> Four days later, *The Washington Post* reported  
8 that a dozen unnamed “Democrats close to the White House” had stated that, “[i]n public and  
9 private, Biden himself has emphasized that he is running, effectively shutting down any  
10 discussion of the topic between the president and his close advisers.”<sup>11</sup>

11 Twice in late June 2022, Vice President Kamala Harris confirmed her understanding of  
12 Biden's intention to run, stating first that “Joe Biden is running for reelection and I will be his  
13 ticket-mate. Full stop.”<sup>12</sup> Two days later, she said that “[t]he president intends to run and if he

1 does, I will be his ticket mate. We will run together.”<sup>13</sup> Regarding this remark, *The Los Angeles*  
2 *Times* reported that an unnamed “prominent Democrat who is close to the White House” said  
3 that Harris made the clarifying statement to “avoid using ‘trigger words’ that would set off  
4 requirements for Biden to establish a formal campaign with the Federal Election Commission  
5 and begin fundraising.”<sup>14</sup>

6 In July 2022, *CNN* reported that Biden had “insisted privately to donors and others [that  
7 he is] their strongest candidate to beat Donald Trump — or another GOP candidate — in  
8 2024.”<sup>15</sup> It further reported that four unidentified aides stated that there are “muted worries . . .  
9 going around the West Wing . . . that someone may yet emerge ahead of the President’s planned  
10 spring 2023 formal reelection campaign launch. Biden advisers expect to stick to that no matter  
11 what happens, including if Trump decides to jump in early.”<sup>16</sup> Later in July 2022, Press  
12 Secretary Jean-Pierre stated, “I’m going to be very clear; I’m going to say this once — and the  
13 President has been very clear about this: He intends to run in 2024. And he is going to — until  
14 then, he is going to do the business of the American people as he has been doing for the past 18  
15 months.”<sup>17</sup> The next day, she twice reiterated during a press briefing that “[t]he President

1 intends to run in 2024,”<sup>18</sup> and on August 1, 2022, she stated twice more that the President  
 2 “intends to run,” noting that he had “said that multiple times.”<sup>19</sup> She was reported as stating so  
 3 again on *This Week with George Stephanopoulos* on August 14, 2022.<sup>20</sup>

4 In August 2022, Secretary of Transportation Pete Buttigieg stated while appearing on  
 5 *CNBC* that he was “looking forward to supporting the president’s reelection. That is as much as  
 6 I can say about these things while I’m here on an official capacity.”<sup>21</sup> Less than a week later,  
 7 *Bloomberg* reported that former White House aide Cedric Richmond had said that “[i]t is clear-  
 8 cut that [Biden is] our best candidate. . . . If he says he’s planning on running, he’s running,”<sup>22</sup>  
 9 and that longtime aide Anita Dunn stated, “The president has said he’s planning on running  
 10 again. People should take him at his word.”<sup>23</sup> *Bloomberg* further reported that unidentified aides  
 11 were “worried that [Biden] publicly declaring [his 2024 candidacy] before the [2022] midterms  
 12 [w]ould trigger legal restrictions on fundraising.”<sup>24</sup> In September 2022, Richmond told a

1 member of the press that Biden is “running and we’re building an infrastructure for him to run  
2 and win. Right now, it’s all an early investment in 2024 while we’re helping 2022.”<sup>25</sup> In late  
3 September 2022, Jean-Pierre again stated that Biden “intends to run. I don’t have any more  
4 announcements on that.”<sup>26</sup>

5         Though Biden claimed as late as February 2023 that he was “just not ready to make” the  
6 decision of whether to run for reelection in 2024,<sup>27</sup> having stated the prior September that he  
7 would “make a judgment on what to do . . . after [the 2022] election cycle here going into  
8 [2023],”<sup>28</sup> he also made clear that it was his “intention to run again” and that part of his concern  
9 about formally deciding to run was that, from the moment he did so, “a whole series of  
10 regulations kick[ed] in and [he has] to be — [he] treat[s] [him]self as a candidate from that  
11 moment on.”<sup>29</sup> In October 2022, *NBC* reported that Reverend Al Sharpton had told his staff at  
12 the National Action Network that Biden had told him, “I’m going to do it again. I’m going,”

1 concerning running for reelection.<sup>30</sup> Further, in November 2022, when asked what he would say  
2 to the “[t]wo thirds of Americans in exit polls [who] say that they don’t think [Biden] should run  
3 for reelection,” Biden responded, “Watch me.”<sup>31</sup> And in December 2022, *The New York Times*  
4 reported that Biden joined a toast at a state dinner with French President Emmanuel Macron to  
5 his 2024 campaign following an exchange in which Biden’s wife, Dr. Jill Biden, reportedly  
6 stated that she was “absolutely” ready for another campaign.<sup>32</sup>

7 Subsequent to the filing of the Complaints and the Responses in these matters, on April  
8 25, 2023, Biden announced that he was running for reelection in 2024,<sup>33</sup> and filed a Statement of  
9 Candidacy with the Commission in which he designated the Biden Committee as his principal  
10 campaign committee and listed the Victory Fund as another authorized committee.<sup>34</sup>

1           **B.       The Committees**

2                   1.       The Biden Committee

3           The Biden Committee is Biden's principal campaign committee.<sup>35</sup> Between November 4,  
 4 2020, and March 31, 2023, the Biden Committee reported \$134,048,699.80 in total receipts.<sup>36</sup>  
 5 Of this amount, the Biden Committee reported receiving \$103,362,129.86 in contributions  
 6 during the 2020 Post-General reporting period;<sup>37</sup> \$151.80 in contributions received during the  
 7 2020 Year-End reporting period;<sup>38</sup> and \$280 in the 2021 April Quarterly reporting period.<sup>39</sup> The  
 8 Biden Committee contends that all of the reported post-2020 election contributions were

1 solicited and made prior to Election Day.<sup>40</sup> The Biden Committee reported no additional  
 2 contributions after the 2021 April Quarterly Report.<sup>41</sup> The remaining receipts included  
 3 \$8,066,596.36 reported as offsets to operating expenditures<sup>42</sup> and \$36,003,662.60 in transfers  
 4 from other authorized committees, of which \$20,221,129.23 came from the Victory Fund,  
 5 discussed below.<sup>43</sup>

6 From November 4, 2020, through March 31, 2023, the Biden Committee also reported  
 7 making expenditures totaling \$294,730,269.94, all designated as for the 2020 election.<sup>44</sup> This  
 8 includes disbursements of, in the aggregate, \$478,158.91 to NGP Van Inc. for “database  
 9 subscription” and “processing fees,” \$5,083,361.49 to Upland Software Inc. for “software,” and  
 10 \$2,019,395.00 to Action Squared Inc. for “text message/email outreach” and “text message

1 outreach.”<sup>45</sup> The individual disbursements summarized above are listed in the Appendix to this  
 2 Report, span the time period from November 4, 2020, through March 23, 2023, and total  
 3 \$7,580,915.41.<sup>46</sup>

4 The Biden Committee did not disclose any debt, nor indicate its engagement in debt  
 5 fundraising, in any of its reports following the 2020 general election.<sup>47</sup>

## 6 2. The Victory Fund

7 The Victory Fund is a joint fundraising representative for the Biden Committee, the  
 8 DNC, and multiple state parties’ federal committees.<sup>48</sup> Since the 2020 general election, the  
 9 Victory Fund has reported receiving \$73,740,037.29 in total receipts, of which \$73,172,580.88  
 10 was reported as contributions.<sup>49</sup> It states that all contributions received for the Biden Committee

1 were made to it on or before Election Day, and that no contributions received after Election Day  
 2 have been transferred to the Biden Committee.<sup>50</sup> It has also reported spending \$78,027,083.84,<sup>51</sup>  
 3 including \$100,000 to Vox Media LLC on March 1, 2021, for “online fundraising.”<sup>52</sup> In  
 4 addition, the Victory Fund transferred \$20,221,129.23 to the Biden Committee as shown below:

1 In its 2020 Year-End Report, the Victory Fund disclosed debts of \$3,090.00 to Mal Warwick &  
 2 Associates, Inc. for “Direct Mail,” but provided no indication that it had engaged in debt-  
 3 settlement fundraising.<sup>60</sup>

#### 4 C. The Complaints and Responses

5 The Complaints allege that Biden became a candidate for President in the 2024 election  
 6 cycle by both making a private determination to run and by raising and spending greater than  
 7 \$5,000 in support of his candidacy via the Biden Committee and the Victory Fund<sup>61</sup> beginning  
 8 shortly after his election in November 2020, and that he accordingly failed to timely file a

1 Statement of Candidacy and designate a principal campaign committee.<sup>62</sup> The MUR 7931  
2 Complaint questions how certain ongoing expenditures made through 2021 can be designated for  
3 the 2020 election cycle and alleges that the Biden Committee either incorrectly reported the  
4 election cycle for its expenditures or failed to report any debts or outstanding liabilities from the  
5 2020 general election.<sup>63</sup> Finally, the MUR 7931 Complaint alleges that the Biden Committee  
6 and the Victory Fund have failed to amend their Statements of Organization to reflect Biden's  
7 2024 candidacy.<sup>64</sup>

8           The Responses and three attached sworn declarations deny that Biden had, at the time of  
9 their submission, become a candidate for the 2024 election cycle, stating that Biden had neither  
10 made a decision to run nor raised or spent \$5,000 or more in support of any 2024 campaign.<sup>65</sup>  
11 Regarding first whether Biden had determined to run, Biden and the Biden Committee state that  
12 Biden had "a general intent to run for re-election, [but] he has not decided for certain that he will  
13 do so,"<sup>66</sup> and that he "has repeatedly stated that he will make a final decision as to whether to run  
14 for reelection after the [2022] mid-term elections."<sup>67</sup>

15           Regarding whether Biden or entities he has authorized to fundraise on his behalf have  
16 *raised* greater than the \$5,000 threshold for candidacy under the Act, Biden and the Biden  
17 Committee aver that the Biden Committee ceased soliciting contributions on Election Day 2020,  
18 and that all contributions received thereafter were "solicited and made on or before Election Day

1 or else refunded.”<sup>68</sup> They further state, as does the Victory Fund, that “all funds [the Victory  
2 Fund] transferred to [the Biden Committee] were comprised solely of contributions made to [the  
3 Victory Fund] on or before Election Day.”<sup>69</sup> With respect to funds received by the Victory Fund  
4 after Election Day as a result of pre-Election Day solicitations, the Victory Fund states that  
5 “none of the contributions made after Election Day were allocated or transferred to” the Biden  
6 Committee,<sup>70</sup> and the Biden Committee notes that funds raised after Election Day by the Victory  
7 Fund were “allocated to the accounts of other [joint fundraising] participants or refunded.”<sup>71</sup>  
8 Respondents attest that, as of the dates of the declarations and prior to Biden’s formal  
9 announcement, the Victory Fund “has not received consent from President Biden or [the Biden  
10 Campaign] to solicit or accept contributions on behalf of either for the 2024 election cycle.”<sup>72</sup>

11       Regarding whether Biden or his committees have *spent* \$5,000 or more in support of his  
12 2024 candidacy, both the Biden Committee and the Victory Fund deny that they had spent any  
13 funds to “influence the 2024 presidential election” at the time of the Responses.<sup>73</sup> With respect  
14 to the \$478,158.91 that the Biden Committee disbursed to NGP Van Inc. for a “database

1 subscription,” the Biden Committee states, relying upon a sworn declaration from its campaign  
2 consultant, that these payments were for an “accounting and compliance database subscription  
3 necessary to maintain records to comply with the Act” and “necessary for operations during the  
4 wind down and the Commission’s reporting requirements, and costs necessary to protect [the  
5 Biden Committee’s] intellectual property.”<sup>74</sup> Concerning the \$5,083,361.49 disbursed to Upland  
6 Software Inc. for “software,” the Biden Committee states that the payments were “related to [the  
7 Biden Committee’s] ownership of a[n] SMS short code.”<sup>75</sup> With respect to the \$2,019,395 the  
8 Biden Committee has disbursed to Action Squared Inc. for “text message/email outreach” and  
9 “text message outreach,”<sup>76</sup> the Biden Committee states that these payments:

10 relate to ongoing communications by the President to his  
11 supporters who have opted-in to receive messages, encouraging  
12 them to make contributions to the [DNC] . . . in 2021 and 2022. . . .  
13 The messages make no reference to the 2024 election or the  
14 potential of President Biden running for re-election.<sup>77</sup>

1 With respect to the \$100,000 disbursed by the Victory Fund to Vox Media LLC for online  
2 fundraising, Respondents state that this “expenditure was for an advertisement purchased in  
3 August 2020 but for which [the Victory Fund] received an invoice in 2021.”<sup>78</sup>

4 The Respondents further deny that the Biden Committee and the Victory Fund have  
5 failed to amend their Statements of Organization with the Commission. The Biden campaign  
6 states that this is “because [a Statement of Organization] does not require the campaign  
7 committee to identify the election for which the candidate seeks office, and because President  
8 Biden has taken no action that has made him a candidate for president in 2024” even if it did so  
9 require.<sup>79</sup> The Victory Fund states that this is because:

10 There is nothing in the Act or Commission regulations requiring a  
11 joint fundraising committee to indicate on its Statement of  
12 Organization that it is raising funds in connection with any  
13 particular election or to indicate on its Statement of Organization  
14 which office in which election year its participating candidate  
15 committees are seeking. There is simply no place to put this  
16 information on the Commission’s current version of [the Statement  
17 of Organization] form.<sup>80</sup>

18 The Victory Fund goes on to assert that it was “not even required to disclose on its Statement of  
19 Organization that President Biden was running in the 2020 election last year, much less amend  
20 this information.”<sup>81</sup>

1 **III. LEGAL ANALYSIS**

2 **A. The Commission Should Take No Action At This Time With Respect to the**  
 3 **Allegation That Biden Failed to Timely File a Statement of Candidacy**

4 As discussed below, the available information strongly supports the Complaints'  
 5 allegations that Biden made a private decision to run for reelection prior to the time of his formal  
 6 announcement in April 2023. At the same time, the available information is unclear about  
 7 whether Respondents engaged in any spending in furtherance of that potential candidacy, with  
 8 the approximately \$5 million disbursed to Upland Software appearing to be the most likely  
 9 spending that potentially may have been for that purpose. Finally, the available information  
 10 supports Respondents' claim that they did not receive contributions for Biden's reelection, at  
 11 least until the April 2023 formal announcement.

12 1. The Available Information Indicates that Biden Decided to Run for  
 13 Reelection in 2024 as Early as March 2021

14 Under the Act and Commission regulations, an individual becomes a candidate when the  
 15 person (1) decides to run for office<sup>82</sup> and (2) receives contributions or makes expenditures  
 16 exceeding \$5,000, either directly or through an entity the candidate has consented to receive  
 17 contributions or make expenditures on their behalf.<sup>83</sup>

18 Commission regulations set forth a non-exhaustive set of “[e]xamples of activities that  
 19 indicate that an individual has decided to become a candidate.”<sup>84</sup> Such indicia include: (1) using

1 “general public political advertising to publicize his or her intention to campaign for federal  
2 office”;<sup>85</sup> (2) raising “funds in excess of what could reasonably be expected to be used for  
3 exploratory activities or undertak[ing] activity designed to amass campaign funds that would be  
4 spent after he or she becomes a candidate”;<sup>86</sup> (3) making or authorizing “written or oral  
5 statements that refer to the individual as a candidate for a particular office”;<sup>87</sup> (4) conducting  
6 “activities in close proximity to the election or over a protracted period of time”;<sup>88</sup> and (5) taking  
7 “action to qualify for the ballot under state law.”<sup>89</sup>

8         In previous matters, the Commission has found reason to believe that an individual had  
9 become a candidate and failed to timely file a Statement of Candidacy when public statements  
10 and other indicia showed that the respondent had determined to run for office. In MUR 6449  
11 (Jon Bruning, *et al.*), the Commission found that an individual who had publicly said “I want to  
12 run. I’m ready to run” and made a solicitation to “help [him] defeat” his primary opponent had  
13 made the decision to campaign for office and become a candidate under the Act.<sup>90</sup> In MUR 6735  
14 (Joseph A. Sestak, *et al.*), the Commission found that an individual who had solicited funds via  
15 emails asking for support in his attempt to “seek the U.S. Senate” and to “help [him] serve you,  
16 again” indicated that he had determined to run and was not testing the waters for a potential  
17 campaign.<sup>91</sup> And in MUR 5908 (Duncan Hunter, *et al.*), the Commission found that an

1 individual who stated, *inter alia*, “while I’ve announced that I am preparing to run for president,  
2 I have not made a formal announcement of my candidacy” had, in fact, become a candidate.<sup>92</sup>

3 Further, in Advisory Opinion 2015-09, the Commission advised that an individual  
4 becomes a candidate when the individual passes the \$5,000 threshold and “when he or she makes  
5 a private determination that he or she will run for federal office.”<sup>93</sup> When determining whether  
6 an individual “has made a decision to run for federal office, [the Commission] assesses an  
7 individual’s objectively deliberate actions to discern whether and when an individual decided to  
8 become a candidate.”<sup>94</sup> The Commission has also advised that “[a] non-conditional statement by  
9 an individual (directly or indirectly) that he or she ‘will’ announce his or her candidacy on a  
10 given date unambiguously indicates that the individual has decided to become a candidate.”<sup>95</sup>

11 Here, Biden’s activities indicate that he had decided to run for reelection in 2024 as early  
12 as March 25, 2021. As set forth in the Commission’s non-exhaustive list of activities that  
13 indicate when an individual has decided to become a candidate, one such indication is that the  
14 individual has made or authorized statements that refer to the individual as a candidate for a  
15 particular office.<sup>96</sup> Biden and his surrogates’ public statements have consistently indicated that  
16 he had decided to run for reelection in 2024 well prior to his April 2023 formal announcement  
17 regarding his candidacy. Below is a chart detailing some of his statements since March 2021,  
18 discussed in Part II.A, above:

1 early as March 2021 indicate that he intended to do so. In MUR 5908, the Commission found  
2 that a statement that the individual had “announced that I am preparing to run for president, [but]  
3 I have not made a formal announcement of my candidacy” was sufficient basis on which to  
4 determine the individual had decided to run for office and become a candidate;<sup>128</sup> accordingly,  
5 Biden’s statements that he intended to run for reelection likewise present a sufficient basis for  
6 the Commission to conclude that Biden had decided to become a candidate. In addition to the  
7 statements already discussed, press reports relying on unnamed sources close to the White House  
8 indicate that Biden planned a “spring 2023 formal reelection campaign launch,”<sup>129</sup> precisely in  
9 line with the timing of Biden’s actual formal announcement on April 25, 2023.<sup>130</sup>

10 Respondents principally appear to contend that the numerous statements do not indicate  
11 that Biden has made a private determination to run. However, while Biden’s statements that he  
12 “intends” to run may be arguably less direct than a statement indicating he “will” run, Biden said  
13 that he had made a decision and that he “*plan[s]* to run for reelection,”<sup>131</sup> with both the Press  
14 Secretary stating, “Yes, he’s running for reelection. I’m — I can’t say more than that,”<sup>132</sup> and  
15 Vice President Harris stating, “Joe Biden is running for reelection and I will be his ticket-mate.  
16 Full stop.”<sup>133</sup> Though Biden and his surrogates subsequently stated that he had not made a  
17 formal decision regarding his 2024 candidacy, the Commission has previously advised that,  
18 where an individual makes a statement evincing that they have decided to become a candidate,

1 “the statement may trigger candidacy regardless of subsequent retraction attempts.”<sup>134</sup> Further,  
2 in MURs 6955, 6983 (John R. Kasich, *et al.*), the Commission found that a “‘non-conditional  
3 statement’ by an individual . . . that he or she ‘*will* announce his or her candidacy on a given date  
4 unambiguously indicates that the individual has decided to become a candidate.’”<sup>135</sup>

5 Additionally, Biden’s reference to a decision to run implicating a “whole series of  
6 regulations,”<sup>136</sup> including “election laws,”<sup>137</sup> appears to confirm his decision to run. If he were  
7 not going to run, his decision would not cause a change from the *status quo* with respect to his  
8 campaign finance obligations, whereas deciding to run (and crossing the statutory monetary  
9 thresholds, discussed *infra*) would immediately implicate the Act’s Statement of Candidacy and  
10 committee designation requirements.<sup>138</sup>

11 The Responses do not dispute the accuracy of any of the statements attributed to Biden or  
12 his surrogates in the Complaints, and instead assert that one of the Complaints “focuses on  
13 anonymously sourced news stories, musings by political insiders, and half-quotes from White  
14 House staff”<sup>139</sup> and that the statements do not have “any bearing on the question at issue”  
15 regarding whether Biden has raised or spent \$5,000 or more for the 2024 presidential election.<sup>140</sup>  
16 Here, as in the matters discussed above in which the Commission evaluated candidate statements

1 using objective criteria, Biden's and his surrogate's public statements have made clear that he  
2 determined to run for reelection in 2024 as early as March 25, 2021. These statements alone  
3 would be sufficient to indicate that Biden has "made a decision to become a candidate."<sup>141</sup>

4 Further, one of the factors the Commission has identified as indicia that a candidate has  
5 determined to run for office is whether the individual is "conducting activities in close proximity  
6 to the election or over a protracted period of time."<sup>142</sup> As discussed above, at the time of this  
7 Report, Biden had made public statements indicating that he had determined to run for president  
8 over a period spanning approximately two years. Though the Commission has not elaborated on  
9 what constitutes a "protracted period of time," and noted in the testing-the-waters context that  
10 "the length of time that an individual spends deliberating whether to become a candidate is one  
11 factor and does not, in and of itself, determine whether the individual has become a  
12 candidate,"<sup>143</sup> two years, or half a presidential term, appears to fall within the scope of a  
13 "protracted period of time."<sup>144</sup>

1                   2.     It Is Unclear Whether Biden Has Surpassed the Threshold for Candidacy  
2                             by Making More Than \$5,000 in Expenditures

3                   As discussed above, once an individual decides to run for office, the individual becomes  
4 a candidate under the Act when: (a) such individual receives contributions or makes  
5 expenditures in excess of \$5,000; or (b) such individual gives their consent to another person to  
6 receive contributions or make expenditures on behalf of such individual and if such person has  
7 received such contributions or has made such expenditures in excess of \$5,000.<sup>145</sup> Once the  
8 \$5,000 threshold has been met, the candidate has 15 days to designate a principal campaign  
9 committee by filing a Statement of Candidacy with the Commission.<sup>146</sup> The principal campaign  
10 committee must file a Statement of Organization within ten days of its designation,<sup>147</sup> and it must  
11 file disclosure reports with the Commission.<sup>148</sup>

12                  The Commission has established “testing-the-waters” regulations excepting from the  
13 definitions of “contribution” and “expenditure” funds received and payments made solely to  
14 determine whether an individual should become a candidate, thereby permitting an individual to  
15 test the feasibility of a campaign for federal office without becoming a candidate under the  
16 Act.<sup>149</sup> These testing-the-waters regulations seek to draw a distinction between activities  
17 directed to evaluating the feasibility of one’s candidacy and conduct signifying that a decision to  
18 become a candidate has been made.<sup>150</sup> The testing-the-waters exceptions are not available to an

1 individual who has decided to become a candidate, even if the individual has made only “a  
2 private determination that he or she will run for federal office.”<sup>151</sup>

3         The Commission’s regulations further provide that funds in a campaign account may be  
4 used for the “ordinary and necessary expenses incurred in connection with the recipient’s duties  
5 as a holder of Federal office,” such as “[t]he costs of winding down the office of a former  
6 Federal officeholder for a period of [six] months after he or she leaves office.”<sup>152</sup> The  
7 Commission has advised that winding-down costs include “the ‘necessary administrative costs’  
8 of terminating a campaign or congressional office, such as office space rental, staff salaries and  
9 office supplies.”<sup>153</sup> Although Commission regulations contemplate a time limit of six months for  
10 when a campaign for a former officeholder may use funds to pay for winding down costs,<sup>154</sup> the  
11 Commission has explained that this provision is a safe harbor that “does not preclude a former  
12 officeholder who can demonstrate that he or she has incurred ordinary and necessary winding  
13 down expenses more than six months after leaving office from using campaign funds to pay  
14 those expenses.”<sup>155</sup>

15         As discussed above, Biden appears to have made a decision to run for reelection in 2024  
16 as early as March 2021, but he does not become a candidate under the Act unless he, or another

1 person to whom he has given consent to do so, raises or spends in excess of \$5,000 in support of  
2 a 2024 candidacy.<sup>156</sup>

3 Here, the available information is murky about whether Biden passed the \$5,000  
4 threshold triggering status as a candidate via funds spent by the Biden Committee in support of  
5 his 2024 candidacy prior to his formal campaign announcement. Though the Biden Committee  
6 attests that Biden had not at the time of its Responses authorized the Biden Committee to solicit  
7 or spend funds on his behalf with respect to the 2024 election cycle,<sup>157</sup> because Biden designated  
8 the Biden Committee as his principal campaign committee, Biden has given consent to the Biden  
9 Committee to “receive contributions or make expenditures”<sup>158</sup> on his behalf; it is and has been  
10 his authorized campaign committee through which he received contributions and made  
11 expenditures during the 2020 election cycle, and which he has maintained as his authorized  
12 campaign committee for 2024.<sup>159</sup>

13 As discussed in Part II.B, above, the Biden Committee disbursed nearly \$295 million  
14 between November 4, 2020, and March 31, 2023.<sup>160</sup> Given the numerous statements made by  
15 Biden and his surrogates indicating that Biden had decided to run as a presidential candidate in  
16 2024 or intended to do so, the Complaints question the substantial spending by the Biden  
17 Committee and whether it has made more than \$5,000 in expenditures to support his 2024  
18 candidacy, especially as more than two years have passed since the 2020 general election.

1 Both the Biden Committee and the Victory Fund deny that they have spent any funds to  
2 “influence the 2024 presidential election.”<sup>161</sup> First, with respect to the Biden Committee’s  
3 \$478,158.91 in disbursements to NGP Van Inc. for “database subscription,” the Biden  
4 Committee avers that these disbursements were for “a compliance and accounting database  
5 necessary for operations during the wind down and the Commission’s reporting  
6 requirements.”<sup>162</sup> These expenditures appear to be consistent with those of at least one prior  
7 successful presidential candidate with respect to the same recipient: After his reelection in 2012,  
8 former President Barack Obama’s campaign committee reported total disbursements of  
9 \$315,784.60 to NGP Van Inc. for “technology consulting” and “telemarketing.”<sup>163</sup> Though  
10 “telemarketing” does not align with the “database subscription” reported by the Biden  
11 Committee, “technology consulting” may refer to services akin to those the Biden Committee  
12 describes in its disclosure reports and Responses. Accordingly, Respondents have credibly  
13 rebutted the Complaints’ allegations that these expenditures were associated with Biden’s 2024  
14 candidacy.

15 The disbursements to Upland Software Inc. for “software” are more difficult to evaluate.  
16 With respect to these disbursements, the Biden Committee states in a sworn declaration that  
17 these disbursements were to “maintain ownership of [the Biden Committee’s] SMS short code

1 phone number, used for communications with [the Biden Committee],”<sup>164</sup> and which the Biden  
2 Committee describes as its “intellectual property.”<sup>165</sup> Comparisons to prior presidential  
3 campaign committee are unhelpful, as prior committees do not appear to have identified  
4 expenditures for similar purposes, likely because of the relative newness of the technology  
5 involved: For example, a search across all disbursements by the authorized committees of  
6 former presidential candidates Obama, Clinton, Romney, and McCain for disbursements with  
7 purposes containing any of “short code,” “SMS,” “text number,” “phone number” or “text id”  
8 revealed no results.<sup>166</sup>

9 As shown in the Appendix to this Report and the figure below, the amount and timing of  
10 the Biden Committee’s disbursements to Upland Software Inc. varied widely over the period  
11 between January 13, 2021, the first disbursement following the immediate aftermath of the 2020  
12 election, and September 23, 2021, the date of the Biden Committee’s last reported disbursement  
13 to this vendor, with disbursements ranging from \$2.34 to \$261,449, including multiple  
14 disbursements occurring on the same day for different amounts, and each disbursement reported

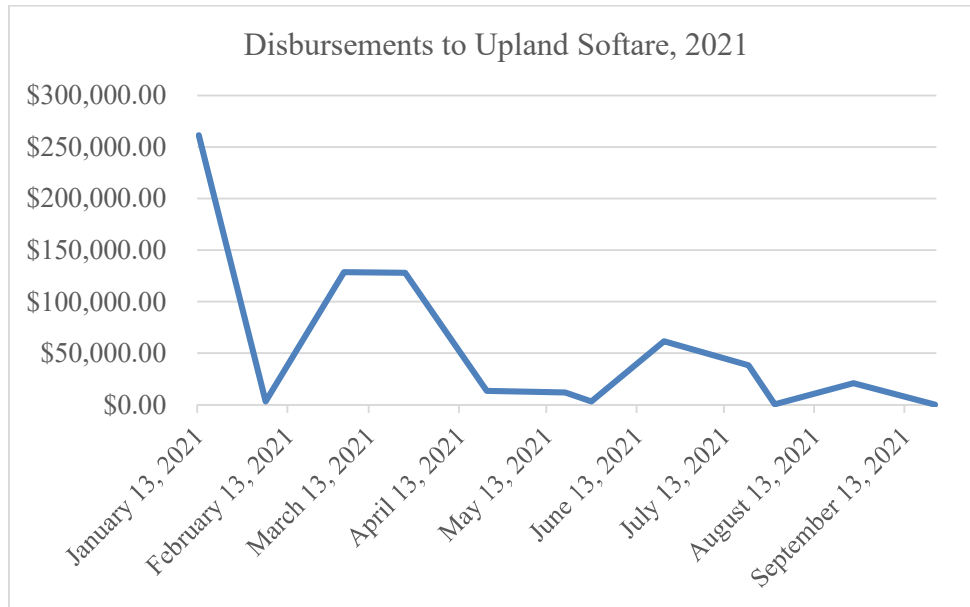

1 as for “software.”<sup>167</sup> Though the amounts disbursed decreased over time, as one might expect  
 2 with a campaign winding down its operations, the data reflects various jumps in spending  
 3 throughout 2021:



4  
 5 On its face, this information could be viewed as being in some tension with the Biden  
 6 Committee's sworn statement that the disbursements to this vendor were made in order to  
 7 maintain ownership of an SMS short code, which one might expect to have been implemented  
 8 through regular, or more routine, payments, akin to a subscription service provided at a set rate,  
 9 rather than charges varying by amount and time and appearing to be triggered by external events.  
 10 An online review of short code vendors indicates that the subscription model, using regular

1 identical payments, is both used in this context and at much lower costs.<sup>168</sup> At the same time and  
2 given the context of a sophisticated presidential campaign, the declaration's statement may  
3 accurately describe a different or more complex maintenance arrangement that happens to be  
4 subject to external events, like energy costs required to maintain a home between set temperature  
5 ranges (that will be subject to weather conditions) or the costs to maintain a maximum target  
6 hold time for customer service calls (that is subject to demand). Further, while Biden is not a  
7 former officeholder as contemplated in the regulations concerning winding-down activities, and  
8 the six-month time period for the winding-down safe harbor is as such not directly applicable to  
9 the circumstances presented here, the Responses do not clearly articulate why the Biden  
10 Committee would need to maintain an SMS short code over a period of more than ten months  
11 following Election Day 2020. It is possible that, consistent with the Complaints' allegations, the  
12 Biden Committee was maintaining the SMS short code as campaign infrastructure in the event  
13 that Biden would run for reelection in 2024, thus making the expenditures fairly linked to the  
14 2024 presidential election. But it is also possible that maintenance of the SMS short code, which  
15 the declaration asserts was "used for communications with [the Biden Committee],"<sup>169</sup> was  
16 necessary as a communications tool to further appropriate wind-down activities.<sup>170</sup> Though not

1 directly supported by the declaration, the Biden Committee also asserts that the expenditures  
2 were “to maintain records or property related to the 2020 election.”<sup>171</sup>

3         Given the more than \$5 million amount involved and the factual questions regarding the  
4 disbursements to Upland Software Inc., the Complaints’ allegation that these disbursements were  
5 for the purpose of advancing Biden’s 2024 reelection campaign is plausible. This is primarily  
6 because of the irregular nature of the payments and the fact that they appeared to be triggered by  
7 external events, suggestive of some type of engagement. Presuming that Biden’s first public  
8 statement on March 25, 2021, confirming that he intended to run, discussed in Parts II.A and  
9 III.A, *supra*, marks the date on which he made that determination, if the disbursements discussed  
10 above were for purpose of advancing his 2024 candidacy, Biden may have passed the \$5,000  
11 threshold via the Biden Committee’s \$128,021.73 disbursement to Upland Software Inc. that  
12 same day.<sup>172</sup> At the same time, however, Respondents attest that these costs were for  
13 maintaining ownership of the Biden Committee’s SMS short code and that this code was used  
14 for communications with the committee; they have further indicated that this information was  
15 related to maintaining records or property.<sup>173</sup> These explanations are also plausible, particularly  
16 given that the payments to Upland Software Inc. ceased after September 2021. On balance,  
17 while the available information indicates that the disbursements the Biden Committee made to

1 Upland Software Inc. do not appear to be solely for the purposes enumerated by the Biden  
 2 Committee, as discussed below,<sup>174</sup> we recommend that the Commission take no action at this  
 3 time as to the timing of his candidacy in light of our recommendation to investigate the potential  
 4 purpose reporting violation, which may shed light on the Complaints' late-candidacy allegations.

5 In addition, with respect to the Biden Committee's \$2.02 million in disbursements to  
 6 Action Squared Inc. for "text message/email outreach" and "text message outreach,"<sup>175</sup> the Biden  
 7 Committee states that the disbursements were for "ongoing communications by the President to  
 8 his supporters who have opted-in to receive messages, encouraging them to make contributions  
 9 to the [DNC] . . . in 2021 and 2022."<sup>176</sup> However, on its disclosure reports, the Biden Committee  
 10 reported each disbursement to Action Squared Inc. as being for the 2020 general election,<sup>177</sup> a  
 11 statement facially at odds with the purpose stated in the Biden Committee's Response.<sup>178</sup>

1 election, for instance, Obama for America disbursed a total of \$210,313.30 for “text  
 2 messages.”<sup>179</sup> And while, following the 2016 election, Trump’s authorized committee disbursed  
 3 a total of \$15.86 million for, *inter alia*, “online advertising,” “email marketing,” and “digital  
 4 consulting/online advertising,”<sup>180</sup> Trump had already declared his reelection candidacy on  
 5 January 20, 2017,<sup>181</sup> making this comparison less helpful. Notwithstanding the discrepancy  
 6 between which election these expenditures were associated with — 2020, as stated in the reports,  
 7 versus 2021 and 2022, as stated in the Responses — in neither event do they appear to be  
 8 associated with Biden’s 2024 candidacy.<sup>182</sup>

9           3.       The Available Information Does Not Indicate That Biden Became a  
 10                    Candidate by Accepting More than \$5,000 in Contributions

11           Regarding Biden and the Biden Committee’s receipts, since November 4, 2020, the  
 12 Biden Committee has reported receiving \$134,048,699.80,<sup>183</sup> including \$20,221,129.23 received  
 13 from the Victory Fund.<sup>184</sup> Of the \$134 million in total receipts, the Biden Committee reported

1 receiving \$103,362,129.86 in contributions during the 2020 Post-General reporting period,<sup>185</sup>  
2 with only \$482 in additional contributions disclosed on subsequent Reports.<sup>186</sup> Since the 2020  
3 general election, the Victory Fund has reported receiving \$2,414,952.90 in contributions.<sup>187</sup>  
4 Although the Complaints raise questions as to the amount of contributions accepted by the Biden  
5 Committee and the Victory Fund after the 2020 general election, the Respondents credibly rebut  
6 the allegations that those post-election contributions were attributable to a 2024 Biden  
7 candidacy.

8         The Biden Committee does not appear to have solicited or accepted contributions for  
9 Biden's reelection campaign prior to Biden's formal campaign announcement. First, the Biden  
10 Committee states in its MUR 7931 Response that it neither solicited nor accepted contributions  
11 made after Election Day 2020, and that it had not at the time of the Response accepted any  
12 contributions for the 2024 election cycle; the sworn statement attached to the MUR 7931  
13 Response supports this statement.<sup>188</sup> This Office is aware of no information that contradicts  
14 these assertions.

15             4.         The Victory Fund Does Not Appear to Have Accepted Contributions or  
16                         Made Expenditures in Support of Biden's 2024 Candidacy

17         The Victory Fund also does not appear to have solicited or accepted contributions for  
18 Biden's reelection campaign prior to Biden's formal campaign announcement. As noted above,  
19 the Biden Committee avers that the Victory Fund "is not authorized to, and has not," raised any

1 funds for Biden in the 2024 presidential election, to which the Victory Fund also attests.<sup>189</sup>  
2 Further, the Victory Fund has provided a sworn statement attesting that it did not transfer any  
3 contributions to the Biden Committee that were made after Election Day 2020.<sup>190</sup> This Office is  
4 aware of no information that contradicts these assertions.

5 Additionally, as noted by Respondents, the size of the post-election receipts reported by  
6 the Victory Fund's joint fundraising operation is consistent with, and in fact smaller than, those  
7 in prior successful presidential campaigns.<sup>191</sup> Between the 2016 general election and the end of  
8 the 2018 election cycle, former President Donald J. Trump's joint fundraising committee, Trump  
9 Victory, reported nearly \$31.26 million in individual contributions,<sup>192</sup> though, as noted above,  
10 Trump had declared his candidacy for 2020 on the first day of his term in office. In the prior  
11 election cycle, between the 2012 general election and the end of the 2014 election cycle, former  
12 President Barack Obama's joint fundraising committee, Obama Victory Fund 2012, reported

1 \$2,890,741.23 in individual contributions.<sup>193</sup> Both figures exceed the \$2,414,952.90 in  
2 contributions reported by the Victory Fund.

3 Transfers from the Victory Fund to the Biden Committee are, however, larger than those  
4 reported by prior campaigns. Between the 2016 general election and the end of the 2018 election  
5 cycle, Trump Victory transferred \$6,804,830.24 to Trump's authorized campaign committee.<sup>194</sup>  
6 In the prior election cycle, between the 2012 general election and the end of the 2014 election  
7 cycle, Obama Victory Fund 2012 transferred \$9,024,726.22 to Obama for America.<sup>195</sup> These  
8 sums are significantly lower than the \$20,221,129.23 the Biden Committee has received from the  
9 Victory Fund.<sup>196</sup> Nonetheless, the disparity in the value of transfers from joint fundraising  
10 committees to the candidate's authorized committee is not, itself, evidence that the Victory Fund  
11 is receiving or transferring to the Biden Committee contributions other than those made for and  
12 prior to the 2020 general election. Accordingly, Biden and those authorized to fundraise on his  
13 behalf do not appear at this time to have raised \$5,000 or more in support of his 2024 candidacy  
14 for reelection prior to his formal campaign announcement.

15 The Biden Victory Fund, as a joint fundraising enterprise partially benefitting the Biden  
16 Committee, was authorized to accept contributions and make expenditures for Biden during the

1 2020 election cycle,<sup>197</sup> but does not appear to have been so authorized in the period between  
 2 Election Day 2020 and Biden's formal campaign announcement on April 25, 2023.  
 3 Accordingly, the contributions it received and expenditures it made after Election Day 2020 and  
 4 before Biden's campaign announcement do not appear to satisfy the statutory threshold for  
 5 triggering Biden's candidacy.

6 \* \* \*

7 In sum, there is insufficient information to determine whether Biden violated 52 U.S.C.  
 8 § 30102(e)(1) and 11 C.F.R. § 101.1(a) by failing to file a Statement of Candidacy with the  
 9 Commission and designating an authorized committee within 15 days of becoming a candidate.  
 10 However, we recommend that the Commission take no action at this time as to this allegation  
 11 rather than dismiss in light of our recommendation that the Commission find reason to believe  
 12 that the Biden Committee violated the reporting provision of the Act and authorize compulsory  
 13 process, as set forth below in Part III.B, *infra*. Should we discover any relevant information  
 14 regarding Biden's pre-candidacy activities, we will make the appropriate recommendation.<sup>198</sup>

1           **B.       The Commission Should Find Reason to Believe That the Biden Committee**  
2                   **Failed to Accurately Report the Purpose of the Disbursements Made to**  
3                   **Upland Software**

4           The Act and Commission regulations require political committees to report the name and  
5 address of each person to whom they make expenditures or other disbursements aggregating  
6 more than \$200 per calendar year, or per election cycle for authorized committees, as well as the  
7 date, amount, and purpose of such payments.<sup>199</sup> Commission regulations define “purpose” as a  
8 “brief statement or description of why the disbursement was made.”<sup>200</sup> “The ‘purpose of  
9 disbursement’ entry, when considered along with the identity of the disbursement recipient, must  
10 be sufficiently specific to make the purpose of the disbursement clear.”<sup>201</sup> The Commission has  
11 determined that the description of the purpose should be sufficient to allow “a person not  
12 associated with the committee [to] easily discern why the disbursement was made when reading  
13 the name of the recipient and the purpose.”<sup>202</sup> Examples of sufficient statements of purpose  
14 include, but are not limited to, dinner expenses, media, salary, polling, travel, party fees, phone  
15 banks, travel expenses, travel expense reimbursement, and catering costs.<sup>203</sup> The Commission’s  
16 website also states that “software” can be an adequate statement of the purpose of a  
17 disbursement.<sup>204</sup>

1           As discussed above, the Biden Committee asserts that its disbursements to Upland  
2 Software Inc. reported as for “software” were to “maintain ownership of [the Biden  
3 Committee’s] SMS short code phone number, used for communications with [the Biden  
4 Committee].”<sup>205</sup> Even if each of the disbursements were for the purpose of maintaining an SMS  
5 short code and communicating with the committee, the reported purpose of “software” does not  
6 “make the purpose of the disbursement clear” even when read in connection with the recipient of  
7 the disbursement.<sup>206</sup> Though “software” can be an adequate description of a disbursement’s  
8 purpose, it does not appear to be so in the context here.<sup>207</sup> In addition, and as discussed above,  
9 the \$5,083,361.49 disbursed to Upland Software is far larger than apparent general costs for  
10 maintaining a SMS short code, and the wide variation in the amounts disbursed between  
11 November 5, 2020, and September 23, 2021, the date of the Biden Committee’s last reported  
12 disbursement to this vendor, are indicative that these expenditures were inadequately described  
13 as “software.”<sup>208</sup>

14           Accordingly, we recommend the Commission find reason to believe the Biden  
15 Committee violated 52 U.S.C. § 30104(b)(5)(A) and 11 C.F.R. § 104.3(b)(4)(i) by failing to  
16 properly disclose the purpose of its disbursements to Upland Software Inc.

1           **C.     The Commission Should Find No Reason to Believe That the Biden**  
2                   **Committee and the Victory Fund Failed to Amend Their Statements of**  
3                   **Organization**

4           The Act requires all political committees to file a Statement of Organization with the  
5 Commission no later than 10 days after they are designated or established.<sup>209</sup> The Statement of  
6 Organization must include the name, address, and type of committee; the name, address,  
7 relationship, and type of any connected organization or committee; the name and address of the  
8 committee's custodian of books and accounts and the committee's treasurer; a listing of all  
9 depositories used by the committee; and, if an authorized committee, the name, address, office  
10 sought, and party affiliation of the authorizing candidate.<sup>210</sup> Changes or corrections to the  
11 information contained in a Statement of Organization must be reported no later than 10 days  
12 after the date of the change.<sup>211</sup>

13           With respect to the allegation in the MUR 7931 Complaint that the Biden Committee and  
14 the Victory Fund have failed to amend their Statements of Organization to reflect Biden's 2024  
15 candidacy,<sup>212</sup> the facts as presented in the MUR 7931 Complaint and supported by the available  
16 information do not indicate any violation of the Act in this regard. As Respondents note, neither  
17 the Act nor Commission regulations require committees to designate the election cycle in which  
18 an affiliated or authorizing candidate is running, instead requiring only the "name, address, office

1 sought, and party affiliation” of that individual.<sup>213</sup> Indeed, the form on which Statements of  
2 Organization are submitted has no line on which this information could be provided.<sup>214</sup>

3 Accordingly, the Commission should find no reason to believe that the Biden Committee  
4 and the Victory Fund violated 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to  
5 amend their Statements of Organization reflecting Biden’s 2024 candidacy.

6 **D. The Commission Should Find Reason to Believe That the Victory Fund**  
7 **Failed to Report a Debt**

8 The Act requires political committees to file reports accurately disclosing their receipts,  
9 disbursements, and debts.<sup>215</sup> In addition, political committees must accurately itemize  
10 contributions and disbursements for each election cycle and must also indicate the amount and  
11 nature of outstanding debts and obligations until those debts are extinguished.<sup>216</sup> Under  
12 Commission regulations, a debt or obligation of \$500 or less must be reported as of the time that  
13 payment is made or within sixty days of the date on which the political committee incurs the  
14 debt, whichever comes first, and a debt exceeding \$500 must be disclosed in the report that  
15 covers the date on which the debt was incurred.<sup>217</sup> If the exact amount of a debt or obligation is  
16 not known, the report shall state that the amount reported is an estimate.<sup>218</sup> Once the exact  
17 amount is determined, a political committee must either: (1) amend the report(s) containing the

1 estimate; or (2) indicate the correct amount on the report for the reporting period in which such  
2 amount is determined.<sup>219</sup>

3 The MUR 7931 Complaint questions whether the Victory Fund's \$100,000 disbursement  
4 to Vox Media LLC on March 1, 2021, for "online fundraising" relates to the 2020 presidential  
5 election, noting that such disbursements are normally made to maintain the committee's  
6 infrastructure and operations for ongoing and future campaign activity.<sup>220</sup> The Victory Fund  
7 states that this disbursement relates to "online fundraising ads [the Victory Fund] ran through  
8 Vox Media, LLC . . . in August 2020."<sup>221</sup> It goes on to state that its received the invoice for this  
9 expense in 2021, and "[a]s such, the payment was made and reported in 2021."<sup>222</sup>

10 Based on the Victory Fund's representations that the March 2021 payment to Vox  
11 Media LLC was for services rendered in August 2020, the Victory Fund appears to have incurred  
12 a debt or obligation to the vendor of greater than \$500 that was outstanding for over sixty days.  
13 Thus, as required by Commission regulations, the Victory Fund should have reported its  
14 \$100,000 debt to Vox Media LLC in its 2020 October Quarterly Report, and continuously  
15 thereafter until paid, but it failed to do so.<sup>223</sup> Accordingly, we recommend that the Commission  
16 find reason to believe that the Victory Fund failed to report a debt in violation of 52 U.S.C. §  
17 30104(b)(8) and 11 C.F.R. § 104.11(b).

**V. INVESTIGATION**

Simultaneous with the conciliation with the Victory Fund, we plan to seek information to investigate the Biden Committee's disbursements to Upland Software Inc. since the 2020 election to determine the purpose for which those disbursements were made. We will request documents and information regarding the Biden Committee's contracts and service agreements with Upland Software Inc. as well as the services it provided in the period following the 2020 general election. We also request that the Commission authorize the use of compulsory process, including the issuance of appropriate interrogatories, document subpoenas, and deposition subpoenas, as necessary.

13                  § 102.2(a)(2) by failing to amend their Statements of Organization;
- 14          4.     Find reason to believe that Biden Victory Fund and Monica Guardiola in her  
15                  official capacity as treasurer violated 52 U.S.C. § 30104(b)(8) and 11 C.F.R.  
16                  § 104.11(b) by failing to report a debt of greater than \$500 at the time it was  
17                  incurred;
- 18          5.     Approve the attached Factual and Legal Analyses;
- 19          6.     Authorize pre-probable cause conciliation with Biden Victory Fund and Monica  
20                  Guardiola in her official capacity as treasurer;
- 21          7.     Approve the attached proposed conciliation agreement;
- 22          8.     Authorize the use of compulsory process; and

**FEDERAL ELECTION COMMISSION****FACTUAL AND LEGAL ANALYSIS**

**RESPONDENT:** Biden for President and Keana Spencer  
in her official capacity as treasurer

**MURs** 7931 and 8059

**1. INTRODUCTION**

These matters arise from Complaints alleging that Joseph R. Biden, Jr. became a candidate for President in the 2024 election cycle prior to his April 2023 formal announcement and failed to file a Statement of Candidacy with the Commission within 15 days of becoming a candidate in violation of the Federal Election Campaign Act of 1971, as amended (the “Act”).

The Complaint in MUR 7931 alleges that Biden surpassed the \$5,000 threshold for candidacy via contributions received by his authorized committee, Biden for President and Keana Spencer in her official capacity as treasurer (the “Biden Committee”), and Biden Victory Fund and Monica Guardiola in her official capacity as treasurer (the “Victory Fund”), a joint fundraising committee in which the Biden Committee was a participant, as well as via disbursements made by the Biden Committee and the Victory Fund. The MUR 7931 Complaint further alleges that the Biden Committee violated the Act by failing to make necessary amendments to its Statement of Organization to reflect the 2024 presidential candidacy of Joseph R. Biden, Jr. The Complaint also questions whether disbursements by the Biden Committee to Upland Software Inc. for “software” were properly reported. In addition, the Complainant in MUR 7931 has filed three supplements to its Complaint documenting statements made by Biden and individuals associated with him and his administration in support of the MUR 7931 Complaint’s claim that Biden decided to run for reelection long before his formal declaration of candidacy.

1           The Complaint in MUR 8059 similarly alleges that Biden failed to timely file a Statement  
2 of Candidacy despite consistent statements indicating that he had determined to run for  
3 reelection and that Biden crossed the \$5,000 statutory threshold because the Biden Committee  
4 had spent, at the time of that Complaint, more than \$5 million including for text messaging,  
5 email, and database services.

6           The Respondents deny the allegations, asserting that, at the time the Responses were  
7 submitted, Biden had not yet conclusively determined to run for reelection in 2024, nor had he or  
8 his affiliated committees raised or spent \$5,000 or more in connection with the 2024 presidential  
9 election. Regarding contributions, Respondents state that all contributions received by the Biden  
10 Committee after the 2020 election were solicited and made prior to the election and that all funds  
11 raised by the Victory Fund for the Biden Committee were contributions solicited and made prior  
12 to Election Day. They state that other funds raised by the Victory Fund after Election Day 2020  
13 were not allocated or transferred to the Biden Committee. Regarding disbursements,  
14 Respondents state that all expenditures made by the Biden Committee after November 3, 2020,  
15 including the disbursements to Upland Software Inc., were associated with winding-down  
16 activities or maintenance of records or property, obligations incurred during the 2020 election  
17 cycle, and expenses incurred in connection with fundraising for the Democratic National  
18 Committee (the “DNC”) in the 2022 election cycle, and that the Biden Committee has made no  
19 disbursements to influence the 2024 presidential election. Respondents state that expenditures  
20 made by the Victory Fund were to pay for services received prior to Election Day and for  
21 services to maintain the Victory Fund while it winds down its operations. The Biden Committee  
22 further states that it was not required to include on its Statement of Organization the election  
23 cycles in which Biden was or is a candidate for office.

1           After the filing of the Responses, on April 25, 2023, Biden filed a Statement of  
2           Candidacy with the Commission indicating that he is running for reelection in 2024 and naming  
3           both the Biden Committee and the Victory Fund as authorized committees.

4           As set forth below, the available information indicates that although Biden appears to  
5           have made statements indicating that he had decided to become a candidate as early as March  
6           2021, neither Biden nor the Biden Committee nor the Victory Fund appears to have accepted any  
7           contributions, or made any expenditures, in excess of \$5,000 to satisfy the statutory threshold for  
8           becoming a candidate. Further, the available information does not indicate that the Biden  
9           Committee did not accurately disclose all of its spending. Accordingly, the Commission: (1)  
10          finds no reason to believe that Biden violated 52 U.S.C. § 30102(e)(1) and 11 C.F.R. § 101.1 by  
11          failing to timely file a Statement of Candidacy and designate an authorized committee within 15  
12          days of becoming a candidate; and (2) finds no reason to believe that the Biden Committee  
13          violated 52 U.S.C. § 30104(b)(5)(A) and 11 C.F.R. § 104.3(b)(4)(i) by failing to properly  
14          disclose the purpose of its disbursements to Upland Software Inc. Additionally, the Biden  
15          Committee had no obligation to amend its Statement of Organization to reflect the election cycle  
16          relevant to Biden's candidacy, and the Commission therefore finds no reason to believe that the  
17          Biden Committee violated 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend  
18          its Statement of Organization.

## 2. FACTUAL BACKGROUND

### A. Statements Made by Biden and His Surrogates Regarding a 2024 Presidential Candidacy

Joseph R. Biden, Jr., was elected the 46<sup>th</sup> President of the United States on November 3, 2020.<sup>1</sup> He filed a Statement of Candidacy for the 2024 election on April 25, 2023.<sup>2</sup>

Beginning in early 2021, Biden and his surrogates made a number of public statements about whether Biden had made a decision to run for President in 2024, as referenced in the Complaints. As early as March 25, 2021, when asked whether he had “decided whether [he was] going to run for reelection in 2024,” Biden responded that “the answer is ‘yes.’ My plan is to run for reelection. That’s my expectation.”<sup>3</sup> Later that year, in November 2021, then-Press Secretary Jen Psaki was asked about “reports that President Biden was telling allies that he is going to run for reelection in 2024” and whether she could confirm whether he is “going to run in 2024,” to which Psaki responded that “[h]e is, that’s his intention.”<sup>4</sup> Two months later, on January 19, 2022, when asked whether Vice President Kamala Harris would be his Vice President on the 2024 ticket and whether he thought she was doing a good job on voting rights,

1 Biden responded “[y]es and yes,” indicating that he had determined to run in 2024 and again  
2 would select Harris as his running mate.<sup>5</sup>

3 Subsequent press reports have reiterated that Biden had made up his mind regarding the  
4 2024 election: *Intelligencer* reported on May 24, 2022, that “in [Biden’s] mind there’s no  
5 question he’s running. . . . ‘Yes!’ he told an interviewer . . . , sighing a little performatively at  
6 having to keep repeating it.”<sup>6</sup> The article went on to state that:

7 Every one of the would-be candidates has consistently maintained that their own  
8 presidential prospects are moot because Biden is running with their full support.  
9 As far as Biden’s camp is concerned, there isn’t any ambiguity about 2024 at all.  
10 He has said in private that he sees himself as the only thing standing between the  
11 country and [the reelection of Donald Trump] and has instructed his aides to  
12 redouble their planning for a rematch. “People ask me with some regularity,  
13 ‘When is Biden going to come out and say what he’s going to do?’” an  
14 exasperated longtime Biden adviser told me recently. “And I say, ‘Well, he  
15 has!’”<sup>7</sup>

16 Biden was also later reported as being relieved that Senator Bernard Sanders would not challenge  
17 him in 2024, and the same press article states that aides argue that Biden is not just intending to  
18 run but also “laying the groundwork by building resources at the [DNC], restocking his operation

1 in battleground states[,] and looking to use his influence to shape the nomination process in his  
2 favor.”<sup>8</sup>

3 In addition to press accounts, individuals associated with Biden’s campaign and the  
4 White House have repeatedly stated that he will run for reelection. On June 13, 2022, Press  
5 Secretary Karine Jean-Pierre stated at a Press Briefing, “Yes, he’s running for reelection. I’m – I  
6 can’t say more than that.”<sup>9</sup> The same day, Jean-Pierre tweeted, “To be clear, as the President has  
7 said repeatedly, he plans to run in 2024.”<sup>10</sup> Four days later, *The Washington Post* reported that a  
8 dozen unnamed “Democrats close to the White House” had stated that, “[i]n public and private,  
9 Biden himself has emphasized that he is running, effectively shutting down any discussion of the  
10 topic between the president and his close advisers.”<sup>11</sup>

11 Twice in late June 2022, Vice President Kamala Harris confirmed her understanding of  
12 Biden’s intention to run, stating first that “Joe Biden is running for reelection and I will be his  
13 ticket-mate. Full stop.”<sup>12</sup> Two days later, she said that “[t]he president intends to run and if he

1 does, I will be his ticket mate. We will run together.”<sup>13</sup> Regarding this remark, *The Los Angeles*  
2 *Times* reported that an unnamed “prominent Democrat who is close to the White House” said  
3 that Harris made the clarifying statement to “avoid using ‘trigger words’ that would set off  
4 requirements for Biden to establish a formal campaign with the Federal Election Commission  
5 and begin fundraising.”<sup>14</sup>

6 In July 2022, *CNN* reported that Biden had “insisted privately to donors and others [that  
7 he is] their strongest candidate to beat Donald Trump – or another GOP candidate – in 2024.”<sup>15</sup>  
8 It further reported that four unidentified aides stated that there are “muted worries . . . going  
9 around the West Wing . . . that someone may yet emerge ahead of the President’s planned spring  
10 2023 formal reelection campaign launch. Biden advisers expect to stick to that no matter what  
11 happens, including if Trump decides to jump in early.”<sup>16</sup> Later in July 2022, Press Secretary  
12 Jean-Pierre stated, “I’m going to be very clear; I’m going to say this once – and the President has  
13 been very clear about this: He intends to run in 2024. And he is going to – until then, he is  
14 going to do the business of the American people as he has been doing for the past 18 months.”<sup>17</sup>  
15 The next day, she twice reiterated during a press briefing that “[t]he President intends to run in

1 2024,”<sup>18</sup> and on August 1, 2022, she stated twice more that the President “intends to run,” noting  
 2 that he had “said that multiple times.”<sup>19</sup> She was reported as stating so again on *This Week with*  
 3 *George Stephanopoulos* on August 14, 2022.<sup>20</sup>

4 In August 2022, Secretary of Transportation Pete Buttigieg stated while appearing on  
 5 *CNBC* that he was “looking forward to supporting the president’s reelection. That is as much as  
 6 I can say about these things while I’m here on an official capacity.”<sup>21</sup> Less than a week later,  
 7 *Bloomberg* reported that former White House aide Cedric Richmond had said that “[i]t is clear-  
 8 cut that [Biden is] our best candidate. . . . If he says he’s planning on running, he’s running,”<sup>22</sup>  
 9 and that longtime aide Anita Dunn stated, “The president has said he’s planning on running  
 10 again. People should take him at his word.”<sup>23</sup> *Bloomberg* further reported that unidentified

1 aides were “worried that [Biden] publicly declaring [his 2024 candidacy] before the [2022]  
2 midterms [w]ould trigger legal restrictions on fundraising.”<sup>24</sup> In September 2022, Richmond  
3 told a member of the press that Biden is “running and we’re building an infrastructure for him to  
4 run and win. Right now, it’s all an early investment in 2024 while we’re helping 2022.”<sup>25</sup> In  
5 late September 2022, Jean-Pierre again stated that Biden “intends to run. I don’t have any more  
6 announcements on that.”<sup>26</sup>

7         Though Biden claimed as late as February 2023 that he was “just not ready to make” the  
8 decision of whether to run for reelection in 2024,<sup>27</sup> having stated the prior September that he  
9 would “make a judgment on what to do . . . after [the 2022] election cycle here going into  
10 [2023],”<sup>28</sup> he also made clear that it was his “intention to run again” and that part of his concern  
11 about formally deciding to run was that, from the moment he did so, “a whole series of  
12 regulations kick[ed] in and [he has] to be – [he] treat[s] [him]self as a candidate from that

1 moment on.”<sup>29</sup> In October 2022, *NBC* reported that Reverend Al Sharpton had told his staff at  
2 the National Action Network that Biden had told him, “I’m going to do it again. I’m going,”  
3 concerning running for reelection.<sup>30</sup> Further, in November 2022, when asked what he would say  
4 to the “[t]wo thirds of Americans in exit polls [who] say that they don’t think [Biden] should run  
5 for reelection,” Biden responded, “Watch me.”<sup>31</sup> And in December 2022, *The New York Times*  
6 reported that Biden joined a toast at a state dinner with French President Emmanuel Macron to  
7 his 2024 campaign following an exchange in which Biden’s wife, Dr. Jill Biden, reportedly  
8 stated that she was “absolutely” ready for another campaign.<sup>32</sup>

9 Subsequent to the filing of the Complaints and the Responses in these matters, on April  
10 25, 2023, Biden announced that he was running for reelection in 2024,<sup>33</sup> and filed a Statement of  
11 Candidacy with the Commission in which he designated the Biden Committee as his principal  
12 campaign committee and listed the Victory Fund as another authorized committee.<sup>34</sup>

## 1                    **B. The Committees**

### 2                    1. The Biden Committee

3                    The Biden Committee is the authorized campaign committee of 2020 and 2024  
 4                    presidential candidate Joseph R. Biden, Jr.<sup>35</sup> The Biden Committee was authorized by Biden in  
 5                    both the 2020 and 2024 election cycles.<sup>36</sup> None of the Biden Committee's original or amended  
 6                    Statements of Organization indicates the election cycle in which Biden is running for office.<sup>37</sup>

7                    Between November 4, 2020, and March 31, 2023, the Biden Committee reported  
 8                    \$134,048,699.80 in total receipts.<sup>38</sup> Of this amount, the Biden Committee reported receiving

1 \$103,362,129.86 in contributions during the 2020 Post-General reporting period;<sup>39</sup> \$151.80 in  
 2 contributions received during the 2020 Year-End reporting period;<sup>40</sup> and \$280 in the 2021 April  
 3 Quarterly reporting period.<sup>41</sup> The Biden Committee contends that all of the reported post-2020  
 4 election contributions were solicited and made prior to Election Day.<sup>42</sup> The Biden Committee  
 5 reported no additional contributions after the 2021 April Quarterly Report.<sup>43</sup> The remaining  
 6 receipts included \$8,066,596.36 reported as offsets to operating expenditures<sup>44</sup> and

1 \$36,003,662.60 in transfers from other authorized committees, of which \$20,221,129.23 came  
 2 from the Victory Fund, discussed below.<sup>45</sup>

3 From November 4, 2020, through March 31, 2023, the Biden Committee also reported  
 4 making expenditures totaling \$294,730,269.94, all designated as for the 2020 election.<sup>46</sup> This  
 5 includes disbursements of, in the aggregate, \$478,158.91 to NGP Van Inc. for “database  
 6 subscription” and “processing fees,” \$5,083,361.49 to Upland Software Inc. for “software,” and  
 7 \$2,019,395.00 to Action Squared Inc. for “text message/email outreach” and “text message  
 8 outreach.”<sup>47</sup> The individual disbursements summarized above are listed in the Appendix to this  
 9 Analysis, span the time period from November 4, 2020, through March 23, 2023, and total  
 10 \$7,580,915.41.<sup>48</sup>

11 The Biden Committee did not disclose any debt, nor indicate its engagement in debt  
 12 fundraising, in any of its reports following the 2020 general election.<sup>49</sup>

## 1                    2. The Victory Fund

2                    The Victory Fund is a joint fundraising representative for the Biden Committee, the  
 3                    DNC, and multiple state parties' federal committees.<sup>50</sup> In its Response, the Biden Committee  
 4                    asserted that the Victory Fund “is not authorized to, and has not,” raised any funds for Biden in  
 5                    the 2024 presidential election, to which the Victory Fund also attests.<sup>51</sup> Since the 2020 general  
 6                    election, the Victory Fund has reported receiving \$73,740,037.29 in total receipts, of which  
 7                    \$73,172,580.88 was reported as contributions.<sup>52</sup> It states that all contributions received for the  
 8                    Biden Committee were made to it on or before Election Day, and that no contributions received

- 1 after Election Day have been transferred to the Biden Committee.<sup>53</sup> It has also reported spending  
 2 \$78,027,083.84,<sup>54</sup> including \$100,000 to Vox Media LLC on March 1, 2021, for “online  
 3 fundraising.”<sup>55</sup> In addition, the Victory Fund transferred \$20,221,129.23 to the Biden  
 4 Committee as shown below:

 2 In its 2020 Year-End Report, the Victory Fund disclosed debts of \$3,090.00 to Mal Warwick &  
 3 Associates, Inc. for “Direct Mail,” but provided no indication that it had engaged in debt-  
 4 settlement fundraising.<sup>63</sup>

### 5           **C.       The Complaints and Responses**

6           The Complaints allege that Biden became a candidate for President in the 2024 election  
 7 cycle by both making a private determination to run and by raising and spending greater than  
 8 \$5,000 in support of his candidacy via the Biden Committee and the Victory Fund<sup>64</sup> beginning  
 9 shortly after his election in November 2020, and that he accordingly failed to timely file a  
 10 Statement of Candidacy and designate a principal campaign committee.<sup>65</sup> The MUR 7931  
 11 Complaint questions how certain disbursements made through 2021 can be designated for the  
 12 2020 election cycle and alleges that the Biden Committee either incorrectly reported the election  
 13 cycle for its expenditures or failed to report any debts or outstanding liabilities from the 2020

1 general election.<sup>66</sup> Finally, the MUR 7931 Complaint alleges that the Biden Committee has  
2 failed to amend its Statement of Organization to reflect Biden’s 2024 candidacy.<sup>67</sup>

3         The Responses and three attached sworn declarations deny that Biden had, at the time of  
4 their submission, become a candidate for the 2024 election cycle, stating that Biden had neither  
5 made a decision to run nor raised or spent \$5,000 or more in support of any 2024 campaign.<sup>68</sup>  
6 Regarding first whether Biden had determined to run, Biden and the Biden Committee state that  
7 Biden had “a general intent to run for re-election, [b]ut he has not decided for certain that he will  
8 do so,”<sup>69</sup> and that he “has repeatedly stated that he will make a final decision as to whether to run  
9 for reelection after the [2022] mid-term elections.”<sup>70</sup>

10         Regarding whether Biden or entities he has authorized to fundraise on his behalf have  
11 *raised* greater than the \$5,000 threshold for candidacy under the Act, Biden and the Biden  
12 Committee aver that the Biden Committee ceased soliciting contributions on Election Day 2020,  
13 and that all contributions received thereafter were “solicited and made on or before Election Day  
14 or else refunded.”<sup>71</sup> They further state, as does the Victory Fund, that “all funds [the Victory  
15 Fund] transferred to [the Biden Committee] were comprised solely of contributions made to [the

1 Victory Fund] on or before Election Day.”<sup>72</sup> With respect to funds received by the Victory Fund  
2 after Election Day as a result of pre-Election Day solicitations, the Victory Fund states that  
3 “none of the contributions made after Election Day were allocated or transferred to” the Biden  
4 Committee,<sup>73</sup> and the Biden Committee notes that funds raised after Election Day by the Victory  
5 Fund “were allocated to the accounts of other [joint fundraising] participants or refunded.”<sup>74</sup>  
6 Respondents attest that, as of the dates of the declarations and prior to Biden’s formal  
7 announcement, the Victory Fund “has not received consent from President Biden or [the Biden  
8 Campaign] to solicit or accept contributions on behalf of either for the 2024 election cycle.”<sup>75</sup>

9       Regarding whether Biden or his committees have *spent* \$5,000 or more in support of his  
10 2024 candidacy, both the Biden Committee and the Victory Fund deny that they had spent any  
11 funds to “influence the 2024 presidential election” at the time of the Responses.<sup>76</sup> With respect  
12 to the \$478,158.91 that the Biden Committee disbursed to NGP Van Inc. for a “database  
13 subscription,” the Biden Committee states, relying on a sworn declaration from its campaign  
14 consultant, that these payments were for an “accounting and compliance database subscription  
15 necessary to maintain records to comply with the Act” and “necessary for operations during the

1 wind down and the Commission’s reporting requirements, and costs necessary to protect [the  
 2 Biden Committee’s] intellectual property.”<sup>77</sup> Concerning the \$5,083,361.49 disbursed to Upland  
 3 Software Inc. for “software,” the Biden Committee states that the payments were “related to [the  
 4 Biden Committee’s] ownership of a[n] SMS short code.”<sup>78</sup> With respect to the \$2,019,395 the  
 5 Biden Committee has disbursed to Action Squared Inc. for “text message/email outreach” and  
 6 “text message outreach,”<sup>79</sup> the Biden Committee states that these payments:  
 7 relate to ongoing communications by the President to his supporters who have  
 8 opted-in to receive messages, encouraging them to make contributions to the  
 9 [DNC] . . . in 2021 and 2022. . . . The messages make no reference to the 2024  
 10 election or the potential of President Biden running for re-election.<sup>80</sup>  
 11 With respect to the \$100,000 disbursed by the Victory Fund to Vox Media LLC for online  
 12 fundraising, Respondents state that this “expenditure was for an advertisement purchased in  
 13 August 2020 but for which [the Victory Fund] received an invoice in 2021.”<sup>81</sup>

1 The Biden Committee further denies that it failed to amend its Statement of Organization  
2 with the Commission, “because [a Statement of Organization] does not require the campaign  
3 committee to identify the election for which the candidate seeks office.”<sup>82</sup>

### 4 **3. LEGAL ANALYSIS**

#### 5 **A. The Commission Finds No Reason to Believe that Joseph R. Biden Failed to** 6 **Timely File a Statement of Candidacy and Designate an Authorized** 7 **Committee**

8 As discussed below, the available information strongly supports the Complaints’  
9 allegations that Biden made a private decision to run for reelection prior to the time of his formal  
10 announcement in 2023. At the same time, the available information does not indicate that  
11 Respondents engaged in any spending in furtherance of that potential candidacy. Finally, the  
12 available information supports Respondents’ claim that they did not receive contributions for  
13 Biden’s reelection, at least until the April 2023 formal announcement.

#### 14 1. The Available Information Indicates that Biden Decided to Run for Reelection 15 in 2024 as Early as March 2021

16 Under the Act and Commission regulations, an individual becomes a candidate when the  
17 person (1) decides to run for office<sup>83</sup> and (2) receives contributions or makes expenditures  
18 exceeding \$5,000, either directly or through an entity the candidate has consented to receive  
19 contributions or make expenditures on their behalf.<sup>84</sup>

1 Commission regulations set forth a non-exhaustive set of “[e]xamples of activities that  
2 indicate that an individual has decided to become a candidate.”<sup>85</sup> Such indicia include: (1) using  
3 “general public political advertising to publicize his or her intention to campaign for federal  
4 office”;<sup>86</sup> (2) raising “funds in excess of what could reasonably be expected to be used for  
5 exploratory activities or undertak[ing] activity designed to amass campaign funds that would be  
6 spent after he or she becomes a candidate”;<sup>87</sup> (3) making or authorizing “written or oral  
7 statements that refer to the individual as a candidate for a particular office”;<sup>88</sup> (4) conducting  
8 “activities in close proximity to the election or over a protracted period of time”;<sup>89</sup> and (5) taking  
9 “action to qualify for the ballot under state law.”<sup>90</sup>

10 In previous matters, the Commission has found reason to believe that an individual had  
11 become a candidate and failed to timely file a Statement of Candidacy when public statements  
12 and other indicia showed that the respondent had determined to run for office. In MUR 6449  
13 (Jon Bruning, *et al*), the Commission found that an individual who had publicly said “I want to  
14 run. I’m ready to run” and made a solicitation to “help [him] defeat” his primary opponent had  
15 made the decision to campaign for office and become a candidate under the Act.<sup>91</sup> In MUR 6735  
16 (Joseph A. Sestak, *et al.*), the Commission found that an individual who had solicited funds via  
17 emails asking for support in his attempt to “seek the U.S. Senate” and to “help [him] serve you,  
18 again” indicated that he had determined to run and was not testing the waters for a potential

1 campaign.<sup>92</sup> And in MUR 5908 (Duncan Hunter, *et al.*), the Commission found that an  
2 individual who stated, *inter alia*, “while I’ve announced that I am preparing to run for president,  
3 I have not made a formal announcement of my candidacy” had, in fact, become a candidate.<sup>93</sup>

4 Further, in Advisory Opinion 2015-09, the Commission advised that an individual  
5 becomes a candidate when the individual passes the \$5,000 threshold and “when he or she makes  
6 a private determination that he or she will run for federal office.”<sup>94</sup> When determining whether  
7 an individual “has made a decision to run for federal office, [the Commission] assesses an  
8 individual’s objectively deliberate actions to discern whether and when an individual decided to  
9 become a candidate.”<sup>95</sup> The Commission has also advised that “[a] non-conditional statement by  
10 an individual (directly or indirectly) that he or she ‘will’ announce his or her candidacy on a  
11 given date unambiguously indicates that the individual has decided to become a candidate.”<sup>96</sup>

12 Here, Biden’s activities indicate that he had decided to run for reelection in 2024 as early  
13 as March 25, 2021. As set forth in the Commission’s non-exhaustive list of activities that  
14 indicate when an individual has decided to become a candidate, one such indication is that the  
15 individual has made or authorized statements that refer to the individual as a candidate for a  
16 particular office.<sup>97</sup> Biden and his surrogates’ public statements have consistently indicated that  
17 he had decided to run for reelection in 2024 well prior to his April 2023 formal announcement

3            Though the Responses state that Biden had not, at the time of their submission,  
 4 “decided for certain” to run for reelection in 2024,<sup>121</sup> Biden’s and his surrogates’ public  
 5 statements as early as March 2021 indicate that he intended to do so. In MUR 5908, the  
 6 Commission found that a statement that the individual had “announced that I am preparing to run  
 7 for president, [but] I have not made a formal announcement of my candidacy” was sufficient

1 basis on which to determine the individual had decided to run for office and become a  
2 candidate;<sup>122</sup> accordingly, Biden’s statements that he intended to run for reelection likewise  
3 present a sufficient basis for the Commission to conclude that Biden had decided to become a  
4 candidate. In addition to the statements already discussed, press reports relying on unnamed  
5 sources close to the White House indicate that Biden planned a “spring 2023 formal reelection  
6 campaign launch,”<sup>123</sup> precisely in line with the timing of Biden’s actual formal announcement on  
7 April 25, 2023.<sup>124</sup>

8 Respondents principally appear to contend that the numerous statements do not indicate  
9 that Biden has made a private determination to run. However, while Biden’s statements that he  
10 “intends” to run may be arguably less direct than a statement indicating that he “will” run, Biden  
11 said that he had made a decision that he “*plan[s]* to run for reelection,”<sup>125</sup> with both the Press  
12 Secretary stating, “Yes, he’s running for reelection. I’m – I can’t say more than that,”<sup>126</sup> and  
13 Vice President Harris stating, “Joe Biden is running for reelection and I will be his ticket-mate.  
14 Full stop.”<sup>127</sup> Though Biden and his surrogates subsequently stated that he had not made a  
15 formal decision regarding his 2024 candidacy, the Commission has previously advised that,  
16 where an individual makes a statement evincing that they have decided to become a candidate,

1 “the statement may trigger candidacy regardless of subsequent retraction attempts.”<sup>128</sup> Further,  
2 in MURs 6955, 6983 (John R. Kasich, *et al.*), the Commission found that a “‘non-conditional  
3 statement’ by an individual . . . that he or she ‘*will* announce his or her candidacy on a given date  
4 unambiguously indicates that the individual has decided to become a candidate.’”<sup>129</sup>

5 The Responses do not dispute the accuracy of any of the statements attributed to Biden or  
6 his surrogates in the Complaints, and instead assert that one of the Complaints “‘focuses on  
7 anonymously sourced news stories, musings by political insiders, and half-quotes from White  
8 House staff’”<sup>130</sup> and that the statements do not have “‘any bearing on the question at issue’”  
9 regarding whether Biden has raised or spent \$5,000 or more for the 2024 presidential election.<sup>131</sup>  
10 Here, as in the matters discussed above in which the Commission evaluated candidate statements  
11 using objective criteria, Biden’s and his surrogate’s public statements have made clear that he  
12 determined to run for reelection in 2024 as early as March 25, 2021. These statements alone  
13 would be sufficient to indicate that Biden has “‘made a decision to become a candidate.’”<sup>132</sup>

14 Further, one of the factors the Commission has identified as indicia that a candidate has  
15 determined to run for office is whether the individual is “‘conducting activities in close proximity  
16 to the election or over a protracted period of time.’”<sup>133</sup> As discussed above, at the time of the  
17 First General Counsel’s Report, Biden had made public statements indicating that he had

1 determined to run for president over a period spanning approximately two years. Though the  
2 Commission has not elaborated on what constitutes a “protracted period of time,” and noted in  
3 the testing-the-waters context that “the length of time that an individual spends deliberating  
4 whether to become a candidate is one factor and does not, in and of itself, determine whether the  
5 individual has become a candidate,”<sup>134</sup> two years, or half a presidential term, appears to fall  
6 within the scope of a “protracted period of time.”<sup>135</sup>

7           2. The Available Information Does Not Indicate That Biden or the Biden  
8           Committee Made More Than \$5,000 in Expenditures

9           As discussed above, once an individual decides to run for office, the individual becomes  
10 a candidate under the Act when: (a) such individual receives contributions or makes  
11 expenditures in excess of \$5,000; or (b) such individual gives their consent to another person to  
12 receive contributions or make expenditures on behalf of such individual and if such person has  
13 received contributions or has made such expenditures in excess of \$5,000.<sup>136</sup> Once the \$5,000  
14 threshold has been met, the candidate has 15 days to designate a principal campaign committee  
15 by filing a Statement of Candidacy with the Commission.<sup>137</sup> The principal campaign committee

1 must file a Statement of Organization within ten days of its designation,<sup>138</sup> and it must file  
2 disclosure reports with the Commission.<sup>139</sup>

3 The Commission has established “testing-the-waters” regulations excepting from the  
4 definitions of “contribution” and “expenditure” funds received and payments made solely to  
5 determine whether an individual should become a candidate, thereby permitting an individual to  
6 test the feasibility of a campaign for federal office without becoming a candidate under the  
7 Act.<sup>140</sup> These testing-the-waters regulations seek to draw a distinction between activities  
8 directed to evaluating the feasibility of one’s candidacy and conduct signifying that a decision to  
9 become a candidate has been made.<sup>141</sup> The testing-the-waters exceptions are not available to an  
10 individual who has decided to become a candidate, even if the individual has made only “a  
11 private determination that he or she will run for federal office.”<sup>142</sup>

12 The Commission’s regulations further provide that funds in a campaign account may be  
13 used for the “ordinary and necessary expenses incurred in connection with the recipient’s duties  
14 as a holder of Federal office,” such as “[t]he costs of winding down the office of a former  
15 Federal officeholder for a period of [six] months after he or she leaves office.”<sup>143</sup> The  
16 Commission has advised that winding-down costs include “the ‘necessary administrative costs’  
17 of terminating a campaign or congressional office, such as office space rental, staff salaries and

1 office supplies.”<sup>144</sup> Although Commission regulations contemplate a time limit of six months for  
2 when a campaign for a former officeholder may use funds to pay for winding down costs,<sup>145</sup> the  
3 Commission has explained that this provision is a safe harbor that “does not preclude a former  
4 officeholder who can demonstrate that he or she has incurred ordinary and necessary winding  
5 down expenses more than six months after leaving office from using campaign funds to pay  
6 those expenses.”<sup>146</sup>

7 As discussed above, Biden appears to have made a decision to run for reelection in 2024  
8 as early as March 2021, but he does not become a candidate under the Act unless he, or another  
9 person to whom he has given consent to do so, raises or spends in excess of \$5,000 in support of  
10 a 2024 candidacy.<sup>147</sup>

11 Here, the available information does not indicate that Biden passed the \$5,000 threshold  
12 triggering status as a candidate via funds spent by the Biden Committee in support of his 2024  
13 candidacy prior to his formal campaign announcement.<sup>148</sup>

1 As discussed in Part II.B, above, the Biden Committee disbursed nearly \$295 million  
2 between November 4, 2020, and March 31, 2023.<sup>149</sup> Given the numerous statements made by  
3 Biden and his surrogates indicating that Biden had decided to run as a presidential candidate in  
4 2024 or intended to do so, the Complaints question the substantial spending by the Biden  
5 Committee and whether it has made more than \$5,000 in expenditures to support his 2024  
6 candidacy, especially as more than two years have passed since the 2020 general election.

7 The Biden Committee denies that it has spent any funds to “influence the 2024  
8 presidential election.”<sup>150</sup> First, with respect to the Biden Committee’s \$478,158.91 in  
9 disbursements to NGP Van Inc. for “database subscription,” the Biden Committee avers that  
10 these disbursements were for “a compliance and accounting database necessary for operations  
11 during the wind down and the Commission’s reporting requirements.”<sup>151</sup> There is no available  
12 information to contradict those assertions.<sup>152</sup> Accordingly, Respondents have credibly rebutted  
13 the Complaints’ allegations that these expenditures were associated with Biden’s 2024  
14 candidacy.

15 With respect to the disbursements to Upland Software Inc. for “software,” the Biden  
16 Committee states in a sworn declaration that these disbursements were to “maintain ownership of

1 [the Biden Committee’s] SMS short code phone number, used for communications with [the  
 2 Biden Committee],”<sup>153</sup> and which the Biden Committee describes as its “intellectual  
 3 property.”<sup>154</sup> Although prior presidential campaign committees do not appear to have identified  
 4 expenditures for similar purposes, this is likely because of the relative newness of the technology  
 5 involved: For example, a search across all disbursements by the authorized committees of  
 6 former presidential candidates Obama, Clinton, Romney, and McCain for disbursements with  
 7 purposes containing any of “short code,” “SMS,” “text number,” “phone number” or “text id”  
 8 revealed no results.<sup>155</sup>

9 As shown in the Appendix to this Factual and Legal Analysis and the figure below, the  
 10 amount and timing of the Biden Committee’s disbursements to Upland Software Inc. varied  
 11 widely over the period between January 13, 2021, the first disbursement following the immediate  
 12 aftermath of the 2020 election, and September 23, 2021, the date of the Biden Committee’s last  
 13 reported disbursement to this vendor, with disbursements ranging from \$2.34 to \$261,449,  
 14 including multiple disbursements occurring on the same day for different amounts, and each

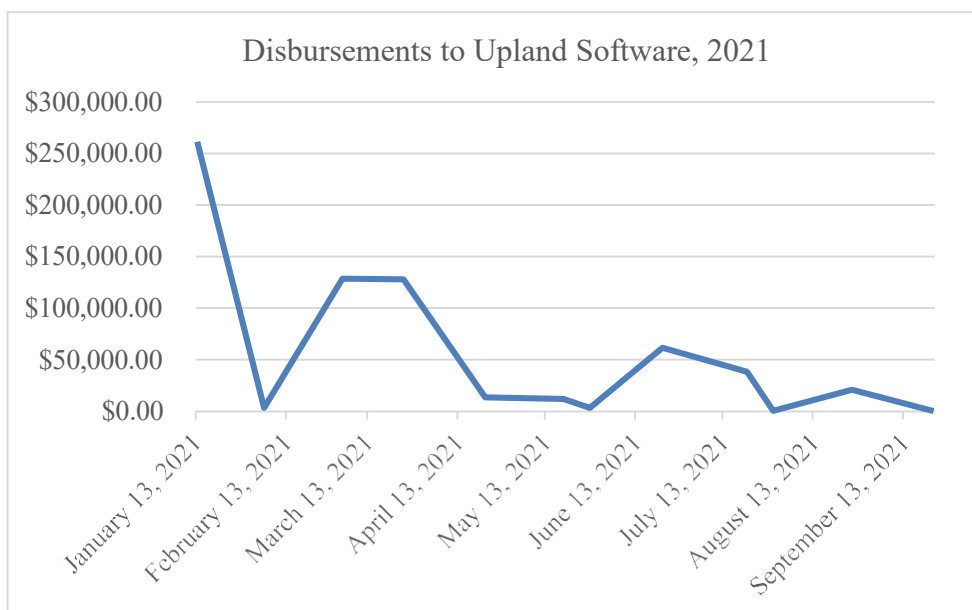

1 disbursement reported as for “software.”<sup>156</sup> Though the data reflects various jumps in spending  
 2 throughout 2021, the amounts disbursed decreased over time, as one might expect with a  
 3 campaign winding down its operations, and ceased on September 23, 2021, less than one year  
 4 following the general election:

 8 Given the context of a sophisticated presidential campaign, the declaration’s statement  
 9 may accurately describe a complex maintenance arrangement that happens to be subject to  
 10 external events.<sup>157</sup> Moreover, given the declaration’s assertion that the SMS short code was

1 “used for communications with [the Biden Committee],”<sup>158</sup> it is reasonable that the Biden  
2 Committee may have viewed it necessary as a communications tool to further appropriate wind-  
3 down activities. Though not directly supported by the declaration, the Biden Committee also  
4 asserts that the expenditures were “to maintain records or property related to the 2020  
5 election.”<sup>159</sup> These explanations are plausible, particularly given that the payments to Upland  
6 Software Inc. ceased after September 2021. It is possible that, consistent with the Complaints’  
7 allegations, the Biden Committee was maintaining the SMS short code as campaign  
8 infrastructure in the event that Biden would run for reelection in 2024, thus making the  
9 expenditures fairly linked to the 2024 presidential election. However, the Complaints do not  
10 provide any specific information that indicate that the payments to Upland Software Inc. were  
11 not for the purposes stated by the Respondents. Indeed, if the Complaints are correct in asserting  
12 that Biden had made up his mind to run for reelection as early as March 2021 and that the  
13 payments to Upland Software Inc. were to maintain campaign infrastructure for a 2024 election  
14 campaign, then it is unclear why those payments would cease nearly three years before the  
15 election.

16 With respect to the Biden Committee’s \$2.02 million in disbursements to Action Squared  
17 Inc. for “text message/email outreach” and “text message outreach,”<sup>160</sup> the Biden Committee  
18 states that the disbursements were for “ongoing communications by the President to his  
19 supporters who have opted-in to receive messages, encouraging them to make contributions to

1 the [DNC] . . . in 2021 and 2022.”<sup>161</sup> However, on its disclosure reports, the Biden Committee  
2 reported each disbursement to Action Squared Inc. as being for the 2020 general election.<sup>162</sup>  
3 Notwithstanding the discrepancy between which election these expenditures were associated  
4 with – 2020, as stated in the reports, versus 2021 and 2022,<sup>163</sup> as stated in the Responses – in  
5 neither event do they appear to be associated with Biden’s 2024 candidacy.

1                   3. The Available Information Does Not Indicate That Biden or the Biden  
 2                   Committee Accepted More than \$5,000 in Contributions

3                   Regarding Biden and the Biden Committee's receipts, since November 4, 2020, the  
 4 Biden Committee has reported receiving \$134,048,699.80,<sup>164</sup> including \$20,221,129.23 received  
 5 as a transfer from the Victory Fund.<sup>165</sup> Of the \$134 million in total receipts, the Biden  
 6 Committee reported receiving \$103,362,129.86 in contributions during the 2020 Post-General  
 7 reporting period,<sup>166</sup> with only \$482 in additional contributions disclosed on subsequent  
 8 Reports.<sup>167</sup> Although the Complaints raise questions as to the amount of contributions accepted  
 9 by the Biden Committee after the 2020 general election, the Respondents credibly rebut the  
 10 allegations that those post-election contributions were attributable to a 2024 Biden candidacy.

11                   The Biden Committee does not appear to have solicited or accepted contributions for  
 12 Biden's reelection campaign prior to Biden's formal campaign announcement. First, the Biden  
 13 Committee states in its MUR 7931 Response that it neither solicited nor accepted contributions  
 14 made after Election Day 2020, and that it had not at the time of the Response accepted any  
 15 contributions for the 2024 election cycle; the sworn statement attached to the MUR 7931  
 16 Response asserts this statement.<sup>168</sup> The Commission is aware of no information that contradicts  
 17 these assertions.

1                   4. The Victory Fund Does Not Appear to Have Accepted Contributions or Made  
 2                   Expenditures in Support of Biden’s 2024 Candidacy

3                   Like the Biden Committee, the Victory Fund denies that it has spent any funds to  
 4 “influence the 2024 presidential election.”<sup>169</sup> Since the 2020 general election, the Victory Fund  
 5 has reported receiving \$2,414,952.90 in contributions.<sup>170</sup> Although the Complaints raise  
 6 questions as to the amount of contributions accepted by the Biden Committee and the Victory  
 7 Fund after the 2020 general election, the Respondents credibly rebut the allegations that those  
 8 post-election contributions were attributable to a 2024 Biden candidacy.<sup>171</sup> The Victory Fund  
 9 also does not appear to have solicited or accepted contributions for Biden’s reelection campaign  
 10 prior to Biden’s formal campaign announcement. As noted above, the Biden Committee avers  
 11 that the Victory Fund “is not authorize to, and has not,” raised any funds for Biden in the 2024

1 presidential election, to which the Victory Fund also attests.<sup>172</sup> Further, the Victory Fund has  
 2 provided a sworn statement attesting that it did not transfer any contributions to the Biden  
 3 Committee that were made after Election Day 2020.<sup>173</sup> The Commission is aware of no  
 4 information that contradicts these assertions. Accordingly, the available information does not  
 5 indicate that Biden and those authorized to fundraise on his behalf have raised \$5,000 or more in  
 6 support of his 2024 candidacy for reelection prior to his formal campaign announcement.

7 **B. The Commission Finds No Reason to Believe That the Biden Committee**  
 8 **Failed to Accurately Report the Purpose of the Disbursements Made to**  
 9 **Upland Software**

10 The Act and Commission regulations require political committees to report the name and  
 11 address of each person to whom they make expenditures or other disbursements aggregating  
 12 more than \$200 per calendar year, or per election cycle for authorized committees, as well as the  
 13 date, amount, and purpose of such payments.<sup>174</sup> Commission regulations define “purpose” as a  
 14 “brief statement or description of why the disbursement was made.”<sup>175</sup> “The ‘purpose of  
 15 disbursement’ entry, when considered along with the identity of the disbursement recipient, must  
 16 be sufficiently specific to make the purpose of the disbursement clear.”<sup>176</sup> The Commission has

1 determined that the description of the purpose should be sufficient to allow “a person not  
2 associated with the committee [to] easily discern why the disbursement was made when reading  
3 the name of the recipient and the purpose.”<sup>177</sup> Examples of sufficient statements of purpose  
4 include, but are not limited to, dinner expenses, media, salary, polling, travel, party fees, phone  
5 banks, travel expenses, travel expense reimbursement, and catering costs.<sup>178</sup> The Commission’s  
6 website also states that “software” can be an adequate statement of the purpose of a  
7 disbursement.<sup>179</sup>

8 As discussed above, the Biden Committee states in a sworn declaration that its  
9 disbursements to Upland Software Inc. were to “maintain ownership of [the Biden Committee’s]  
10 SMS short code phone number, used for communications with [the Biden Committee],”<sup>180</sup> and  
11 which the Biden Committee describes as its “intellectual property.”<sup>181</sup> As shown in the  
12 Appendix to this Analysis and the figure above, the amount and timing of the Biden Committee’s  
13 disbursements to Upland Software Inc. varied widely over the period between January 13, 2021,  
14 the first disbursement following the immediate aftermath of the 2020 election, and September  
15 23, 2021, the date of the Biden Committee’s last reported disbursement to this vendor.  
16 Notwithstanding the variation, the amounts disbursed decreased over time and ceased  
17 approximately 11 months after the 2020 election, as one might expect with a campaign winding  
18 down its operations.<sup>182</sup>

1 As discussed above, there is no information in the Complaints to suggest that these  
2 disbursements were for something other than the software expenses described by the  
3 Respondents. Accordingly, the Commission finds no reason to believe that the Biden Committee  
4 violated 52 U.S.C. § 30104(b)(5)(A) and 11 C.F.R. § 104.3(b)(4)(i) by failing to properly  
5 disclose the purpose of its disbursements to Upland Software Inc..

6 **C. The Commission Finds No Reason to Believe That the Biden Committee**  
7 **Failed to Amend Its Statement of Organization**

8 The Act requires all political committees to file a Statement of Organization with the  
9 Commission no later than 10 days after they are designated or established.<sup>183</sup> The Statement of  
10 Organization must include the name, address, and type of committee; the name, address,  
11 relationship, and type of any connected organization or committee; the name and address of the  
12 committee's custodian of books and accounts and the committee's treasurer; a listing of all  
13 depositories used by the committee; and, if an authorized committee, the name, address, office  
14 sought, and party affiliation of the authorizing candidate.<sup>184</sup> Changes or corrections to the  
15 information contained in a Statement of Organization must be reported no later than 10 days  
16 after the date of the change.<sup>185</sup>

17 With respect to the allegation that the Biden Committee failed to amend its Statement of  
18 Organization to reflect Biden's 2024 candidacy,<sup>186</sup> the facts as presented in the Complaint and  
19 supported by the available information do not indicate any violation of the Act in this regard. As  
20 the Biden Committee notes, neither the Act nor Commission regulations require committees to

1 designate the election cycle in which an affiliated or authorizing candidate is running, instead  
2 requiring only the “name, address, office sought, and party affiliation” of that individual.<sup>187</sup>  
3 Indeed, the form on which Statements of Organization are submitted has no line on which this  
4 information could be provided.<sup>188</sup>

5 Accordingly, the Commission finds no reason to believe that the Biden Committee  
6 violated 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend its Statement of  
7 Organization reflecting Biden’s 2024 candidacy.

**FEDERAL ELECTION COMMISSION****FACTUAL AND LEGAL ANALYSIS**

**RESPONDENT:** Biden Victory Fund and Monica Guardiola  
in her official capacity as treasurer

**MUR 7931**

**I. INTRODUCTION**

This matter arises from a Complaint alleging that Biden Victory Fund and Monica Guardiola in her official capacity as treasurer (the “Committee”), violated the Federal Election Campaign Act of 1971, as amended (the “Act”), by failing to make necessary amendments to its Statement of Organization to reflect the 2024 presidential candidacy of Joseph R. Biden, Jr. The Complaint also questions whether a disbursement by the Committee to Vox Media LLC on March 1, 2021, for “online fundraising” was properly reported.

The Committee denies the allegations, and states that it was not required to include on its Statement of Organization the election cycles in which Biden was or is a candidate for office. The Committee further provides the sworn declaration of its treasurer who asserts that the disbursement to Vox Media LLC was for advertising in August 2020 for which it was not invoiced until 2021.

Because the Committee had no obligation to amend its Statement of Organization to reflect the election cycle relevant to Biden’s candidacy, the Commission finds no reason to believe that the Committee violated 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend its Statement of Organization. Additionally, the Commission exercises its prosecutorial discretion and dismisses the allegation that the Committee failed to report a debt of \$100,000 in August 2020.

## 1 II. FACTUAL BACKGROUND

2 The Committee is a joint fundraising representative for Biden for President, the  
3 authorized campaign committee of 2020 and 2024 presidential candidate Joseph R. Biden, Jr.;  
4 the Democratic National Committee; and multiple state parties' federal committees.<sup>1</sup> The  
5 Committee was authorized by Biden in both the 2020 and 2024 election cycles.<sup>2</sup>

6 On its 2021 April Quarterly Report, the Committee reported a disbursement of \$100,000  
7 to Vox Media LLC for "Online Fundraising" on March 1, 2021.<sup>3</sup> The Complaint questions  
8 whether this expenditure was in connection with the 2020 election cycle, given that it was  
9 reported in 2021, and alleges that the expenditure indicates that Biden triggered candidacy in  
10 2024.<sup>4</sup>

11 The Committee's treasurer attests that the Committee "made a disbursement of \$100,000  
12 to Vox Media, LLC on March 1, 2021 for online fundraising costs related to advertising run in  
13 August 2020. [The Committee] received an invoice for these costs in 2021."<sup>5</sup>

14 The Complaint also alleges that the Committee has failed to amend its Statement of  
15 Organization to reflect Biden's 2024 candidacy.<sup>6</sup> The Committee denies this allegation because:

16 There is nothing in the Act or Commission regulations requiring a  
17 joint fundraising committee to indicate on its Statement of  
18 Organization that it is raising funds in connection with any particular

1 election or to indicate on its Statement of Organization which office  
2 in which election year its participating candidate committees are  
3 seeking. There is simply no place to put this information on the  
4 Commission’s current version of [the Statement of Organization  
5 form].<sup>7</sup>

6 The Committee further asserts that it was “not even required to disclose on its Statement of  
7 Organization that President Biden was running in the 2020 election . . . , much less amend this  
8 information.”<sup>8</sup>

### 9 III. LEGAL ANALYSIS

#### 10 A. The Commission Finds No Reason to Believe That the Committee Failed to 11 Amend Its Statement of Organization

12 The Act requires all political committees to file a Statement of Organization with the  
13 Commission no later than 10 days after they are designated or established.<sup>9</sup> The Statement of  
14 Organization must include the name, address, and type of committee; the name, address,  
15 relationship, and type of any connected organization or committee; the name and address of the  
16 committee’s custodian of books and accounts and the committee’s treasurer; a listing of all  
17 depositories used by the committee; and, if an authorized committee, the name, address, office  
18 sought, and party affiliation of the authorizing candidate.<sup>10</sup> Changes or corrections to the  
19 information contained in a Statement of Organization must be reported no later than 10 days  
20 after the date of the change.<sup>11</sup>

1 With respect to the allegation that the Committee failed to amend its Statement of  
2 Organization to reflect Biden’s 2024 candidacy,<sup>12</sup> the facts as presented in the Complaint and  
3 supported by the available information do not indicate any violation of the Act. As the  
4 Committee notes, neither the Act nor Commission regulations require committees to designate  
5 the election cycle in which an affiliated or authorizing candidate is running, instead requiring  
6 only the “name, address, office sought, and party affiliation” of that individual.<sup>13</sup> Indeed, the  
7 form on which Statements of Organization are submitted has no line on which this information  
8 could be provided.<sup>14</sup>

9 Accordingly, the Commission finds no reason to believe that the Committee violated  
10 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend its Statement of  
11 Organization reflecting Biden’s 2024 candidacy.

12 **B. The Commission Dismisses pursuant to its Prosecutorial Discretion the**  
13 **Allegation That the Committee Failed to Report a Debt**

14 The Act requires political committees to file reports accurately disclosing their receipts,  
15 disbursements, and debts.<sup>15</sup> In addition, political committees must accurately itemize  
16 contributions and disbursements for each election cycle and must also indicate the amount and  
17 nature of outstanding debts and obligations until those debts are extinguished.<sup>16</sup> Under  
18 Commission regulations, a debt or obligation of \$500 or less must be reported as of the time that  
19 payment is made or within sixty days of the date on which the political committee incurs the

1 debt, whichever comes first, and a debt exceeding \$500 must be disclosed in the report that  
2 covers the date on which the debt was incurred.<sup>17</sup> If the exact amount of a debt or obligation is  
3 not known, the report shall state that the amount reported is an estimate.<sup>18</sup> Once the exact  
4 amount is determined, a political committee must either: (1) amend the report(s) containing the  
5 estimate; or (2) indicate the correct amount on the report for the reporting period in which such  
6 amount is determined.<sup>19</sup>

7 The Complaint questions whether the Committee’s \$100,000 disbursement to Vox  
8 Media LLC on March 1, 2021, for “online fundraising” relates to the 2020 presidential election,  
9 noting that such disbursements are normally made to maintain the committee’s infrastructure and  
10 operations for ongoing and future campaign activity.<sup>20</sup> The Committee states that this  
11 disbursement relates to “online fundraising ads [the Committee] ran through Vox Media,  
12 LLC . . . in August 2020.”<sup>21</sup> It goes on to state that it received the invoice for this expense in  
13 2021, and “[a]s such, the payment was made and reported in 2021.”<sup>22</sup>

14 To devote scarce Commission resources to higher priority matters, the Commission  
15 exercises its prosecutorial discretion to dismiss the allegation.<sup>23</sup>
