My name is Cris Ericson, candidate for U.S. Senator 2022 in Vermont and I am submitting this second supplement to my complaint M.U.R. 8065 because I believe that U.S. Congressman Peter Welch, Democrat, and Gerald Malloy, Republican, have been in a continuing conspiracy with other entities against me to exclude me from political candidate debates, for possible wrongful debate exclusion, which might also be unreported in-kind campaign contributions to them.

I was excluded from the October 26, 2022 U.S. Senate candidate debate on WCAX and they did not respond to my email asking for their debate exclusion criteria for excluding me.

I also believe that U.S. Congressman Peter Welch, Democrat and Gerald Malloy, Republican, are in conspiracy with the Democrat Party at the state and federal level and the Republican party at the state and federal level to exclude me, and I believe that based on the fact that they have willingly participated in three debates which excluded me. I also believe that WCAX is in conspiracy with the Democrat and Republican political parties to exclude me.

I believe that the United States of America and our citizens suffer because of minor party and independent candidate debate exclusion which creates a much greater divide in our country than if the political pie was more divided between a greater presence of candidates. Just glaring black and white without the shades of gray creates a starker reality.

I have never won an election. I keep running for political office because voters want me to raise valid issues of importance to them that they don't hear other candidates talking about. There has never been a fair election in Vermont in the twenty years I have been a perennial candidate, every two years from 2002 through 2022. I have been excluded from the majority of debates and forums during that time period.

In 2020 facebook.com "permanently" banned me from their platform in October 2020 before the November 2020 election. I am listed as an "interested party" in Trump v. Meta but the Miami Judge wouldn't let me create a sub-class. I was not a Republican and I was excluded long before former President Trump and the problem at the U.S. Capitol.


