Amended ANSWER

On September 20, 2022, I, Gerald Malloy received a COPY of: Complaint to Office of the General Counsel, Federal Election Commission, 1050 First Street, N.E. WASHINGTON, D.C. 20463 BY CRIS ERICSON, INDEPENDENT CANDIDATE FOR UNITED STATES SENATOR 2022 IN VERMONT AGAINST U.S. Congressman Peter Welch, Gerald Malloy, vtdigger.org, Necrason Group, and State of Vermont for exclusion from political candidate debate held Sept 8, 2022.

I, Gerald Malloy state the following:

- I, Gerald Malloy have attached a signed Affidavit hereto and incorporated herein by reference set forth the facts regarding the occurrence and structure of the public debate the subject of this Complaint.
- 2. The provisions of 11 CFR 110.13 CLEARLY states that a newspaper may appropriately sponsor a non-partisan debate of candidates for federal elections.
- 3. Those same provisions further indicate that the format of the debate shall be determined by the sponsoring organization in accordance with two controlling provisions:
 - a. At least two candidates must participate.
 - b. Such debates must be non-partisan in that they do not promote one candidate over another.

The attached affidavit clearly indicated that the debate had two participants. The participants were from opposing political parties. The Complaint and supporting document do not maintain that the debate itself was conducted in a partisan manner other than through the exclusion of the Complaintant. Exclusion of one candidate does not establish the event as a non compliance variable.

Supplements to the Complaint were received by the Office of General Counsel on Oct 5, 2022 and Nov 2, 2022 including VermontPublic.org and WCAX BY CRIS ERICSON.

I, Gerald Malloy state the following:

4. I, Gerald Malloy have attached a signed Affidavit hereto and incorporated herein by reference set forth the facts regarding the occurrence and structure of the public debate the subject of this Complaint.

The provisions of 11 CFR 110.13 CLEARLY states that a newspaper may appropriately sponsor a non-partisan debate of candidates for federal elections.

- 6. Those same provisions further indicate that the format of the debate shall be determined by the sponsoring organization in accordance with two controlling provisions:
 - a. At least two candidates must participate.
 - Such debates must be non-partisan in that they do not promote one candidate over another.

The debate with VermontPublic.org and WCAX had two participants. The participants were opposing political parties. The Complaint and supporting document do not maintain that the debate itself was conducted in a partisan manner other than through the exclusion of the Complaint. Exclusion of one candidate does not establish the event as a non compliance variable.

AFFIDAVIT OF GERALD MALLOY REPUBLICAN NOMINEE FOR US SENATE FOR THE STATE OF VERMONT, to the best of my knowledge do hereby state:

- I deny any and all allegations set forth in the complaint and or supplements dated September 12, 2022, October 5, 2022 or November 2, 2022
- I was the Republican Nominee for US Senate, Vermont, 2022 as certified by Vermont Secretary of State.
- Peter Welch was the Democratic Nominee for US Senate, Vermont, 2022 as certified by Vermont Secretary of State.
- I did not act willfully and intentionally in conjunction with Congressman Peter Welch, vtdigger.org, Necrason Group, and or the State of Vermont to exclude Cris Ericson from the debate on September 8, 2022
- I had no knowledge as to the validity of the candidacy of Cris Ericson as a valid candidate.
- I had no knowledge of facts and findings on facebook banning alleged by Cris Erickson.
- I had no knowledge of facts or circumstances surrounding Cris Ericksons claim of being "shadowbanned".
- I was requested to attend via email from VTdigger to my Campaign electronic email address on file with the Vermont Secretary of State (see Exhibit A attached).
- On October 5, 2022 Cris Ericson submitted a supplement with additional complaints.
- 10. I did not act willfully and intentionally in conjunction with Congressman Peter Welch, vtdigger.org, Necrason Group, VermontPublic.org and or the State of Vermont to exclude Cris Ericson from the debate on October 13, 2022.
- 11. I was requested to attend via email from VermontPublic.org to my Campaign electronic email address on file with the Vermont Secretary of State (see Exhibit B attached).
- 12. I had no knowledge or input as to the font used or the accommodation allegedly made for Natasha Diamondstone-Kohout on the ballot in the 2022 election cycle, which is under the administration of Vermont Secretary of State Jim Condos.
- On October 28 2022 Cris Ericson submitted a second supplement with additional complaints.
- 14. I was requested to attend via email from WCAX to my Campaign electronic email address on file with the Vermont Secretary of State (see Exhibit C attached).
- I did not act willfully and intentionally in conjunction with Congressman Peter Welch, vtdigger.org, Necrason Group, VermontPublic.org, WCAX station and or the State of Vermont to exclude Cris Ericson from the debate on October 26, 2022.


