Thank you for speaking with me this morning with respect to the above referenced matter. As we discussed, my firm has been retained to represent Abby Dupree, who is one of a number of respondents included with the FEC Complaint made by Citizens for Responsibility and Ethics in Washington. A copy of Ms. Dupree's Statement of Designation of Counsel identifying our representation is attached for your files.

Ms. Dupree received notice of the Complaint on or about November 15, 2022, making the response due on or before November 30, 2022. My purpose in contacting you this morning was both to introduce myself and request an extension of the deadline to respond to the Complaint, making it now due on or before December 23, 2022. The Thanksgiving holidays consumed a significant portion of the original 15-day period and the Complaint itself is 41 pages long.
