COMPLAINT

This complaint is filed under 52 U.S.C. § 30109(a)(1) against George Anthony Devolder-Santos ("George Santos"), Devolder-Santos for Congress (the "Campaign"), Nancy Marks, in her official capacity as treasurer, and Sam Miele (collectively, "Respondents") for violating provisions of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Federal Election Commission (the "FEC" or "Commission") regulations. Based on public reports, Sam Miele, who worked as a fundraiser for George Santos's congressional campaign during the 2020 and 2022 election cycles, impersonated Dan Meyer, a campaign employee of and the chief of staff to then Minority Leader Kevin McCarthy, for the purpose of soliciting financial

contributions to Santos's campaign. Federal law states that no person shall fraudulently misrepresent themselves as acting on behalf of a candidate or an agent of a candidate for the purpose of soliciting contributions. Respondents appear to have violated this well-established prohibition, raising hundreds of thousands of dollars for Santos's congressional campaign under false pretenses. The Commission should act immediately to investigate Respondents' actions and seek the appropriate financial penalties.

BACKGROUND

George Santos was elected to the U.S. House of Representatives for New York's 3rd Congressional District in the November 2022 general election.² He was also a candidate for Congress in the 2020 election cycle.³

On December 26, 2022, Santos admitted that he lied about numerous aspects of his background during his recent federal campaign. These admissions—as well as other discrepancies in his campaign's filings and disclosures—have led to him and his Campaign being investigated for a number of possible federal campaign finance violations.⁴ Weeks later, reports emerged that a member of Congressman Santos's political team sent calls and emails to wealthy donors "from a man who said he was Dan Meyer, McCarthy's chief of staff, during the 2020 and 2022 election cycles." According to several sources, Miele called donors pretending to

be Meyer and sent follow-up emails from a fake address.⁶ One fundraiser said that they were suspicious following one of Miele's solicitations and used their contacts "to get in touch with the chief of staff and he said, 'This isn't me.'" Reports indicate that McCarthy's team learned of the Congressman's campaign's behavior *as early as* August 2021.⁸ In response to press inquiries, Elliot Berke, counsel to Kevin McCarthy for Congress, said: "When this issue came to our attention last year, I raised it with the Santos campaign and felt it was resolved to our satisfaction." Majority Leader McCarthy himself responded by saying the following: "It happened and I know they corrected, but I was not notified about that until a later day." Though news reports state that Meyer worked as McCarthy's chief of staff at the House of Representatives, disclosure reports show that he was also on McCarthy's campaign payroll during the 2020 and 2022 election cycles. Specifically, McCarthy's principal campaign committee, Kevin McCarthy for Congress, disclosed paying Meyer a total of \$84,742 since 2019, as listed in Exhibit A.

LEGAL DISCUSSION

Federal law states that "no person shall fraudulently misrepresent themselves as speaking, writing, or otherwise acting for, or on behalf of, any candidate or agent thereof for the purpose of soliciting contributions or donations" or "willfully and knowingly participat[ing] in or conspir[ing] to participate in any plan, scheme, or design to" misrepresent a candidate for the

purpose of soliciting donations."¹¹ The legislative history of this law indicates that Congress intended this prohibition to "apply to any entity that fraudulently raises donations by posing as a political committee or candidate, or participates in a scheme intended to fraudulently raise donations by posing as a political committee or candidate."¹²

In clear violation of this rule, it appears that Miele, acting on behalf of Santos's campaign, misrepresented that he was acting on behalf of McCarthy and his campaign employee and official side chief of staff, Dan Meyer, in order to solicit donations to Santos's campaign. The reporting suggests Miele engaged in this activity to give the impression that McCarthy supported or endorsed the solicitations. Public reporting indicates that Miele misrepresented himself as Meyer in both phone calls and emails seeking contributions for Santos's campaign, and also used fake email addresses to follow up with individuals regarding the contributions. Further, this activity did not occur in isolation; rather, it appears that Miele engaged in these fraudulent fundraising activities over the course of two election cycles. The Santos campaign paid Miele almost \$50,000 for fundraising consulting during the 2019-2020. After losing by more than 12 percent, Santos Recount Fund paid Miele \$15,000 in November 2020. ¹³ In the 2022 cycle, FEC records show that the Campaign gave over \$42,000 to The One57 Group, a Florida based limited liability company that Miele manages. ¹⁴ As the Santos campaign's fundraiser, Miele's actions are directly attributable to the Campaign. Accordingly, Respondents'

actions, if proven, would constitute a clear violation of the law, as concluded by the FEC in similar enforcement matters. 15

It is indisputable that Meyer was on the McCarthy campaign's payroll during the relevant time period, earning nearly \$85,000 for campaign-related work. And the solicitations referenced Rep. McCarthy's staffer specifically. As noted above, the statute specifies that fraudulent misrepresentation includes "speaking, writing, or otherwise acting for, or on behalf of, *any candidate or agent thereof* for the purpose of soliciting contributions or donations." Accordingly, there is reason to believe that Respondents violated 52 U.S.C. § 30124(b) by fraudulently misrepresenting an agent of a federal candidate for purposes of soliciting contributions.

REQUESTED ACTION

Respondents' actions, if true, would amount to significant violations of federal campaign finance law, undermining the Act's transparency and anti-corruption objectives. We respectfully request that the Commission immediately investigate these allegations, fine Respondents the maximum amount permitted by law, and enjoin Respondents from further violations of the law.
