1. N/A

- 2. Our Treasurer, Dierdre Morrison, received guidance from our FEC analyst Kevin McQueen on the PAC reimbursing me for purchases directly related to PAC business put on my credit card.
 - A. We have documented all expenses that are related to the work of the PAC. We used a personal American Express card. EXHIBIT A
 - B. The \$3K reimbursement with no explanation on June 15th is a partial reimbursement for a payment we made to Lake Outfitters for T-shirts, invoiced March 28, 2022.
 - C. Education First Defenders LLC is my consulting company. We do graphic design, research, strategy, and other things related to consulting. Education First Defenders LLC has invoiced the PAC for services performed.
 - D. Not sure how or why the address of Pen & Shield 501c3 is relevant to this complaint.
 - E. Not sure how or why our personal income tax report or LLC tax report is relevant. Moreover, our tax filin]g deadline is April 15, 2023.
- 3. Our Treasurer has reviewed all our FEC submissions and cannot determine the nature of the complainant's allegations. Copies of submitted forms attached to this email EXHIBIT B
- 4. When we established the PAC, we filed the name "Education First Alliance INC" instead of "Education First Alliance PAC," and we changed the name of the PAC on the day we discovered the error. We worked with our FEC analyst Kevin McQueen at 202-694-1173 to correct the error.
 - A. Our non-profit Corp. and this PAC each have have separate EINs. Education First Alliance INC. EIN: 88-1879542
 - B. Ed First Alliance PAC opened its associated bank account on the day the PAC was created.
 - C. In August 2022, the Complainant Kelly Wiggin herself pointed out in a video that the PAC immediately changed "INC" to "PAC" once the error was brought to our attention. EXHIBIT C: https://youtu.be/URgVyTPu89c
- 5. The day we started our PAC, we updated our website to alert the public of the change. We also sent email alerts announcing the change and noticed the public through various other media platforms. The Complainant presented to the Commission a copy of a press release we issued to notify the public that we had become a PAC and that we would be supporting candidates for office.
 - A. Contrary to the Complaintant's allegation, I voluntarily contacted the Secretary of State around June 28,2022 to ask for guidance on having the same name for a PAC and NC non-profit. Specifically, I spoke to Gail Elula who told me that although it may not be illegal, it would be ideal to change the name of one entity so as not to create marketplace confusion i.e avoid a substantial likelihood of confusion.
 - a. The Complaintant learned that I contacted the Secretary of State through an open record request she made sometime after
 - B. Contrary to the complaint's allegation, the Secretary of State at no time forced or otherwise compelled us to contact the FEC.

- C. From February June 2022 potential donors were referred to our Annedot page when they clicked a "DONATE" button to make financial contributions. Said page contained all required disclosures.
- D. We added additional disclosures to multiple webpages around the first of June, 2022 after we looked at other PACs to learn best practices.
- E. I am unsure how or why our decision not to renew the charity license of a separate entity with the Secretary of State is germane.
- 6. I am not sure how or why a North Carolina non-profit corp is relevant here.
- 7. We held an educational event on 4/22/2022 and the money from ticket sales paid for speakers and expenses related to the event.
 - A. The sale of all tickets was disclosed on our first FEC filing. We listed all the names and contacts of every person who bought a ticket.
- 8. Expenses for Legal Shield and other media subscriptions were used as part of the PAC.
 - A. We rely on multiple newspapers to analyze current events and political trends so we may construct messaging and policies that guide our advocacy. A bulk of our advocacy comes from writing articles. We use local and national media content to guide our work in this regard.
 - B. Legal Shield is a subscription legal insurance.
 - C. This insurance is used to indemnify Sloan Rachmuth as a direct result of the Complainant's group members taking out criminal charges against me in bad faith. EXHIBIT D
 - D. These charges were dismissed, however the Complainant issues legal threats against each time the PAC makes political endorsements that she did not approve of. Were it not for my work as the PAC spokesperson, I wouldn't have incurred the expense.
 - a. Videos of the Complainant making these threats against me, the PAC, our candidates, and our volunteers can be viewed HERE and HERE.
 - E. On June 15th, the complainant's group launched a public attack against the PAC in retaliation for supporting a Black candidate for office.
 - a. In mass emails sent to me and published online, the Complainant's PAC objected to a Jewish person (me) taking part in the political process. Because of continued harassment by the Complainant, we require personal indemnification. EXHIBIT E
 - b. The PAC published a video response to the Complainant's attack against our PAC: https://www.youtube.com/live/kEcXFMELNyY?feature=share
 - F. Tracy Ovitt received a donation from the PAC to help cover her expenses which resulted as a direct consequence of defending the PAC on Facebook against attacks made by the Complainant.
 - G. The Complainant and her PAC filed fraudulent criminal charges against Ovitt in four separate counties. The Complainant then sent copies of criminal charges against Ovitt and me to hundreds of candidates and officials as a means to damage the PAC.
 - a. Our response sent out to various candidates, lawmakers, and supporters about the Complaintantant's attack: EXHIBIT F

- b. The Complainant admits to taking out charges for the purpose of damaging our PAC and our supported candidates: https://youtu.be/kilC1370JU0
- c. The Complainant used the criminal charges her PAC members took out on me and our volunteer as a promotional vehicle for her own PAC as seen on its website: https://www.hbtribe.com/newsroom
- d. After all the charges were dismissed, the PAC's board voted to donate \$300 to help her pay legal fees.
- H. Supporting policies, people, and candidates who take a stand against racism and bigotry is central to the PAC's mission. On our website we write: "Civil society is built on respect for human dignity."
 - a. Our PAC has a program where we support people who are being targeted because they support our PAC-backed candidates.
 - b. Given Ovitt publicly stood against Neo Nazism and in favor of democracy, the PAC felt the donation also provided an ideal public symbol of our commitment to our mission. We used Ovitt's case and our donation as a touchpoint in publicity for the PAC.
- I. The PAC also donates to volunteers who incur legal expenses as a direct result of their political advocacy on behalf of the PAC.
- J. In December, the PAC donated \$300 to an activist who had a restraining order brought against her by the political opponent of a candidate the PAC supported. EXHIBIT H
 - a. That complaint was dropped a month later, however the volunteer had incurred \$1K in legal fees. Our board decided to donate \$300 to her legal expenses because the event happened as a result of her advocacy of a candidate supported by the PAC.
 - The Complainant made a video about the incident and our commitment to support this volunteer: https://youtu.be/URgVyTPu89c
- 9. The PAC is a 527 Org. and, thus, donors have no donation limit.

CONCLUSION: Since we started our PAC a year ago, we have worked with our FCC agent Kevin McQueen to ensure that we were accounting for personal reimbursements correctly before filings, and in changing our name from "Education First Alliance INC" to "Education First Alliance PAC" as soon as the error was brought to our attention.

The Commission should be aware that the Complainant has filed this baseless complaint to harass me and to attempt to stop our work. This is not the first time the Complainant has exhibited discriminatory behavior towards me and it is my good faith belief that it is deeply rooted in the Complainant's antisemitism.

These ceasless attacts on various people associated with our PAC has required us to take protective, and defensive measures.

To clarify, we are dealing with extremists in the North Carolina mountains – people who hold the most polarizing views in the country and who despite anyone and everyone who do not exactly agree with their political and social beliefs. A year ago, the Complaintant publicly announced her intentions to destroy our PAC and has gone through multiple government agencies to attempt to achieve her goal.

Well, that email was quickly forwarded to the leader of Education First, a non-profit LLC or a PAC, take your pick, as they have the same web site and the same named agent for service, one Jennifer Rachmuth, a bossy Jewess who has been slandering my associates and now myself for asking about the work history of her favored candidate, one Brian Echevarria. Her antics have included various misdirection methods right out of the radical handbook, including stating that we are racists, sexual perverts, anti-semites, and pure evil, just for asking the innocent question, "how has Brian supported himself for the past twenty years with no employment record, and a pattern of abusing the legal requirements for reporting on his multiple non-profit LLC's over many years?" I sent that email to my regular distribution of followers in response to a request for clarification of the term zionist from one of my readers. AFAIK there are no political leaders in my readership, only conservative Christians. My reply did not say anything about Jews in general or Education First or Jennifer Rachmuth; it was not an attack on anyone, rather a source of information for those who want to learn about the plans and intentions of the zionists, and to understand why zionism is a direct threat to American values, as it is anti-Christian. It is not hate speech or bigotry, it merely addresses historical facts. (See Article 19 of the UN Declaration of Human Rights). The zionists are a death cult which worships Satan and refuses Jesus. Their philosophy, stated clearly in the Talmud, their bible of revisionist Jewish history, makes clear that they are the Chosen People (by the vengeful god of the Old Testament), and that they are expected to enslave or kill all nonbelievers. It does not respect all God's creatures as ends in themselves, but considers them all fair game to be used as means to suit zionist ends. Read the Talmud before you start playing the victim card, the anti-semitic card, and start claiming that I am attacking you or Education First. I merely pointed out my own personal conclusion that zionism is a direct threat to the vision of America as we know it. I personally do not have the time or want to waste the energy hating anyone.
