Dear Mr. Keeys,

This law firm has been engaged to represent Congresswoman Lauren Boebert, Lauren Boebert for Congress, We The People Leadership PAC, and Taylor Moose (collectively, "Respondents") related to MUR 8134. On May 12, 2023, Respondents received notification of the Complaint regarding MUR 8134. Pursuant to 52 U.S.C. § 30109(a)(1), Respondents have the opportunity to demonstrate in writing within fifteen days of notification that the Commission should take no further action.
