A. OGC -

Excessive, Prohibited and Other Impermissible Contributions or Transfers (Standard 5)

The Committee can be referred to the Office of General Counsel (OGC) for failing to clarify, fully refund, or transfer-out the excessive and prohibited portions of contributions received from one (1) organization, totaling \$114,240.00 during the 2019 calendar year. The Committee also did not include an indication that the contributions were deposited into the non-contribution account.

The Committee can be referred to OGC for failing to clarify, fully refund, or transfer-out the excessive portions of contributions received from six (6) individuals, totaling \$59,000.00 during the 2020 calendar year. The Committee also did not include an indication that the contributions were deposited into the non-contribution account.

Mathematical Discrepancies (Standard 6)

The Committee can be referred to OGC on the 2019 Year-End Report for an opening cash-on-hand discrepancy totaling \$421,579.84.

Independent Expenditure Reporting Problems – Political Committees (Form 3X) (Standard 14)

The Committee can be referred to OGC for failing to disclose the Presidential Primary state for independent expenditures totaling \$135,774.31 during the 2019 calendar year and \$236,760.36 during the 2020 calendar year.

IX. OTHER COMMISSION ACTIONS DURING THE 2017-2018 AND 2019-2020 ELECTION CYCLES:

The Committee was the subject of an Administrative Fine matter in which the Committee was assessed a fine of \$9,446.00 for failing to timely file the 2020 April Quarterly Report (AF 3828).

The Committee is currently the subject of three (3) open Administrative Fine matters in which the Commission found reason to believe the Committee failed to timely file the 2020 July Quarterly, October Quarterly, and Year-End Reports (AF 3900, AF 3950, and AF 4187 respectively).

X. OTHER RELEVANT INFORMATION:

The Committee submitted an Amended 2020 Year-End Report on April 18, 2021. Review of this amendment revealed potential violations under Standards 5 (Excessive, Prohibited and Other Impermissible Contributions or Transfers) and 11 (Failure to Properly Itemize Disbursements) for which a Request for Additional Information (RFAI) was sent to the Committee. Due to time constraints of the audit referral, these potential violations were not included in this referral.
