As sent in this envelope, a twitter  
user named Ryan Hooker posted a  
mailer he received in the mail.

This mailer attacked another candidate  
for Arizona's 1<sup>st</sup>, Marlene Gordon Woods,  
for not having acceptable views of  
gay marriage. I asked Hooker if he  
knew who sent it, but he did not

know. That was on October 27<sup>th</sup>,  
2023. On November 1<sup>st</sup>, 2023,

I received a reply to my reply to  
Hooker by another candidate for  
Arizona's 1<sup>st</sup> district, Andrew Horne.

I attached relevant communications  
with Horne in the envelope. He said  
that Mr. O'Callaghan made the

mailer and intentionally sent it out  
without a disclaimer. In addition,

Mr. O'Callaghan has yet to report any  
transactions regarding mailing

communications as of November 1<sup>st</sup>

2023. It is unknown whether Mr. O'Callaghan

has reached the 500 similar communications mark, but the respondent should still be held accountable. I hope you can reach out to Mr. O'Callaghan and find out.
