SUBJECT: MUR 8212 (Country Over Party PAC) Pre-Probable Cause Conciliation

On February 6, 2024, the Commission opened a MUR and found reason to believe that Country Over Party PAC (f/k/a Kinzinger for Congress) and Paul Kilgore in his official capacity as treasurer violated 52 U.S.C. § 30116(f) and 11 C.F.R. § 102.9(e)(3) by failing to timely remedy general election contributions. The Commission authorized the Office of General Counsel ("OGC") to engage in pre-probable cause conciliation with Country Over Party PAC. Attached is a signed Conciliation Agreement signed by Country Over Party PAC's treasurer and a redlined version as compared to the opening offer approved by the Commission. We recommend

that the Commission accept the signed agreement and close the file in this matter.
