Dear Members of the Commission,

We are writing on behalf of the "McCorkle For Colorado" campaign in response to the inquiries detailed in Matter Under Review (MUR) 8221. This letter aims to provide comprehensive explanations and substantiations for the financial activities in question.

### **1. Amendments and Late Filings:**

We acknowledge that during the 2019-2020 election cycle, the campaign committee had a single late filing regarding the Pre-Primary report due to an oversight of the required reporting schedule. This was the team at the time's first electoral campaign, and the intricacies of the reporting requirements were unfamiliar to that team. The late filing resulted in a fine of approximately \$4,000, which was promptly paid.

### **2. Personal Vehicle Expenses and Reimbursements:**

Throughout the 2021-2022 and 2023-2024 cycles, our candidate extensively used his personal vehicle for campaign activities across Colorado's largest district. This usage was never reimbursed, which is reflected in the following detailed breakdown:

- 2021-2022: Fuel and maintenance expenses totaled \$7,445.48, documented across numerous entries (e.g., \$103.90 on 2/3/2023 at Conoco, \$617.51 on 4/6/2023 at Bozworth Chevy for car maintenance).
- 2023-2024: Similar expenditures continued, amounting to significant costs solely for campaign purposes. Detailed entries are available in the attached documentation.
- The candidate never claimed compensation for miles.

As of Q1 2024, new campaign leadership have implemented a rigorous system for logging mileage (using MileIQ) to ensure all future travel is accurately documented and reimbursed in accordance with FEC guidelines, and implemented a policy ending the use of campaign funds for direct fuel purchases/maintenance costs for personal vehicles.

In the complaint, the complainant alleges that the candidate did not properly reimburse the campaign for 'personal use'. Notably, the candidate is fully retired and does not use the vehicle for a personal commute or work-related purposes unrelated to campaign operations.

Additionally, when totaling all fuel expenditures and maintenance costs, if the candidate had been reimbursed at the federal mileage rate for previous usage, the cost to the campaign would have been more than the actual expenditures. See the attachment for additional information.

### **3. Campaign Expenditures on Events and Office Supplies:**

Detailed records have been maintained for each category of expenditure, as outlined below:

- Events: \$484.56 on food and supplies for various campaign events. Specific expenses include \$193.32 at Costco for a coordinated event with Colorado Democrats (6/27/2022), and \$95.41 at King Soopers for a meet-and-greet at Walker Ranch TrailHead (8/22/2022).
- Office Equipment and Supplies: \$3,202.40 spent on essential office equipment from vendors such as Amazon and Best Buy. For example, \$1,746.24 at Best Buy and \$349.04 at Costco on 5/22/2023. Non-expendable equipment has not been disbursed by the campaign and continues to be maintained as campaign assets.
- Office Cleaning: Totaling \$497.97, including multiple services from Moxie Pest Control to maintain the campaign office utilized for public engagements.

### **4. Small Dollar Meals and Miscellaneous Expenses:**

Our campaign has also incurred small, yet necessary, expenses related to meals during travel and campaign activities, amounting to \$749.81. These include multiple occasions such as meals at Raising Canes and local eateries like gb fish and chips, which facilitate campaign operations. Since the campaign has always operated primarily out of the Parker area, these meals were for both the candidate and staff during travel to and from campaign events, candidate appearances, field operations, and other operational use.

**5. Toll Expenses:**

A charge of \$258.12 for “NY state tolls” was incurred on 5/30/2023. Colorado has many toll roads that are not reasonably avoidable, and uses a toll-by-plate billing system which is outsourced to a company based in New York. This expense was necessary for the use of the toll roads in Colorado.

**Conclusion:**

The "McCorkle For Colorado" campaign assures the Commission of our strict adherence to FEC regulations and our proactive measures to correct previous oversights. Attached you will find all relevant receipts, logs, and additional documentation supporting each expense and amendment made.

We appreciate the Commission's attention to ensuring transparency and accountability and remain at your disposal for any further inquiries or clarifications.

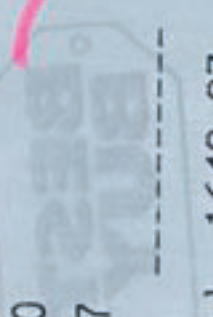
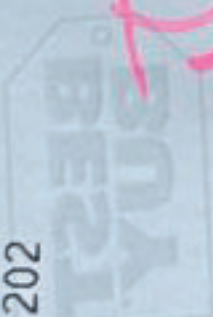
