We are writing on behalf of Respondent New San Diego in connection with the above-referenced matter and provide the attached Designation of Counsel to confirm our representation of Respondent.

The Committee received the November 14, 2024 letter from Gordon King advising that a complaint had been filed in this matter. Although the 15 day period to formally respond to the letter has run, we ask for your consideration in providing an extension of time for the committee to respond to the complaint given that the letter was received shortly before the Thanksgiving holiday and the committee was only recently able to secure representation. Moreover, as our firm has just become involved in this matter, it will take additional time for us to investigate the facts and provide a comprehensive response to the complaint.
