To Whom it May Concern:


I represent Tony Vargas for Congress and the Campaign's Treasurer, Jessica Lathrop (collectively, "Campaign"). We are in receipt of your March 19, 2024, correspondence notifying the Campaign of a complaint filed against it by the Foundation for Accountability and Civic Trust ("Complainant").

The purpose of this letter is to request a brief extension of time to respond to the Complainant's allegations. The current deadline for the Campaign's response is April 3, 2024; however, we respectfully request an additional thirty days, until May 3, 2024, to submit our response.
