COMPLAINT

Complainant Justice Democrats PAC is a PAC with a Non-Contributor Account, C00630665.

This complaint is filed with the Federal Election Commission (“FEC”) in accordance with the provisions of 52 U.S.C. § 30109(a)(1) in the belief that Respondents violated the Federal Election Campaign Act of 1971, as amended, 52 U.S.C. §§ 30101 *et. seq.* (the “Act”). As described below, the April Quarterly report filed by MartyDolanForCongress, with Dolan as its Treasurer, is riddled with errors and blatant recordkeeping and reporting violations of the Act.

The Act’s reporting requirements are crucial to ensure that the general public knows who is funding and working on campaigns – the report filed by MartyDolanForCongress flagrantly simply disregards these disclosure requirements. The Commission should penalize Dolan and his candidate committee accordingly.

FACTS

1. **Martin Dolan** is a candidate for United States Congress in New York’s Fourteenth Congressional District (“Dolan”). **MartyDolanForCongress**, with Dolan as its Treasurer, is his authorized campaign committee. MartyDolanForCongress registered with the FEC in October 2023, first to run in New York’s Sixteenth District, and then changed districts on March 7, 2024.¹

2. As Treasurer, Dolan is responsible for ensuring that reporting and recordkeeping requirements of the Act are met.
3. On April 15, MartyDolanForCongress filed its April Quarterly report (“April Quarterly Report”, the “Report”).²
4. The filed Report contains multiple material errors that amount to violations of the Act, and a clear disregard for the Act’s reporting and recordkeeping requirements:
 - a. The Report lists the candidate’s district as New York’s Sixteenth District, opposed to New York’s Fourteenth District, despite the fact that Dolan has filed a FEC Form 2 to run in the Fourteenth District.³
 - b. **Contributions, Schedule A, Line 11a:**
 - i. The Report does not show compliance with best efforts rules for obtaining occupations and employers: it lists “unknown” for occupation and employer instead of “information requested” and no other note on report indicating that there has been follow up has been made to obtain that information. *All donors, other than himself, are missing occupations and employers.*⁴

By way of example, three entries are shown below, but in total **23 donors totaling \$14,000 are disclosed this way.**

iv. MartyDolanForCongress does not report any contributions received through ActBlue, despite ActBlue having reported receiving and disbursing contributions to the committee – the report shows \$0 in unitemized contributions on the April Quarterly Report, but it received \$12 in ActBlue contributions.⁷

Of note, MartyDolanForCongress’ Year-End report is missing nearly \$2,982 in ActBlue contributions that were not reported, including five that should have been itemized. ActBlue, disbursements to MartyDolanForCongress at

i. The campaign paid Common Sense America \$7,500 on March 28th, but failed to include a purpose for the disbursement.⁸

iii. The Report fails to report any potential memo entries for expense reimbursement of \$1,000 to Parker DeDeker on March 28th.¹⁰

iv. The Report discloses multiple disbursements as “cash expenses for canvassers” – \$1,000 to Parker DeDeker and \$500 to the candidate. While a campaign may maintain a petty cash fund, expenditures to any one person per purchase is limited to \$100 and requires maintaining a detailed log of disbursements.¹¹

vii. The campaign paid Meridian Campaign Advisors \$15,000 on March 19th for “retainer” which does not provide adequate detail for the general public to understand the services provided.¹⁴

d. Expenditures, Schedule B, Line 17:

- i. The Report lists repayment of Dolan’s loan on Line 20a instead of 19a, which makes it look like the campaign refunded \$35,000 to Marty Dolan (more than it had raised).¹⁵
- ii. In addition, the above loan repayments are not listed on Schedule C.

VIOLATIONS OF THE ACT

5. Failure to provide Employer and Occupation for donors.

Respondents have knowingly and willingly violated 52 U.S.C. § 30104(b)(3)(A) for at least 24 contributions, which requires the “identification” of each “person (other than a political committee) who makes a contribution to the reporting committee during the reporting period, whose contribution or contributions have an aggregate amount or value in excess of \$200 within the calendar year (or election cycle, in the case of an authorized committee of a candidate for Federal office), or in any lesser amount if the reporting

committee should so elect, together with the date and amount of any such contribution.”¹⁶

6. Failure to provide purposes for expenditures.

Respondents have knowingly and willfully violated 52 U.S.C. § 30104(b)(5)(A) for at least seven expenditures, which requires a committee to identify each “person to whom an expenditure in an aggregate amount or value in excess of \$200 within the calendar year is made by the reporting committee to meet a candidate or committee operating expense, together with the date, amount, and purpose of such operating expenditure.”¹⁷

7. Failure to properly report loan repayments.

Respondents have knowingly and willfully violated 52 U.S.C. § 30104(b)(5)(D) by failing to properly report loan repayments to the candidate, which requires a disclosure of each “person who receives a loan repayment from the reporting committee during the reporting period, together with the date and amount of such loan repayment.”¹⁸

8. Petty Cash Fund

There is reason to believe that Respondents failed to properly maintain a petty cash fund according to 11 C.F.R. § 102.11.

Justice Democrats PAC requests that the FEC review this matter and find reason to believe that MartyDolanForCongress and Marty Dolan (as candidate and Treasurer) violated the Act by failing to properly report contributions and expenditures – for failing to properly disclose to the public who was contributing to the campaign and how the campaign spent its money.

Whether out of ignorance or avoidance, MartyDolanForCongress has filed a severely deficient report that flaunts the Act’s crucial disclosure requirements. Unfortunately for Respondents, this is a violation of the Federal Election Campaign Act. The FEC should penalize them accordingly.


