Dear Ms. Brown:

I am counsel for and represent Thomas Datwyler in the complaint filed with the Federal Election Commission (the "Commission") on or about April 29, 2024 and designated as Matter Under Review 8253 (the "Complaint"). This letter, along with the affidavit of Thomas Datwyler ("Affidavit") attached hereto as Exhibit 1, constitutes Mr. Datwyler's response to the Complaint.

Upon information and belief, Benjamin Ray (the "Complainant") seems to have named Mr. Datwyler as a respondent because of the Complainant's belief that Mr. Datwyler is the treasurer of the other named respondent, an entity named "Turn AZ Blue PAC", which is not registered with the Commission.¹ However, Mr. Datwyler is not the Treasurer of "Turn AZ Blue PAC", nor has he ever been the treasurer of it.² In fact, Mr. Datwyler has no knowledge of who or what "Turn AZ Blue PAC" even is.³ The only reason he now has any of knowledge of why he is listed as the Treasurer of "Turn AZ Blue PAC" is because of information that a reporter from Arizona sent him via email.⁴

That reporter sent a document to Mr. Datwyler that she allegedly obtained from the Federal Communications Commission's website that is entitled "ISSUE (Non-candidate) ADVERTISEMENT AGREEMENT FORM". That document appears to be an ad buy made by "Renegade Public Affairs/Turn AZ Blue PAC". Upon receiving this document from the

reporter, Mr. Datwyler called/emailed the individual representing Renegade Public Affairs, an individual by the name of Carlos Sierra, to ask why Mr. Datwyler is listed as Treasurer of "Turn AZ Blue PAC". To date, Mr. Datwyler has not heard back from Carlos Sierra. 8

There is no information available to suggest Mr. Datwyler was in any way involved with or aware of any of the issues giving rise to this matter. That is because Mr. Datwyler is not, nor has he ever been, the treasurer of an entity named "Turn AZ Blue PAC". Accordingly, Mr. Datwyler respectfully requests that the Commission remove him from MUR 8253 and dismiss him from the matter entirely. Alternatively, the Commission should find no reason to believe that Mr. Datwyler violated the Act because Mr. Datwyler is not, nor has he ever, been the treasurer of an entity named "Turn AZ Blue PAC".

AFFIDAVIT OF THOMAS DATWYLER

- I, Thomas Datwyler, being over the age of 18 and under no legal disability, testify from personal knowledge as follows:
 - I am named as a respondent in a complaint that was filed by Benjamin Ray with the Federal Election Commission ("FEC") and has been assigned as Matter Under Review 8253 ("Complaint").
 - 2. I submit this Affidavit in support of my Response to the Complaint.
 - 3. I am the President of AxCapital LLC, a limited liability company that provides campaign accounting and compliance services to candidate and political committees.
 - 4. Over the last 16 years, I have served as treasurer or assistant treasurer for hundreds of candidate and political committees that were required to register with the FEC.
 - 5. On May 3, 2024, I received notice from Ms. Christal Dennis of the FEC that the Complaint had been filed against an entity named "Turn AZ Blue PAC" and me, in my alleged capacity as Treasurer of the entity named "Turn AZ Blue PAC".

- 6. After I reviewed the Complaint that same day, I was confused about why I was named as a Respondent in the Complaint because I had never heard of the entity named "Turn AZ Blue PAC", nor had I ever done any work for an entity named "Turn AZ Blue PAC", particularly as Treasurer.
- 7. Consequently, I asked Ms. Dennis in an email for more information about this Complaint since I had no knowledge of the existence of an entity known as "Turn AZ Blue PAC". Ms. Dennis informed me that I received the Complaint because the Complainant listed me as Treasurer of the entity known as "Turn AZ Blue PAC". A true and accurate copy of my email communications with Ms. Dennis is attached to this Affidavit as Exhibit A.
- 8. Five days later, on May 8, 2024, I was contacted by a woman named Laura Gersony, a national politics reporter for The Arizona Republic, who wanted to know how much the entity known as "Turn AZ Blue PAC" had spent so far in a certain congressional race in Arizona. Not having any knowledge of an entity known as "Turn AZ Blue PAC", just as I did with Ms. Dennis, I asked Ms. Gersony for more information why she contacted me about that issue. A true and accurate copy of my email communications with Ms. Gersony is attached to this Affidavit as Exhibit B.
- 9. Ms. Gersony forwarded me a document entitled "ISSUE (Non-candidate) ADVERTISEMENT AGREEMENT FORM", which was filled out by a Carlos Sierra of Renegade Public Affairs and listed "Thomas Datwyler, Treasurer" on the form.
- 10. I have never had any discussion or communication whether in person, over the phone, over email, or over any other medium with any person or representative of an entity named "Turn AZ Blue PAC", including with Carlos Sierra of Renegade Public Affairs.

- 11. I have never agreed to serve as Treasurer for an entity named "Turn AZ Blue PAC".
- 12. I have never provided any service whatsoever to an entity named "Turn AZ Blue PAC".
- 13. After finding contact information for Carlos Sierra, on May 4, 2024, I called/emailed him to ask why I was listed on the "ISSUE (Non-candidate) ADVERTISEMENT AGREEMENT FORM" as Treasurer.
- 14. To date, Mr. Sierrra has not responded to my call/email.


