**RE: Request to investigate apparent campaign finance violations by John McGuire**

To whom it may concern,

My name is Rick Boyer, attorney with Integrity Law Firm in Lynchburg, Virginia. I am in possession of evidence which appears to point strongly to multiple potential serious campaign finance violations by John McGuire, spanning his Virginia Senate District 10 campaign (SD 10) and his current campaign for U.S. Congress in Virginia's Fifth District (CD 5).

I am enclosing a large file of information relating to the various campaign accounts Mr. McGuire has had open for various campaigns, including the SD 10 and CD 5 campaigns, his Virginia House of Delegates campaign in District 56 (HD 56), and his two campaigns for Congress in the 7<sup>th</sup> Congressional District, CD 7 2020 and CD 7 2022. References to finance reports from these campaigns are labeled accordingly in the file.

I am requesting that your office conduct a full investigation into these apparent violations, and determine if there is in fact a flagrant and willful flouting of multiple state and federal campaign finance laws.

Links to McGuire's campaign finance reports are provided in an appendix at the end of this letter.

The report is far too comprehensive to detail in this letter, but I attempt to categorize the most significant issues as I see them. Please see the attached file for further details and supporting documentation. The primary reference document is titled "John McGuire Financial Review" (**EXHIBIT 1**) and it is far more comprehensive than space allows in this letter.

- I. **McGuire appears to have illegally listed a deceased person as his campaign treasurer.**

For his HD 56 campaign, McGuire lists David Matthew Clemens as campaign treasurer. His Amended Statement of Organization for “Friends of John McGuire” (HD56), dated July 27, 2021, shows Mr. Clemens being appointed as Treasurer on July 26, 2021. **SEE EXHIBIT 2.** Mr. Clemens passed away on October 10, 2021. **SEE EXHIBIT 3.** Code of Virginia § 24.2-947.3 requires campaign committees to designate a new treasurer within ten days of the “death, resignation, removal or change” of a treasurer. That deadline passed on October 20, 2021. “Friends of John McGuire” continued filing finance reports from October 2021 to August 2022. Mr. Clemens continued to be named on these reports as the person authorizing all expenditures.

§ 24.2-947.3 provides, “Any candidate who fails to appoint a treasurer or successor treasurer shall be deemed to have appointed himself treasurer and shall comply as such with the provisions of this chapter.” Accordingly, Mr. McGuire himself is liable for any false or inaccurate filings after the death of Mr. Clemens and until the date the HD 56 committee was closed.

Also interestingly, the email address attributed to David Clemens on the amended Statement is [tadatwyler@gmail.com](mailto:tadatwyler@gmail.com). Datwyler is a questionable GOP operative from Wisconsin, who serves as treasurer for a number of GOP-affiliated PACs. One Datwyler-connected PAC “is reportedly under investigation by the Federal Bureau of Investigation.” **SEE EXHIBIT 4<sup>1</sup>.** § 24.2-947.3(A) requires that “the candidate shall appoint a single campaign treasurer **who shall be a registered voter in Virginia.**”

Attached as an exhibit is the Virginia State Corporation Commission regarding a corporation known as “Caging for Conservatives, Inc” (CFC). On Page 7 is the corporation’s 2022 annual report. **SEE EXHIBIT 5.** The report lists Mr. Clemens as the registered agent for CFC. It lists Thomas Datwyler of 455 Carriage Lane, Hudson, Wisconsin as CFC’s president, and Timothy Datwyler of the same address as treasurer.

Given that Mr. Clemens continued to be listed as treasurer for months after his death, it raises the question whether Mr. Datwyler was for all practical purposes filling the role of treasurer, perhaps before and after Mr. Clemens’ death, in violation of § 24.2-947.3(A)’s requirement that the treasurer be a registered voter in Virginia. **SEE EXHIBIT 6,** the Statement of Organization for McGuire’s CD 7 2022 committee, in which Datwyler is named as treasurer (which is legal in federal committees). It appears possible that McGuire used Datwyler for the same purpose in his Virginia race, illegally.

- II. It appears that McGuire claimed donations from one of his campaign accounts to another, but the recipient campaign’s finance report apparently never shows receipt of the donation.**

*(See p. 2 of EXHIBIT 1)*

Between November 2019 and December 2023, there are 15 occurrences where one McGuire committee reports a donation to another committee, but the recipient committee apparently never reports the donation. **SEE EXHIBIT 7.**

On April 4, 2022, an attempt was made to close down McGuire's CD 7 2022 congressional account. This followed a donation of the remaining \$122,623.45 to his SD 10 account on March 31, 2022. The SD 10 report apparently never shows receipt of the donation.

After the April 4, 2022 termination filing for CD 7, the Federal Elections Commission notified the campaign in a letter dated April 7, 2022, that the account could not be terminated until refunds were issued to 21 donors, totalling \$59,300 (I believe these were individuals who donated the maximum amount allowed for both the primary election period and the general election period, but because McGuire did not win the primary, the general election donation had to be refunded). **SEE EXHIBIT 8**. Since the CD 7 account had a zero balance at that point, a "refund" of \$59,300 was reported by the CD 7 account from the SD 10 account. However, the SD 10 account apparently never reports the transfer of the funds to the CD 7 account. Not until several amended termination reports were filed did the FEC approve termination of CD 7 2022 on July 20, 2022. **SEE EXHIBIT 9**.

### **III. Duplicate filing of expenditures between two state campaigns**

McGuire's HD 56 and SD 10 accounts repeatedly report identical or substantially similar expenditures on the same dates as each other. There are 72 such duplicate transactions totaling more than \$26,000. **SEE EXHIBIT 10**. It is perhaps possible that both campaign made identical expenditures to identical vendors for identical purchases on identical dates 72 times, but it seems highly implausible.

There are also 16 dates where identical donation amounts are made to both McGuire's HD56 and SD 10 campaigns on the same date. **SEE EXHIBIT 11**. McGuire could not have been running for House of Delegates and state senate simultaneously, since every year state senators are elected, all delegates are elected as well.

There is a questionable notation on the donation reports as well, on April 13, 2022, where the address of donor Margaret Listrom is shown as, e.g., "Austin, VA 78746," and when the identity and address of the donor are checked, the donor is actually from Austin, Texas, and not "Austin, VA."

### **IV. Repeated apparently false statements of expenditure reports**

McGuire's SD 10 account shows two donations of \$350 to the Fifth Congressional District Republican Committee (CD 5 GOP), on June 13, 2022, and July 6, 2022. The CD 5 GOP reports apparently show neither donation received. **SEE EXHIBIT 1, P. 7**.

The SD 10 account shows a \$25 expenditure for "parking" on October 30, 2023, at 123 Main Street, Palmyra, Virginia. Palmyra, Virginia has no paid parking spaces. **SEE EXHIBIT 1, P. 7**.

### **V. Material Errors in Statement of Organization**

The amended Statement of Organization filed January 12, 2023 contains a material error. The account was opened on March 23, 2022. It states that August 2, 2022 was the date the campaign depository was designated, the first contribution was received, and the first expenditure made. In fact, receipts and expenditures were reported for the period from March 23, 2022 to August 2, 2022.

Also, for a brief period between February 24 and March 1, 2022, McGuire had an open Statement of Organization to run for Congress in the 10<sup>th</sup> District, which he never did.

**VI. Other, comparatively minor errors on report – SEE EXHIBIT 1, P. 7.**

**VII. Apparently using funds donated to state SD 10 campaign to pay federal CD 5 expenditures**

**A. Campaign signs**

**SEE EXHIBIT 1, P. 8.**

It appears that McGuire likely used funds donated to his state senate campaign to pay for signs for his congressional campaign. During the period of March 2022 (when the SD 10 account was opened) until the SD 10 convention (May 6, 2023), the SD 10 account shows expenses totalling \$22,713.93 for printing/signs to Imagine This Printing Company. The signs printed up until convention day read “John McGuire State Senate.” **SEE EXHIBIT 12**, photos of various McGuire campaign signs.

On September 25, 2023, there is another expenditure to Imagine This for \$6081.75, and another on October 19 for \$1939.80. About this time, signs reading “John McGuire for Virginia” instead of John McGuire for State Senate” began appearing around the senate district.

On November 15, 2023, McGuire filed to run for Congress against Bob Good. According to finance reports for McGuire’s three affiliated federal committees (McGuire for Virginia, McGuire Victory Fund and Seal Team PT PAC), there were no expenses for printing or signs from November 15 to December 31, 2023. But McGuire for Virginia signs were now appearing all across the Fifth Congressional District.

**B. Email advocacy communications**

**SEE EXHIBIT 1, P. 9**

On November 15, 2023, McGuire sent his first congressional announcement email, “Big announcement: We can do better than Good.” A graphic of the “McGuire for Virginia” yard sign used in the state senate race is affixed to the email. The email contains the disclaimer, “Paid for and authorized by Friends of John McGuire,” and is sent out by Constant Contact. Additional emails with the same disclaimer and vendor follow 13 more times up to December 31, 2023.

Expenditures to Constant Contact are reported by McGuire’s SD 10 campaign on November 8, 2023 and December 8, 2023. Both occurred after the state senate election on November 7, 2023. None of his federal committees show any payments to Constant Contact between November.

In McGuire’s December 23 email, he includes a picture of himself waving and holding a 4’x8’ “McGuire” sign where the words “for Virginia” are covered by the word “Congress” taped on the sign with blue painter’s tape. The email states, “Waving at cars in Lynchburg this week. I have been having fun campaigning all over the 5<sup>th</sup> Congressional District.” Lynchburg is nowhere near McGuire’s senate district. A copy of the linked web version of the email is attached. **SEE EXHIBIT 13.**

**VIII. Mass entries on one day that suggest expenditures of state funds on federal race**

In his November 25, 2023 email noted in VII. C above, McGuire states, “this Thanksgiving I visited and thanked our first responders and dispatchers in all 24 localities in the 5<sup>th</sup> Congressional District.... FYI, I get 600 miles on a full tank of gas and I filled my truck up twice in just one day!” **SEE EXHIBIT 14.**

None of McGuire’s three federal committees show any expenses for fuel or travel during the Thanksgiving time frame. His SD 10 account shows no fuel expenses in late November, but **shows 26 entries for fuel all dated December 7, totalling over \$1600.00. SEE EXHIBIT 15.** Eleven of the fuel expenses show payments to Exxon in Glen Allen, Virginia. 13 of the other 15 are paid to four other fuel stations in Glen Allen, Ashland, Locust Grove and Manakin Sabot, Virginia. It appears highly unlikely that his state senate campaign made 11 stops for gas at one Exxon on the same day, after the senate election. It appears far more likely that the 26 entries on December 7 are entered to mask actual fuel purchases on behalf of the congressional campaign for his Thanksgiving-season blitz of the congressional district.

On the same December 7 date, the SD 10 account reports “travel” expenses for the Homewood Suites hotel in Christiansburg in southwest Virginia, and the Hyatt Regency in Tyson’s Corner just outside Washington, D.C. **SEE EXHIBIT 15.** It seems unlikely that, more than a month after the state senate race ended, the senate campaign paid for two hotels the same night, in far-distant reaches of the state, well outside the district or the Richmond area where a state senator might be expected to be. There is also a \$55.21 expense to True Value for “sign supplies” on the same date, a month after the senate campaign concluded and three weeks into the congressional campaign. *Id.*

#### **IX. Other questionable expenditures by SD 10 committee**

*(See pp. 11-12 of EXHIBIT 1)*

McGuire’s SD 10 account opened on March 23, 2022. For the first nine days of his first report, expenses exceed receipts for the first nine days, through March 31. How were these expenses paid?

McGuire’s SD 10 report for the period of October 27, 2023 to November 30, 2023, shows a payment for “bank fees” to FNBO in Omaha, Nebraska on October 30, 2023 for \$5102.69. FNBO is not reported as the depository on any of McGuire’s committee Statements of Organization. Such a “bank fee” seems questionable at best.

The FEC’s April 7, 2022 letter requiring McGuire’s CD 7 campaign to refund \$59,000 also questions a contribution from Loading Doc Central, LLC of \$1000 on January 18, 2022 as a possible illegal contribution from a prohibited entity. **SEE EXHIBIT 7.** The FEC allowed closure of the account in July 2022, apparently without addressing the issue further. This appears to be an illegal contribution. The donor is a business located at 535 Halladay Ave W, Suffield, CT.

An expense of \$3600 was reported on November 6, 2023 as a “donation” to the Republican Party of Virginia (RPV). Perhaps this could be a payment for a final mailer paid by the RPV, but there is no gift in kind by RPV reported on the same or the following SD 10 committee report. **SEE EXHIBIT 1, p. 12.**

Throughout his reports, McGuire fails to distinguish between his “Friends of John McGuire” and “John McGuire SD 10” committees. *Id.*

## **X. Petty cash fund**

*(See p. 13 of EXHIBIT 1)*

McGuire's HD 56 committee appeared to violate Virginia petty cash policies. The Virginia Department of Elections' "Summary of Lawss and Policies for Candidate Campaign Committees" (<https://www.elections.virginia.gov/media/formswarehouse/campaign-finance/2023/Candidate-Summary-2023-06-06.pdf>), on Page 27, provides that:

A treasurer may establish a petty cash fund up to \$200. These monies are inclusive of the committee's total expendable funds. The fund should be used for the purpose of making expenditures or reimbursing credit card expenditures of less than \$200. Receipts must be kept and the expenditure made for reimbursement must be reported on the date the expenditure was made and not the date that the reimbursement was provided. The treasurer may replenish the petty cash fund as needed provided the total balance of the fund never exceeds \$200.

McGuire's HD 56 report shows a "petty cash" expense on July 1, 2019 of \$283.80, in excess of the \$200 maximum.

## **XI. Acceptance of illegal contributions during General Assembly session**

*(See p. 14 of EXHIBIT 1)*

Code of Virginia § 24.2-954 provides:

No member of the General Assembly or statewide official and no campaign committee of a member of the General Assembly or statewide official shall solicit or accept a contribution for the campaign committee of any member of the General Assembly or statewide official, or for any political committee, from any person or political committee on and after the first day of a regular session of the General Assembly through adjournment sine die of that session.

McGuire's SD 10 and HD 56 accounts show multiple apparently illegal donations during the 2022 General Assembly session, which ran from January 12 to April 27:

- Jan. 31: Thomas Datwyler: \$746.84
- April 13: Jack Bergman: \$1000
- April 13: Margaret Listrom: \$200
- April 13: Randolph Reynolds: \$5000
- April 18: Frank Bellanger: \$250

McGuire also donated to himself from his other accounts:

- April 3: McGuire for Virginia: \$20934.37

- April 3: Friends of John McGuire: \$20,934

## **XII. Questionable travel expenses for state legislative committees**

McGuire's state legislative committees show a shockingly large number of out-of-state trips charged to state campaigns. **SEE EXHIBIT 16.** Exhibit 16 details a how large numbers of these expenses are charged on the same day in widely divergent parts of the nations. As just a few examples, travel expenses are charged to his HD 56 committee on August 23, 2021 in Dallas, Texas and "Parsippany, New York." Others are charged on August 27 in Dallas, San Ramon, California, and Chicago.

In his SD 10 campaign, the pace steps up still more. On June 14, 2022, both the HD 56 and SD 10 committees show identical expenses of \$828.70 to American Airlines in Dallas. On April 21, 2023, his SD 10 committee shows expenses in Dallas, Boca Raton, Coral Gables, and Miami, Florida, Parsippany, New Jersey, Glen Allen, Virginia and Long Island City, New York.

As the 2023 senate campaign (in which McGuire ran unopposed in the general) drew to a close and the 2024 congressional campaign approached, McGuire's out-of-state travel charges to the SD 10 campaign increased. October 30 saw SD 10 expenses in South San Francisco and Burlingame, California, Boston and Canton, Massachusetts, Parsippany, New Jersey, Amelia Courthouse, Glen Allen and Mineral, Virginia, and Chicago.

It appears unlikely that these charges are legally attributable to campaigning for a Virginia state senate seat for which McGuire was unopposed. Even if the widely divergent points on the compass in the same day could be reconciled, it would appear far more likely that McGuire was conducting fundraising operations on behalf of his congressional run. This amount of apparent out-of-state interest in an unopposed state senate race is simply not credible. It would appear to strongly suggest that state committee funds were used to fuel his federal campaign without being properly donated to the CD 5 campaign under federal donation limits.

As noted, there is more in Exhibit 1 than I can cover in this letter. I request that it be examined in detail for other potential violations.

## **LEGAL ISSUES**

There appear to be a number of legal issues that need to be examined, as detailed below.

- I. **State Law Issues – Virginia Campaign Finance Disclosure Act: Code of Virginia § 24.2-945. et. seq.**
  - A. **Penalties:** Any person who violates, or aids, abets, or participates in the violation of the Campaign Finance Disclosure Act shall be subject to a civil penalty not to exceed \$100, unless a greater penalty is imposed by this article. In the case of a willful violation, the violator shall be guilty of a Class 1 misdemeanor. Code of Virginia § 24.2-953.

As suggested in # VIII, *supra*, 26 charges for fuel totalling more than \$1600 on a single day is highly incredible. It appears more likely to be a willful effort to account for expenditures while covering their actual use. If the travel figures charged to the SD 10 committee are also as incorrect as they appear to be with incongruous transnational travel, willfulness is also strongly

suggested. Continuing to file reports for months using a deceased man's name as treasurer also suggests willfulness.

- B. Statute of Limitations:** The applicable statute of limitations for prosecution of violations of the Virginia Campaign Finance Disclosure Act is within one year of discovery and no more than three years after commission of the offense. Code of Virginia § 19.2-8.

## II. Federal Law Issues:

### A. Federal Election Campaign Act – Disclosure/Attribution requirements:

- B. Federal Election Campaign Act - Contribution limits** - \$3300 per election and \$5000 per year, per individual donor, and \$2000 per election and \$5000 per year, per candidate campaign committee donor.

### C. Federal Election Campaign Act - violation of contribution limits


- 52 U.S. Code § 30109 (d): Penalties; defenses; mitigation of offenses
  - (1)
    - (A) Any person who knowingly and willfully commits a violation of any provision of this Act which involves the making, receiving, or reporting of any contribution, donation, or expenditure—
      - (i) aggregating \$25,000 or more during a calendar year shall be fined under title 18, or imprisoned for not more than 5 years, or both; or
      - (ii) aggregating \$2,000 or more (but less than \$25,000) during a calendar year shall be fined under such title, or imprisoned for not more than 1 year, or both.

See Sections VII.A and VIII *supra*. It appears McGuire may have spent more than \$8000 of state senate funds on yard signs intended to be used for his congressional race, and \$1600 worth of fuel, plus email expenses. These amounts easily exceed the amount legally contributable by the SD 10 campaign to the CD 5 campaign, even if they were reported on the CD 5 reports as donations, which they apparently are not.

It appears McGuire authorized the significant expenditure for signs, changing from “McGuire for Senate” to “McGuire for Virginia,” a month before ending an uncontested state senate race and beginning his U.S. House race. Without question, he ran emails and made fuel expenditures that were not reported on his CD 5 report, and appear to be misreported as SD 10 expenditures. This appears to be a violation of 52 U.S. Code § 30109 (d)(1)(A)(ii).

I request that your office promptly open a criminal investigation into this multitude of questionable and apparently illegal activities by a major contender for Congress. Please contact me with any questions as may be appropriate.




# How activist Princess Blanding got a boost from a GOP operative

A mysterious group that spent more than \$60,000 promoting third-party candidate Princess Blanding in Virginia's closely contested governor's race is connected to a longtime GOP operative.

The group's treasurer, Thomas Datwyler, also holds that role for a handful of political action committees that have spent hundreds of thousands of dollars supporting GOP politicians ranging from Rep. Jim Jordan (R-OH) to Rep. Marjorie Taylor Green (R-GA). Another PAC connected to Datwyler is reportedly under investigation by the Federal Bureau of Investigation.

There's almost no public information about "Our First Principles Fund," which sent out



promoting Blanding. The group hasn't registered with the Virginia Department of Elections or the Federal Election Commission. It registered as a not-for-profit "exempt" organization in February in Delaware. Its web presence is skeletal and no one answers its listed phone number.

The mystery behind the group highlights what critics say are shortcomings in Virginia's disclosure laws. While lawmakers regularly tout the commonwealth's unlimited-spending campaign finance laws as transparent, there are big loopholes for certain non-profits and other groups if they can claim that their primary focus isn't on Virginia elections, according to Austin Graham, a lawyer with the Campaign Legal Center.

"Virginia overall, the transparency requirements are pretty relaxed," Graham says. "I think this is an example of that."

McAuliffe lost to Republican Glenn Youngkin by over 60,000 votes, according to unofficial results from the Department of Elections. Blanding, who ran a campaign heavily focused on criminal justice reform, garnered around 23,000 votes.

The group filed two disclosures with the Dept. of Elections dated Oct. 26 showing it spent \$62,597 on mailers, and listing Datwyler as treasurer. A group with a nearly identical name -- **First Principle Fund** -- and the same website spent at least \$148,000 attacking Del. Kirk Cox during the GOP gubernatorial nomination fight without filing any state or federal election disclosures.


Datwyler is also named as treasurer for a number of other political groups registered with the Federal Election Commission. The "**Right Women PAC**," for example, spent over \$675,000 promoting Republican House candidates and attacking Democratic opponents during last year's Congressional races. Datwyler's consultancy, **Seven Consulting**, reported over \$1 million in business during the 2020 campaign cycle on the federal level. In Virginia, the consultancy did compliance work as recently as October for Del. John McGuire (R-Goochland).

Datwyler is also listed as the treasurer for a group that is reportedly under investigation from the FBI. Axios reported in May that the bureau is investigating **1820 PAC**, a group that backed U.S. Sen. Susan Collins (R-ME) in her 2020 re-election campaign, for an alleged illegal finance scheme involving a defense contractor. (Axios reported there was no indication Collins knew about the alleged scheme). In 2012, Datwyler was "reprimanded" by administrative judges in Minnesota for violating that state's ban on corporate contributions, according to the Star Tribune.

Datwyler did not respond to phone calls and emails seeking comment.

Virginia law requires groups that receive and spend for the "primary purpose" of advocating for or against a candidate to register with the state and disclose their donors and spending. But that definition can leave out groups like 501(c)(4)'s, "social welfare organizations" that can contribute politically and lobby lawmakers but that spend a majority of their money on civic or charitable activities. That means Virginia voters won't know who is backing organizations that spent hundreds of thousands of dollars in last week's elections largely backing Republicans, including more than \$300,000 from the **American Principles Project** attacking McAuliffe, who lost to Republican Glenn Youngkin, and nearly \$75,000 from the **American Federation for Children** targeting Del. Roslyn Tyler (D-Sussex), who lost her seat last week to Republican Otto Wachsman.

contributions, Virginia and the federal government do not. Nancy Morgan, an organizer with the Virginia chapter of the good governance group *American Promise*, said they're working with Sen. Barbara Favola (D-Arlington) to draft legislation that would increase disclosure requirements.

Democrats in the General Assembly and Gov. Ralph Northam campaigned on tightening Virginia's open-ended campaign finance system. But lawmakers have made no major changes since Democrats flipped the chamber in 2019. A study group met four times and produced a draft report in October recommending some changes to Virginia law, including banning the personal use of campaign dollars. It's not clear where those proposals stand after Republicans gained control of the executive branch and likely the House of Delegates in last week's elections; Morgan said the subcommittee ended with "more of a whimper than a bang" from the perspective of advocates frustrated at the lack of progress, though the report indicated the group may meet in the future.

Governor-elect Youngkin was highly critical of one of Virginia's biggest donors, Dominion Energy, on the campaign trail after the company donated \$200,000 to a secretive group that attacked him from the right. Still, he wouldn't say what his policies toward the state-regulated monopoly might be. The wealthy businessman has said he won't accept his salary as governor and will put at least some of his more than \$300 million in financial holdings in a blind trust. A spokesperson for Youngkin didn't respond to a request for comment on his broader views on campaign finance reform.
