Dear, Office Of General Counsel,

I am reaching out to your office to report what I believe to be fraudulent activity taken by New Coalition PAC. According to the FEC's public data, New Coalition PAC is a Super PAC (Independent Expenditure-Only) with ID C00822288, registered on August 5<sup>th</sup>, 2022. The committee lists the mailing address of 311 New Bern Ave, STE. 27108, Raleigh, NC 77611, and a phone number of (919)749-7679. The President/Treasurer of the PAC is Alexandria Leupen.

I was first introduced to Alexandria Leupen back in late 2023, in and around October of that year. The introduction, and all conversations would occur on X (Formerly Twitter) in a group chat for Political persons. In the time since that introduction Mrs. Leupen has, on multiple occasions, made statements which indicate she is violating FEC reporting requirements. I am aware of Four (4) filings by the FEC alleging that New Coalition PAC had failed to timely file its donation and expenditure information. I am further aware that New Coalition PAC has, since November 15<sup>th</sup>, 2023, been administratively terminated by the FEC.

Despite this termination, Mrs. Leupen has maintained to the public that her PAC is still operating. The PAC website continues to operate a merchandise store and an active ActBlue donation link. According to OpenSecrets, a nonprofit organization which tracks political donation and expenditures, New Coalition has continued to take in donations after its November 15<sup>th</sup> Termination.

In addition to its continued operation Mrs. Leupen has repeatedly mentioned a billboard campaign, made possible by over \$10,000.00 in donations. It is to my knowledge, based on FEC filings and data from OpenSecrets that this campaign donation, and subsequent expenditure, was never reported. The billboard campaign was posted on the PAC's X (Formerly Twitter) account in an October 27, 2023 post.

It is for these reasons that I believe Mrs. Leupen has been operating New Coalition PAC in a fraudulent manner. I have submitted this letter to the best of my knowledge. I have attached in the corresponding email all files which substantiate my complaint.



Dear Treasurer:

Pursuant to 52 U.S.C. §30103(d)(2) of the Federal Election Campaign Act, and Commission regulations at 11 CFR §102.4, the Commission intends to administratively terminate your committee. As such, your committee is no longer obligated to file reports. However, any receipt or disbursement of funds by the committee for the purpose of influencing a Federal election or supporting a federal candidate will void the administrative termination. In such an event, the committee will be required to begin filing reports with the appropriate office. The first such report will include any activity since the date of the last report filed by the committee.

Please note that:

-Excess or residual funds can only be used in accordance with Commission regulations 11 CFR Part 113.

-The administrative termination of your reporting obligation does not relieve the committee of any legal responsibility for the payment of any outstanding debt or obligation, even if those debts are owed to the United States Department of Treasury.

-The committee must continue to maintain all records in accordance with 52 U.S.C. §30102(d) which should be available for Commission inspection should the need arise.

-Any funds used to defray the remaining debts and obligations of the committee must comport with the limitations and prohibitions of the Federal Election Campaign Act of 1971, as amended, and the Commission's regulations.
