Dear Ms. Stevenson,

My name is Erin Matson, and I'm President and CEO of Reproaction. I am writing today to file a complaint against the group Progressive Anti-Abortion Uprising (PAAU) and the campaign of Terrisa Bukovinac for President for what appears to be illegal elections communications.

As seen in the attachment, PAAU, a 501(c)3 organization, sent an email to their list from their [info@paaunow.org](mailto:info@paaunow.org) account fundraising for Terrisa Bukovinac, a founder of PAAU and self-declared Democratic primary presidential candidate who is seeking funds to air political ads. This communication appears to violate Internal Revenue Service guidance on political campaign intervention by 501(c)3 organizations. [1]

It appears that Bukovinac used her ties to PAAU to improperly fundraise for her campaign. While PAAU could have sold their list to Bukovinac for campaign use, they instead utilized their 501(c)3 email to send a fundraising email for a federal candidate; it seems unlikely they would use their organizational account to fundraise for a candidate other than Bukovinac. Additionally, it is unclear if Bukovinac has used her ties to other anti-abortion organizations to distribute similar fundraising appeals or whether Bukovinac paid for this communication to be sent.

I ask that the FEC investigate this potential misconduct by 501(c)3 organization PAAU and its founder, presidential candidate Terrisa Bukovinac.

Dear Friends,
