Some factors to consider in determining whether an organization is engaged in prohibited political activity campaign include:

- a. Whether the good, service or facility is available to candidates in the same election on an equal basis,
- b. Whether the good, service or facility is available only to candidates and not to the general public,
- c. Whether the fees charged to candidates are at the organization's customary and usual rates, and
- d. Whether the activity is an ongoing activity of the organization or whether it is conducted only for a particular candidate.

Hello.

Thank you so much for your assistance with this matter.

In the fall of 2023, Terrissa asked me to find a platform through which we could rent lists from PAAU. We were told by our advisors that the campaign could not purchase lists and that, with list rental, we would not be allowed to look at the emails from the nonprofits we were renting from. We looked at various platforms to see whether they could support this kind of email campaign, but companies like Mail Chimp, Nation Builder, Aenedot, etc. could not support these kind of communications. By January, we asked Robert, our treasurer, to reach out to the FEC to inquire about what platforms they allow candidates to use for this purpose. In the interim, I looked into the FEC and IRS policies regarding a 501(c)(3) organization conduct business activities with a candidate for public office and discovered that there are four conditions that determine whether this is acceptable (which are listed in my preliminary emails with PAAU). This information, in conjunction with what Robert received from the FEC, led us to conclude that it would be acceptable for a 501(c)(3) to send an email on the campaigns behalf so long as it clearly communicated that the email was not an endorsement, and that list rental is an ongoing activity of PAAU, available at the same rate to all candidates in the same election on an equal basis and to the general public at that time.

To corroborate these facts, I attached below Robert's FEC communications and preliminary emails with PAAU (which describe a slightly different deal than the one we settled on that is represented in our contract), and our final signed contract.

Below, I have also included a statement from Robert, our treasurer, detailing his interactions with the FEC.

Robert's Statement (treasurer):

I was tasked by the Campaign in the Fall of 2023 to ask Nationbuilder, the vendor hosting the website and donation landing page, about services they provide in the area of purchasing email contacts to send emails to. They informed me that they had no such service. Additionally, they told me that their embedded email communication tool is only allowed to send to people who opt in — that Nationbuilder's policy precludes sending anything to a rented or purchased list. Because of this, the Campaign never used Nationbuilder's email tool and we continued our research in the future. Between January and April 2024, I was tasked by the campaign to call the FEC Information Division to ask about how to purchase access to contacts. I was told that there are third party companies who offer temporary access to lists of contacts for a standard fee. When asking them about contacting nonprofits to provide this service, I was told that as long as no discount is offered — that we're not cut a break in terms of how much we must pay them — the same arrangement can be made with 501(c)3 organizations as with a company centered on this activity.

This Agreement ("Agreement") is entered into on April 24, 2024, between Progressive Anti-Abortion Uprising ("PAAU") and Bukovinac for President ("Candidate").

1. Purpose of Agreement:

PAAU agrees to send 4 emails to its supporters spread out over the course of the next 6 weeks on behalf of the Candidate with consideration of the IRS rules regarding a section 501(c)(3) organization conducting business activities with a candidate for public office. These emails would not constitute an endorsement of the Bukovinac for President Campaign and would clearly state the following:

"This email does not constitute an endorsement of the Bukovinac for President Campaign by Progressive Anti-Abortion Uprising per the IRS rules regarding a section 501(c)(3) organization conducting business activities with a candidate for public office. List rental is an ongoing activity of this organization, available at the same rate to all candidates in the same election on an equal basis and to the general public at this time."

2. Use of List:

The Candidate agrees to use the rented list exclusively for campaign-related activities, including but not limited to fundraising, outreach, and voter engagement efforts. The Candidate shall not use the list for any other purposes, including commercial or non-political activities. The Candidate will provide PAAU with email copy 24 hours or more before the email is to be sent to the list.

4. Confidentiality:

Candidate agrees to maintain the confidentiality of the rented list and to not disclose, sell, or otherwise distribute the list to any third parties. The Candidate shall take all necessary measures to safeguard the privacy and security of the supporter information contained in the list.

5. Payment:

The Candidate will pay Nonprofit an agreed-upon rate of 20 percent of all proceeds from the use of the supporter list. Payment will be made digitally or via check after the second and fourth emails.

6. Term and Termination:

This Agreement shall commence on the date of execution and shall remain in effect until the completion of the New Jersey Primary on June 4, 2024. Either party may terminate this Agreement with written notice in the event of a material breach by the other party.

To whom it may concern,

Thank you for the opportunity to demonstrate in writing that no action should be taken against PAAU in this situation concerning a complaint against us made this past summer. Here you can find my statement as well as some attached evidence for your consideration.

In 2023, I was contacted by Stephanie Luiz asking if we could discuss the possibility of the Terrisa for President campaign renting PAAU's email list in order to connect with our contacts. Stephanie and I talked at length about the legal regulations and the parameters around this type of activity, and we created a thorough contract to outline the agreement (attached here). After speaking with advisors and reviewing the laws at length, we understood that Terrisa's campaign would not be allowed to access the email addresses, but instead could rent the list and send the content of an email to be sent out by PAAU. I understand that in January the campaign treasurer Robert reached out to the FEC to inquire about what platforms they allow candidates to use for this purpose. Stephanie also looked into the FEC and IRS policies regarding a 501(c)(3) organization conducting business activities with a candidate for public office and discovered that there are four conditions that determine whether this is acceptable, which we discussed and outlined in the contract we drafted. This information, in conjunction with what Robert received from the FEC, led us to conclude that it would be acceptable for a 501(c)(3) to send an email on the campaign's behalf so long as it clearly communicated that the email was not an endorsement, and that list rental is an ongoing activity of PAAU, available at the same rate to all candidates in the same election on an equal basis and to the general public at that time.

I have included a copy of the email communication between myself and Stephanie, which discusses several different options, and I have included the contract that we finally settled on after much research. I believe you can see the caution that I expressed within these communications.

I hope we can quickly resolve this situation and I appreciate your patience and understanding.

"This email does not constitute an endorsement of the Bukovinac for President Campaign by Progressive Anti-Abortion Uprising per the IRS rules regarding a section 501(c)(3) organization conducting business activities with a candidate for public office. List rental is an ongoing activity of this organization, available at the same rate to all candidates in the same election on an equal basis and to the general public at this time."

2. Use of List:

The Candidate agrees to use the rented list exclusively for campaign-related activities, including but not limited to fundraising, outreach, and voter engagement efforts. The Candidate shall not use the list for any other purposes, including commercial or non-political activities. The Candidate will provide PAAU with email copy 24 hours or more before the email is to be sent to the list.

4. Confidentiality:

Candidate agrees to maintain the confidentiality of the rented list and to not disclose, sell, or otherwise distribute the list to any third parties. The Candidate shall take all necessary measures to safeguard the privacy and security of the supporter information contained in the list.

5. Payment:

The Candidate will pay Nonprofit an agreed-upon rate of 20 percent of all proceeds from the use of the supporter list. Payment will be made digitally or via check after the second and fourth emails.

6. Term and Termination:

This Agreement shall commence on the date of execution and shall remain in effect until the completion of the New Jersey Primary on June 4, 2024. Either party may terminate this Agreement with written notice in the event of a material breach by the other party.
