I am writing in response to the complaint filed by the New York Republican State Committee (NYRSC) against Paula Collins and Paula Collins for Congress, dated July 5 and received on July 13, 2024, which alleges violations of 52 U.S.C. § 30114(b) regarding the use of federal campaign funds for personal expenses. We respectfully submit that these allegations are unfounded for the following reasons:

**1. Campaign Operations Across a Large District**

New York's 21st Congressional District is vast, spanning 15 counties and over 15,000 square miles, requiring extensive travel and operational flexibility. Due to the geographical size of the district, it is necessary for Ms. Collins to maintain multiple operational bases, including the Amish Country Inn at 441 Old State Road, Canton, NY 13617. This location serves as one of several critical sites for campaign activities, given the need to engage with constituents across the district effectively. The Amish Country Inn provides an accessible and practical location for meeting with voters and conducting campaign-related activities in the northern part of the district.

**2. Necessity of Multiple Locations for Campaign Efficiency**

The large geographic expanse of NY-21 necessitates using several locations for storing campaign materials and signage within reach of volunteers. For example, the campaign currently utilizes Ms. Collins' law office in NYC as a campaign office, where the social media team works, materials are stored, and phone banking occurs. Ms. Collins does not charge the campaign any

rent for the use of this office. The Canton location is used as a combined office and a place to sleep, equipped with two printers, numerous boxes of signs and campaign literature, and space for staffers to sleep when campaigning in that part of the district. By staying at the campaign headquarters, hotel bills are minimized, ensuring the efficient use of donor funds. Additionally, the campaign uses the Democratic Headquarters in Utica and the Voters for Change Office in Saranac Lake at no cost. Therefore, the expenditure on the Canton office represents a prudent investment of donor dollars, not a personal expense.

### **3. No Personal Salary or Rent Charges**

Ms. Collins has not taken any salary from her campaign funds, nor has she charged the campaign rent for operating out of her office at 251 W. 30th Street, New York, NY 10001. These decisions underscore her commitment to utilizing campaign resources strictly for campaign-related purposes and ensuring that no personal financial gain is derived from these funds. The expenditures related to the Amish Country Inn are solely for campaign use, facilitating necessary operations within the district.

### **4. Amendments to Reflect Headquarters Address**

Recognizing the importance of transparency and compliance, Ms. Collins has amended her prior filings to accurately reflect her campaign headquarters' address at 251 W. 30th Street, New York, NY 10001. This amendment ensures that all official documents accurately represent the campaign's operational base and further demonstrates Ms. Collins' dedication to maintaining regulatory compliance. Attached to this letter are the Amended Pre-Primary Report and the Amended Q2 Report, showing the corrected headquarters address.

### **5. Clarification of Headquarters Locations and Future Expenses**

The campaign has established four headquarters in total:

- The Oneida County Democratic Party headquarters (no charge).
- Voters for Change in Saranac Lake (no charge).
- 251 W. 30th Street, New York, NY 10001 (\$1,400 a month previously charged personally to Ms. Collins).
- 441 Old State Road, DeKalb Junction, NY 13630 (\$1,350 a month previously charged to the campaign).

Going forward, the campaign card will be charged with rent for the NYC headquarters, which is used for phone banking, digital teams, merchandise, and post carding. The rent for the apartment in DeKalb Junction will be paid from personal funds.


If required, Ms. Collins is prepared to re-characterize the funds by withdrawing an amount from the campaign equal to what has been paid towards the apartment rent as a permissible salary expense, and then repaying the campaign the same amount.

## Conclusion

The payments made to White Pillars for the use of the Amish Country Inn are legitimate campaign expenses, necessary for the effective functioning of the campaign within the extensive boundaries of New York's 21st Congressional District. These expenses are in no way personal but are vital for campaign operations and voter engagement.

We respectfully request that the Federal Election Commission consider these clarifications and recognize that Paula Collins for Congress has operated within the bounds of the law, without any intent to use campaign funds for personal benefit. Ms. Collins has always acted in good faith in interpreting the FEC guidelines regarding permissible expenses. The campaign may have misunderstood some provisions, but there was no intent to violate regulations. Ms. Collins is prepared to rectify any oversights, including repaying any funds deemed improperly used.
