COMPLAINT

- Cornel West for President, FEC ID No. Coo843508 ("the West-Abdullah Campaign")
 brings this Complaint pursuant to 52 USC §30109, upon the belief that a violation of
 the Federal Election Campaign Act has occurred and is continuing to occur, for
 which the West-Abdullah Campaign requests an immediate investigation and such
 enforcement action as the Commission may deem warranted by its findings.
- 2. Specifically, the West-Abdullah Campaign has evidence indicating that one or more persons have violated and are continuing to violate 52 USC §30124 ("Fraudulent misrepresentation of campaign authority") by making unauthorized use of the names of the federal candidates Dr. Cornel West, a candidate for President of the United States, and Dr. Melina Abdullah, a candidate for Vice President of the United States, without authorization, to divert and misdirect internet users to the website of Donald J. Trump For President 2024, Inc., FEC ID No. Coo828541 ("the Trump Campaign"), thereby fraudulently misrepresenting themselves as speaking, writing, or otherwise acting on behalf of the West-Abdullah Campaign, and/or willfully and knowingly participating in or conspiring to participate in a plan, scheme, or design for purposes of making such fraudulent misrepresentations.
- 3. The West-Abdullah Campaign cannot determine, and so does not allege, that the misconduct described herein has been or is being committed by the Trump Campaign itself, or even with its knowledge. Indeed, it would be speculative even to presume that the misconduct described herein is necessarily imputable to any supporter of the Trump Campaign, as it is also possible that the misconduct may be intended to falsely implicate the Trump Campaign in a Complaint just like this. The

owners and operators of the deceptive websites at issue cannot be determined by the West-Abdullah Campaign but might be discovered by the Commission. At present, we identify such as-yet-unknown respondents as "John Doe" for purposes of this Complaint. Because it is possible that not just one but two federal campaigns may be the victims of fraudulent misrepresentation in this case so near to Election Day, it is imperative that the Commission expeditiously investigate and determine the true culpable parties, whoever they may be.

RECITATION OF FACTS

- 4. Based upon information and belief, on or about April 10, 2024, one or more unidentified individuals, acting without authorization from the West-Abdullah Campaign, registered the domain names "westabdullah.com", "westabdullah.org", and "westabdullah2024.com" (referred to collectively herein as "the False Domains"). (The West-Abdullah Campaign owns the domain name "westabdullah2024.org".) See Exhibits 1, 2, and 3. This John Doe registrant is not publicly identifiable, as they have opted for an additional privacy service to conceal their identities from public view.
- 5. Each of the unauthorized domain names is set to instantly redirect visitors to the website "www.donaldjtrump.com", the official website of the Trump Campaign, where viewers are immediately presented with a solicitation for contributions. See Exhibit 4. When the solicitation pop-up is cleared, viewers find themselves on the main page of the Trump Campaign's official website. See Exhibit 5.
- 6. Many of the policy positions advocated for by the West-Abdullah Campaign differ substantially from the policy positions advocated for by the Trump Campaign, so the false association of the campaigns is damaging to the West-Abdullah Campaign, causing reputational harm, potential confusion of the electorate, misdirection of would-be donors or volunteers, and the like.

RESPONDENTS

- 7. The Trump Campaign is plainly at least involved in this case, because the unauthorized domain names that falsely misrepresent themselves as associated with and referring to the West-Abdullah Campaign are redirecting traffic from the domain names containing the names of the West-Abdullah Campaign's candidates to the Trump Campaign's official website and a solicitation for contributions to the Trump Campaign.
- 8. However, as noted above, the West-Abdullah Campaign does not allege that the Trump Campaign is responsible, directly or indirectly, for the misconduct described herein. The Trump Campaign may not even be aware of the misconduct, and it is possible that the misconduct is intended to inaccurately suggest the Trump Campaign's involvement.
- Because 52 USC §30124 also prohibits participating or conspiring to participate in a fraudulent misrepresentation scheme like this, we believe it would be prudent for

- the Commission to investigate what knowledge of or involvement with this misconduct the Trump Campaign may have, if any.
- 10. If the Trump Campaign has fraudulently misrepresented itself as speaking, writing, or otherwise acting for or on behalf of the West-Abdullah Campaign by employing the candidates' names without the West-Abdullah Campaign's authorization, thereby damaging the West-Abdullah Campaign by causing reputational harm, confusion of the public, misdirection of donors and volunteers, etc., or if the Trump Campaign has willingly and knowingly participated in or conspired to participate in the plan, scheme, or design to make such a fraudulent misrepresentation, then that conduct is in violation of 52 USC §30124(a) and must be brought to an immediate end, along with such other enforcement measures as the Commission may deem warranted in the circumstances.
- 11. The John Doe unidentified respondents are the individual or individuals who registered the False Domains without authorization from the West-Abdullah Campaign, thereby fraudulently misrepresenting themselves as speaking, writing, or otherwise acting on behalf of the West-Abdullah Campaign, and who, for the apparent purpose of soliciting contributions or donations to the Trump Campaign, caused viewers to the False Domains to be instantly misdirected to a solicitation for contributions to the Trump Campaign.
- The John Doe unidentified respondents also include any individual or individuals who willfully and knowingly participated in or conspired to participate in the plan, scheme, or design to make such fraudulent misrepresentations. The conduct of all such John Doe respondents described in this and the preceding paragraph is in violation of 52 USC §30124(b) and must be brought to an immediate end, along with such other enforcement measures as the Commission may deem warranted in the circumstances.
- 13. GoDaddy.com, LLC is the registrar for the False Domains and is likely to be able to identify the John Doe unidentified respondents to the Commission. See Exhibits 1, 2, and 3.

ACTIONS SOUGHT

- 14. The West-Abdullah Campaign respectfully requests that the Commission immediately investigate the identities of the John Doe respondents, who may be identified by GoDaddy.com, LLC, with whom the False Domains are registered, and that the Commission take such enforcement action against such respondents as may be deemed warranted under the circumstances.
- 15. The West-Abdullah Campaign respectfully requests that the John Doe respondents, once identified, should be immediately enjoined from continuing to engage in the fraudulent misrepresentations described herein, either being ordered to convey the False Domains to the West-Abdullah Campaign, or to cause the domains to redirect viewers to the actual official website of the West-Abdullah Campaign, or to disable the False Domains entirely.

16. The West-Abdullah Campaign respectfully requests that the Commission investigate what connection, if any, the Trump Campaign may have to the fraudulent misrepresentations described herein and, if warranted, to immediately enjoin the Trump Campaign from continuing to engage in the fraudulent misrepresentations described herein, either being ordered to convey the False Domains to the West-Abdullah Campaign, or to cause the domains to redirect viewers to the actual official website of the West-Abdullah Campaign, or to disable the False Domains entirely, and to take such additional enforcement action against the Trump Campaign as may be deemed warranted under the circumstances.


