Complaint – Improper redirection of donation by Act Blue –
inappropriate billing of credit card for wrong campaign

Because of the questions that arose in the aftermath of the June Presidential Debate as to whether the President would remain in race on July 12, 2024 I decided to donate to the Biden presidential campaign on the Act Blue website. To emphasize my desire for him to remain in the race I decided to make this a monthly reoccurring donation. This is the only reoccurring donation I have ever authorized on Act Blue. I have not knowingly authorized an Act Blue donation except in support of Joe Biden. When the President announced he was no longer running for office I assumed that, just like when any other candidate pulls out of a race, the auto donations would stop. There is no longer a campaign to

contribute to. I was wrong. On August 6, 2024 I received a notification from my credit card company that I had been charged the same amount as my contribution donation to President Biden, but that the charge was on behalf of Kamala Harris. (See attached credit card document – 2 pages.) I have never, and will never contribute to Ms. Harris. Therefore, I can only assume that Act Blue took it upon themselves to decide that since I supported President Biden, I automatically support and agree to contribute to Ms. Harris. Nothing could be further from the truth. This, in my opinion, amounts to fraud. How many other people have they done this to? A full investigation needs to be conducted into Act Blue and their practices.
