**Subject: Complaint Regarding Violations of Federal Election Law by Terri Sewell for Congress Committee** 

To Whom It May Concern:

I, Jacob Thomas, hereby file this complaint under oath and affirm that the facts contained herein are true to the best of my knowledge. This complaint is filed against Terri Sewell for Congress (FEC Identification Number: C00458976) for multiple violations of federal election law, specifically in relation to prohibited contributions and improper disclaimers.

# **Allegations:**

The following violations have been committed by the Terri Sewell for Congress Committee:

# 1. Improper Disbursement for Polling Services:

The committee reported a disbursement of \$25,000 to American Airlines on November 7, 2022, purportedly for "Polling." Since American Airlines is not a polling firm, this disbursement raises significant concerns about the actual purpose of the funds. 11 CFR 104.3 requires that all expenditures be properly itemized and classified. This disbursement appears to be misreported and may represent an inappropriate use of campaign funds in violation of federal election law (See Exhibit A).

# 2. Prohibited Contributions to Political Action Committees (PACs):

Under **52** U.S.C. § **30118(a)** and **11** CFR **114.5**, it is prohibited for corporate PACs (separate segregated funds or SSFs) to receive contributions from candidate committees, except in specific circumstances. The Terri Sewell for Congress Committee made multiple prohibited contributions to the following PACs (See Exhibit B):

- MICROSOFT CORPORATION POLITICAL ACTION COMITTEE
- GOOGLE LLC NETPAC

- AT&T Inc. PAC
- AMAZON.COM SERVICES LLC SEPARATE SEGREGATED FUND (AMAZON PAC)

These contributions represent clear violations of the regulations governing how candidate committees may use campaign funds, as outlined in **52 U.S.C. § 30118(a)** and **11 CFR 114.5** regarding corporate contributions. Transfers of funds from candidate committees to corporate PACs are strictly prohibited, and the disbursements made by the Terri Sewell for Congress Committee were improperly classified as legitimate campaign expenses.

# 3. Improper Disclaimers on Campaign Materials:

The Terri Sewell for Congress Committee failed to meet the disclaimer requirements set forth by 11 CFR 110.11 on several of its public communications:

- Campaign Website:
  - The disclaimer on sewellforcongress.com reads "Paid for by Sewell for Congress," which fails to properly identify the official committee name, "Terri Sewell for Congress," and is not enclosed in a box, violating 11 CFR 110.11(c)(2), which requires that disclaimers be clearly visible and enclosed in a box (See Exhibit C).
- Billboards:
  - Campaign billboards promoting Terri Sewell lack the required "Paid for by" disclaimer enclosed in a box, as required by 11 CFR 110.11(c)(2). The disclaimer fails to meet the visibility and enclosure requirements (See Exhibit D).
- Social Media Posts:
  - Numerous social media posts from the committee refer to "Sewell for Congress" instead of the full committee name, "Terri Sewell for Congress," in violation of the disclaimer requirements in 11 CFR 110.11(b)(1) for social media communications (See Exhibit E).

These disclaimers fail to meet FEC standards for transparency and proper disclosure as outlined in the cited sections of 11 CFR 110.11.

# **Requested Action:**

I respectfully request that the Federal Election Commission:

- Initiate proceedings in connection with the misreporting of the \$25,000 disbursement for "Polling" to American Airlines, in violation of 11 CFR 104.3.
- Initiate proceedings for all violations related to prohibited contributions to PACs, in violation of 52 U.S.C. § 30118(a) and 11 CFR 114.5.
- Initiate proceedings for improper disclaimers on the campaign website, billboards, and social media posts, in violation of 11 CFR 110.11, and require the committee to amend its

communications to comply with FEC regulations, including using the correct committee name, proper contrast, and enclosing the disclaimers in a box where required.
