COMPLAINT

1. This complaint is filed pursuant to 52 U.S.C. § 30109(a)(1) seeking an immediate and

thorough investigation into ActBlue's egregious and systemic violations of the Federal Election

Campaign Act ("FECA" or "Act"). The evidence presented herein demonstrates a clear and

urgent need for swift enforcement action against ActBlue for its knowing and willful violations

of federal campaign finance law.

Based on the information detailed below, there is compelling reason to believe that 2.

Respondent ActBlue has repeatedly and flagrantly violated 52 U.S.C. § 30122 by knowingly

permitting its name and platform to be used to effect contributions made by one person in the

name of another, undermining the integrity of our electoral process.

COMPLAINANTS

3. Complainant Mark J. Block¹ ("Mr. Block") is a veteran political strategist and campaign

manager with over 50 years of experience in American politics. Mr. Block served as the chief of

staff and senior advisor for Herman Cain's 2012 presidential campaign, demonstrating his

extensive knowledge of campaign finance regulations and unwavering commitment to

transparency and integrity in political fundraising. As Herman Cain's campaign chief of staff,

Mr. Block's campaign email address was caincos@gmail.com.

- 4. Complainant Citizens Defending Freedom ("CDF") is a nonpartisan non-profit corporation, organized under section 501(c)(3) of the Internal Revenue Code. CDF is committed to protecting the right of citizens to be informed about the activities of government officials, to ensuring transparency and accountability in our system of governance and is committed to resolving breaches of freedom and liberty through local awareness, local light, and local action.
- 5. One of CDF's core missions is ensuring that election activities are free and fair and conducted in accordance with the law. In furtherance of this mission, CDF conducts public engagement, advocacy, and education initiatives to ensure reasonable, common-sense election activities are carried out lawfully to give confidence to the public at large. CDF seeks to ensure that these election activities are carried out in accordance with duly enacted election law and shed light on ambiguity in order for our citizens to maintain trust and confidence in our election outcomes.
- 6. When CDF investigates and discovers violations of the FECA, publicizes campaign finance violators, and files complaints with the FEC, CDF's mission is served by keeping the general public informed on the importance of campaign finance laws and deterring future violations.
- 7. In order to assess whether an individual, candidate, political committee, or other regulated entity is complying with federal campaign finance law, CDF needs the information contained in receipts and disbursements reports that political committees and others must file pursuant to the FECA, 52 U.S.C. § 30104; 11 C.F.R. §§ 104.1–22, 109.10. CDF is hindered in its programmatic activity when an individual, candidate, political committee, or other regulated entity fails to disclose or provides false information in reports required by the FECA. The

proper administration of the FECA's reporting requirements includes mandating that all disclosure reports required by the FECA are properly filed with the FEC with an accurate accounting of any contributions made to an individual, candidate, political committee, or other regulated entity.

RESPONDENT

8. ActBlue is a registered political committee that functions as a conduit for contributions to Democratic candidates and committees. Founded in 2004, ActBlue has processed billions of dollars in political contributions, making it one of the largest and most influential political fundraising platforms in the United States. Its sophisticated operations and vast reach amplify the severity of its alleged violations.

STATEMENT OF FACTS

- 9. Mr. Block has used the name Bernie Cain and continued using the associated email address caincos@gmail.com as an alias for over a decade for privacy concerns. Mr. Block has never used the alias, email address, or any other correlating information to make political donations or to obfuscate requirements under FECA.
- 10. Between May 13, 2024, and October 7, 2024, 386 unauthorized donations totaling \$890.61 were made through ActBlue using Mr. Block's alias "Bernie Cain" and the email address caincos@gmail.com.
- 11. These unauthorized donations were made to 62 different Democratic campaigns and political organizations, including at least 35 donations to the Harris Victory Fund.
- 12. The donations were structured as follows:
 - 86 one-time donations;
 - 234 weekly recurring donations;

- 65 monthly recurring donations.
- 13. The typical donation ranged from \$1 to \$5, with only 4 donations exceeding \$10.00.
- 14. All donations were made using the same American Express card, ending in 4005, expiring in July 2026, with a billing ZIP code of 90403 (Santa Monica, CA).
- 15. The donations list a UPS mailbox address: 1223 Wilshire Blvd., #802, Santa Monica, CA, 90403.
- 16. Mr. Block has no connection to this credit card, UPS mailbox, or ZIP code, and has never authorized their use for political donations.
- 17. Upon investigation, Mr. Block discovered that the UPS location was previously used as a mailing address for "Cain Companies Construction," which was administratively dissolved by the California Secretary of State in 2013. The principal was listed as Bernard L. Cain, Jr., with whom Mr. Block has no connection or relationship.
- 18. Mr. Block made multiple attempts to contact Bernard L. Cain, Jr., including:
 - Sending a package to the UPS Location (delivered on September 12, 2024);
- Sending packages to two residences believed to be associated with Bernard L. Cain, Jr. (one delivered in Colorado on September 16, 2024, and one attempted delivery in California);
- Sending an email to two addresses believed to relate to Bernard L. Cain, Jr. on September 19, 2024.
- 19. Mr. Block has received no response to these attempts at contact.
- 20. Since the first attempt to contact Bernard L. Cain, Jr. on September 12, 2024, an additional 151 unauthorized donations totaling \$303.40 have been made using Mr. Block's information.

- 21. Mr. Block has never used his alias or associated email to make political donations or to circumvent federal reporting requirements.
- 22. Mr. Block did not make, authorize, or consent to any of these donations. Given his political leanings, he would never consider donating to any of the ActBlue-affiliated campaigns or organizations.
- 23. Because these donations were structured to remain under the \$200 reporting threshold, none of the recipient campaigns have reported receiving contributions from "Bernie Cain."
- 24. Mr. Block has expended significant time and resources working with counsel to prepare this FEC filing and to ensure he faces no exposure for these improper donations made in his name.
- 25. CDF, in its role of ensuring transparency and accountability in election activities, is hindered in its programmatic activity when political committees fail to disclose or provide false information in reports required by the FECA.
- 26. Similar to the details provided by Mr. Block, CDF believes it is likely that a persistent and widespread pattern of conduct may be associated with the respondent's activities.
- 27. The true contributors' anonymity on a large scale presents an additional potential issue that should be investigated, as the source of funds used to make contributions may have come from foreign nationals, a group that is categorically prohibited from spending money to influence U.S. elections.

ALLEGED VIOLATIONS OF LAW

28. Under 52 U.S.C. § 30122, "No person shall make a contribution in the name of another person or knowingly permit his name to be used to effect such a contribution, and no person shall knowingly accept a contribution made by one person in the name of another person."

- 29. By processing multiple unauthorized contributions in Mr. Block's name over an extended period, as evidenced by the 386 donations detailed above, ActBlue has knowingly and willfully permitted Mr. Block's name to be used to effect contributions he did not authorize, in clear and direct violation of 52 U.S.C. § 30122.
- 30. The repeated nature of these unauthorized contributions, many set to recur weekly or monthly, demonstrates that ActBlue has either intentionally failed to implement proper safeguards to prevent contributions from being made in the name of another or has deliberately chosen to ignore such safeguards for its own financial benefit.
- 31. Given ActBlue's sophistication and the vast scale of its operations, along with inconsistencies discovery in this complaint, appears to be part of a systemic and potentially willful disregard for federal campaign finance law.

PRAYER FOR RELIEF

WHEREFORE, the Complainants respectfully urge the Federal Election Commission to take immediate and decisive action as follows:

- a) Find reason to believe that ActBlue has violated 52 U.S.C. § 30122;
- b) Conduct an immediate, thorough, and expedited investigation under 52 U.S.C. § 30109(a)(2) into these allegations;
- c) Expand the investigation to determine the full extent of ActBlue's unauthorized contribution scheme, including identifying other potential victims;
- d) Determine that there is probable cause to believe ActBlue has committed serious and repeated violations of FECA;
- e) Order ActBlue to immediately cease and desist from all operations that may result in further violations of FECA;

- f) Impose substantial civil penalties commensurate with the scale and severity of the violations found;
- g) Require ActBlue to implement robust verification processes for all future donations and conduct a thorough review of its existing donor database;
- h) Order ActBlue to provide a full accounting of all unauthorized contributions made using Mr. Block's information and facilitate the return of these funds;
- i) Require ActBlue to notify all potentially affected individuals of the unauthorized use of their personal information for political contributions;
- Mandate that ActBlue establish a dedicated hotline and support system for individuals who believe they may have been victims of unauthorized contributions;
- k) Refer this matter to the Department of Justice for criminal investigation if evidence of knowing and willful violations is found;
- Issue a public report detailing the findings of the investigation and the actions taken by the Commission to address these violations;
- m) Initiate a rulemaking process to strengthen regulations surrounding online fundraising platforms to prevent future similar violations.

The integrity of our democratic process and the faith of the American people in our campaign finance system hang in the balance. Swift and decisive action by the Commission is not just warranted – it is imperative. The Complainants respectfully submit that granting the relief requested herein is necessary to uphold the letter and spirit of FECA and to protect the American public from further exploitation by sophisticated political fundraising operations. To

protect the integrity of our elections and deter future noncompliance, the FEC must hold accountable those who seek to undermine transparency in our elections.


