The Complaint alleges that Dave Giles for Congress and Douglas Wolfe in his official capacity as treasurer (the “Committee”), the principal campaign committee of David V. Giles,<sup>1</sup> a 2024 candidate in Arizona’s 4th Congressional District,<sup>2</sup> did not disclose complete identifying information for several contributors and did not make best efforts to obtain, maintain, and submit the same, totaling \$8,469, in violation of the Federal Election Campaign Act of 1971, as amended (the “Act”).<sup>3</sup> The Complaint characterizes 134 contributions from contributors with the same first and last name and an address outside of Arizona as “suspiciously irregular” and “illegitimate,” alleging that the Committee’s disclosures “appear to be incomplete” and the contributors’ names appear to be “inconsistently spelled.”<sup>4</sup>

1 In Response, Giles and the Committee both state that the Committee’s disclosure reports  
2 contain contributor information “extracted from credit card processing agents” and state that the  
3 Committee “reported the contributions as provided by the processing agents.”<sup>5</sup> The Committee  
4 filed a Termination Report which was accepted as a termination prior to the submission of the  
5 Complaint.<sup>6</sup>

6 Based on its experience and expertise, the Commission has established an Enforcement  
7 Priority System using formal, pre-determined scoring criteria to allocate agency resources and  
8 assess whether particular matters warrant further administrative enforcement proceedings. These  
9 criteria include (1) the gravity of the alleged violation, taking into account both the type of activity  
10 and the amount in violation; (2) the apparent impact the alleged violation may have had on the  
11 electoral process; (3) the complexity of the legal issues raised in the matter; and (4) recent trends in  
12 potential violations and other developments in the law. This matter is rated as low priority for  
13 Commission action after application of these pre-established criteria. Given that low rating, and  
14 apparent low dollar amount at issue, we recommend that the Commission dismiss the Complaint,  
15 consistent with the Commission’s prosecutorial discretion to determine the proper ordering of its  
16 priorities and use of agency resources.<sup>7</sup> We also recommend that the Commission close the file


