COMES NOW, Jay McDonald, and hereby files this complaint against the Alaska Democratic Party ("ADP") for violating 52 USC § 30120 & 11 CFR § 110.11.

Factual Allegations

- 1. The ADP is the state committee of the Democratic National Committee in Alaska.
- The ADP is a political party that works to elect Democrats to public office in Alaska.
- More than 75,000 Alaskans are registered members of the ADP.
- 4. The ADP is a "Political Committee" pursuant to 11 CFR § 100.5.
- The ADP is supporting incumbent Mary Peltola, a registered Democrat, in the 2024 general election for Alaska's lone seat in the United States House of Representatives.
- 6. The ADP has paid for and distributed at least three mailers relevant to this complaint. On each of the mailers, the ADP alleges that Republican candidate Nick Begich "scammed seniors." The mailers both also state that "[a] scam has been reported in your area" and to call 1-877-AK-SCAMS "[i]f you or a loved one has been affected."
- 7. Attached hereto is a recording of a telephone call to 1-877-AK-SCAMS (1-877-257-2267). The number rings to a prerecorded message that begins with "[t]hank you for calling the Nick Begich scammer hotline." The recording identifies Nick Begich as a "congressional candidate."

Complete copies of the relevant mailers are attached to this complaint as Exhibits 1-3.

A copy of the recording is attached to this complaint as Exhibit 4.

- 8. The mailers themselves contain disclaimers that appear to comply with relevant federal law. However, the prerecorded message identified as Exhibit 3 does not contain any identification or disclaimer as required by 52 USC § 30120 and 11 CFR § 110.11.
- 9. Per 11 CFR § 110.11(a) all public communications made by a political committee must include disclaimers.
- 10. Per 11 CFR § 100.26 public communications include: ". . . mass mailing, or telephone bank to the general public, or any other form of general public political advertising."
- 11. Per 11 CFR § 110.11(c)(2)(v), "[a] communication that would require a disclaimer if distributed separately, that is included in a package of materials, must contain the required disclaimer.
- 12. According to the Alaska Division of Elections, there were 273,038 registered voters in Alaska as of October 3, 2024.
- 13. Upon information and belief, the ADP sent the mailers to most, if not all, registered voters in Alaska. As such, it is reasonable to assume that more than 500 people called the number on the mailers and heard the recorded message.³ As such, the ADP's recorded message was a telephone bank that required a disclaimer.
- 14. Moreover, even if the recorded message was not a "telephone bank," it most certainly was a "form of general public political advertising" given that Nick Begich is identified as a congressional candidate on the recording.

Exhibit 3 contains an admission from the ADP that a number of Alaskans have already in fact called the relevant phone number and listened to the recording.

15. Given the foregoing, the message required a disclaimer. Accordingly, given that the recorded message would have required a disclaimer if distributed separately than the mailers, it required a disclaimer on the recording.

RELIEF REQUESTED

- That the FEC immediately issue an order to the ADP mandating that they add a disclaimer to their recorded message.
- 2. That the FEC impose all other such penalties against the ADP as allowed by law.
- That the FEC provide for such other relief as it deems just and proper.
