**Re: *Complaint under 52 U.S.C. § 30120(c) and 11 C.F.R. 110.11(c) for Unlawful "Paid For" Advertising Disclaimers***

Dear Office of General Counsel:

On behalf of Turning Point PAC Inc. ("TPPAC"), I submit the following complaint alleging violations of 52 U.S.C. § 30120(c) and 11 C.F.R. 110.11(c) against Arizona Republicans Who Believe In Treating Others With Respect (the "Arizona Republicans"). I swear under penalty of perjury that I serve as the executive director or TPPAC and am an authorized officer/agent of TPPAC.

Arizona Republicans' various digital billboards expressly advocating for Kamala Harris' election in the Phoenix metropolitan area violate federal law and render this unlawful advertising campaign subject to a Commission enforcement action.

### **Factual Background**

Arizona Republicans launched various digital billboards around the Phoenix metropolitan area beginning on August 26, 2024. According to its website, Arizona Republicans erected nearly 50 digital billboard advertisements along various Phoenix freeways during the August primary election, including along Interstate 10, Interstate 17, Loop 202, Loop 303, and other highly trafficked areas.<sup>1</sup>

The number of billboards dropped to 20 for the following 5 weeks, between September 2 and October 6, 2024. The deployment increased to 35 billboards for the next 3 weeks between October 7 and October 27, 2024— now known as "Phase II" of Arizona Republicans' plan.<sup>2</sup>

The current phase of the plan, "Phase III," consists of 50 billboards deployed between October 28 and November 5, 2024.<sup>3</sup>

Arizona Republicans' website contains a map with all billboard locations:<sup>4</sup>



Each billboard expressly advocates for Kamala Harris' election for President, phrased as either "Arizona Republicans for Harris" or "Arizona Independents for Harris".<sup>5</sup>



Upon information and belief, these digital billboards display the "FOR HARRIS" message for approximately 15 seconds, until another commercial advertisement appears. Upon information and belief, the "FOR HARRIS" message reappears approximately every 1-2 minutes on each digital billboard.

Even when standing stationary below a billboard (or at least, the billboards erected at freeway height), the "paid for" disclaimer is unreadable due to the small font size and the viewer's distance below the billboard. The disclaimer is even further unreadable when accounting for digital pixelation and drivers' inability to see the disclaimer at high rates of speed.

Upon information and belief, Arizona Republicans also placed yard signs on various Phoenix-area public streets:



Yard signs are among the merchandise for sale on Arizona Republicans' website, including T-shirts, posters, bumper stickers, and tote bags—all with express advocacy for Harris' election.<sup>6</sup>

### Legal Argument

#### 1. Violation of 52 U.S.C. § 30120(c) and 11 C.F.R. 110.11(c)

Any person or political committee that makes a disbursement for the purpose of financing public communications expressly advocating the election or defeat of a clearly identified federal candidate must include a disclaimer on any such communication. 52 U.S.C. § 30120(a); 11 C.F.R. 110.11(a)(2).

Section 100.26 defines a public communication to include an "outdoor advertising facility" and "any other form of general public political advertising," like billboards and yard signs. See MUR 7355 (Heller for Senate), First General Counsel's Report at 5 ("The electronic billboard required a disclaimer. First, the billboard is a public communication because it is both an outdoor advertising facility and a general form of public political advertising. Second, the billboard contains express advocacy."); MUR 6861 (Williams, *et al.*), Factual and Legal Analysis at 7 ("billboards [and] yard signs . . . expressly advocated the election of clearly identified federal candidates and therefore qualified as public communications that required proper disclaimers"); MUR 6658 (Unknown Respondents), Second General Counsel's Report at 3 ("Signs, including yard signs, are encompassed within the phrase, 'any other form of general public political advertising[.]'").

Regardless of which medium the public communication is transmitted, all disclaimers must be "of sufficient type size to be clearly readable by the recipient of the communication," 52 U.S.C. § 30120(c), and "must be presented in a clear and conspicuous manner." 11 C.F.R. 110.11(c). A disclaimer is "clear and conspicuous" if it gives adequate notice of the identity of persons who paid for the communication, and the disclaimer's placement is not easily overlooked. 11 C.F.R. 110.11(c); see also MUR 6861 (billboards and yard signs violated disclaimer requirements because they did not "comply with the specifically enumerated size, type, and font requirements set forth in the regulations").

Arizona Republicans' billboards do not meet these advertising standards. Taking into consideration the geographic distance between the billboard and its observers—mostly individuals driving approximately 65 miles per hour (or over) on the freeway—the font size of the disclaimer does not give members of the electorate adequate notice of the organization paying for such communication. And, given the billboard height and digital pixelation effect, the disclaimer on most or all billboards is not even readable by a stationary observer looking up at the sign at a 45-degree angle.

Moreover, the small font size of the disclaimer—in contrast to the large all capital lettering “FOR HARRIS”—diminishes the disclaimer’s readability. It is considerably smaller than the rest of the billboards’ lettering and covers only a small portion of the advertisements’ surface area, leading to the disclaimer being easily overlooked.

For these reasons, Arizona Republicans’ billboards fail the clear and conspicuous standards under 52 U.S.C. § 30120(c) and 11 C.F.R. 110.11(c).

## 2. The Commission Should Initiate An Enforcement Action

The costs are significant. Arizona Republicans’ 48-hour campaign finance report dated September 26, 2024, disclosed spending \$57,134 on digital billboards.<sup>7</sup>

Arizona Republicans’ subsequent 24-hour reports disclosed further spending, which likely included substantial spending on the billboards as well:

- \$127,821 for “advertising” on October 18, 2024.<sup>8</sup>
- \$257,226.62 (in total) for “advertising” on October 26, 2024.<sup>9</sup>
- \$10,588.99 for “advertising” on October 30, 2024.<sup>10</sup>
- \$123,972.77 for “advertising” on October 31, 2024.<sup>11</sup>

Arizona Republicans therefore spent at least \$576,743.38 on its independent expenditure campaign, excluding recognizable costs for yard signs. Upon information and belief, the billboards constituted the core component of Arizona Republicans’ spending.

These costs far exceed *de minimis* levels and are significant enough to warrant the Commission’s enforcement resources in this matter.<sup>12</sup>
