On November 13, 2024, the Commission found reason to believe that 1199 SEIU United Healthcare Workers East Federal Political Action Fund and Helen Schaub in her official capacity as treasurer (the "Committee") violated 52 U.S.C. § 30104(b)(4)(H)(iii) and 30104(g)(1) and 11 C.F.R. § 104.4(a) and 104.4(c), provisions of the Federal Campaign Election Act of 1971, as

amended (the "Act") and the Commission's regulations. The Commission authorized the Office of General Counsel to engage in pre-probable cause conciliation with the Committee and approved a conciliation agreement
