Dear Mr. Jordan:

This response, including attached exhibits, is submitted on behalf of Friends of Connie Mack and Craig Engle, in his official capacity as treasurer (collectively "the Committee"), in the above-referenced matter. We write in response to the complaint filed in this matter on July 20, 2012 by Mr. Clyde M. Collins, Jr. For the reasons set forth herein, we respectfully request that the Commission exercise its prosecutorial discretion and dismiss the complaint.

Mr. Collins's complaint alleges that the Committee violated the Federal Election Campaign Act's (FECA) prohibition on using campaign funds for personal use, including clothing purchases of more than de minimis value. See 2 U.S.C. §§ 439a(b)(1)-(2)(B); 11 C.F.R. § 113.1(g)(1)(i)(C). Specifically, the complaint alleges that the Committee violated the personal use prohibition when a campaign employee purchased clothing at a Brooks Brothers store in Jacksonville, Florida using a campaign credit card.

The pertinent facts are as follows. An individual employed by the Mack campaign made two clothing purchases at the Jacksonville, Florida Brooks Brothers store and charged the purchases to a campaign American Express card. The charges were reported on the Committee's July 15, 2012 Quarterly Report. See Exhibit A. When the error was brought to the Committee's attention on July 17, 2012, the Committee required that the employee immediately reimburse the campaign for the reported charges, as well as additional personal charges uncovered as a result of a review of all charges made by that employee. The employee promptly reimbursed the campaign a total of \$706.82 on July 20, 2012. The Committee disclosed the employee's repayment on its Twelve-Day Pre-Primary Report filed on August 2, 2012. See Exhibit B. Significantly, the complaint in this matter was received by the Committee on July 30, 2012 -

nearly two weeks after the Committee had already taken remedial action with regard to the inappropriate charges.

In similar cases involving alleged violations of the personal use prohibition based on the purchase of clothing with campaign funds, the Commission has repeatedly exercised its prosecutorial discretion and dismissed complaints when the campaign committee was reimbursed as soon as they learned of the alleged violation and/or before a complaint was filed. See, e.g., MUR 6140, First General Counsel's Report at 7. In that matter, the Commission also observed that given the amounts in violation, which ranged from \$145 to \$1,089, any civil penalties would be "so low that it would not merit the further use of Commission resources to pursue this matter." Id. See also Statement of Policy Regarding Commission Action in Matters at the Initial Stage in the Enforcement Process, 72 Fed. Reg. 12545, 12545-56 (March 16, 2007)("[T]he Commission has broad discretion to . . . dismiss matters that do not merit the additional expenditure of Commission resources.").

The same factors militate in favor of dismissal here. As in MUR 6140, the Committee acted immediately as soon as it discovered the charges were inappropriate and had already taken remedial action nearly two weeks *before* it learned that the instant complaint had been filed. The total nruount of the inappropriate charges was only \$706.82. In light of these circumstances, the Committee respectfully requests that the Commission exercise its discretion under *Heckler v. Chaney*, 470 U.S. 821 (1985) and dismiss the referenced complaint.
