Dear Sir or Madam:

I would like to request a formal inquiry into the campaign fundraising activities of the Friends of Don Chairez for Congress Campaign committee (FEC ID# C00337352). My analysis of his FEC reports shows \$27,000 in questionable campaign contributions.

Don Chairez has accepted campaign contributions for the primary election after the September 1st primary election. I understand that FEC rules allow for the receipt of primary contributions after the primary to retire debt incurred by the committee during the primary. However, Chairez reported zero debt on his FEC reports to date. In a recent Las Vegas Sun article (copy included) Chairez's campaign manager claimed \$36,000 in primary debt. This is contrary to any of Chairez's filings.

In Chairez's October Quarterly report he accepted \$1750 for a single individual on September 11, 1998, Chairez listed this as two separate contributions with \$1000 coded as primary and the remainder coded as general. Further, in the October report, Chairez accepted \$10,000 from both the Monday Morning PAC and the NFIB Safe Trust on September 17th, and September 24th respectively. Acceptance of these PAC contributions exceeds the federal limit by \$5000 each. I ask you to request that Chairez return these contributions as they were accepted in violation of FEC rules. Chairez also accepted \$1000 from the Henderson Police Officers Association. This organization is not registered with the FEC as a PAC.

In Chairez's Pre-general report Chairez received at least eight, \$2000 contributions, coding half as general and half as primary. In recent 48-hour notices, Chairez has accepted five, \$2000 individual contributions well after the primary. In addition, Chairez received three contributions from local candidate committees, two state assembly committees, and the county recorder's committee. Each of these committees are not regulated by the FEC and are allowed to receive soft money contributions. I ask you to





request documentation from Chairez indicating that these committees have enough campaign funds from federally permissible sources to cover these contributions.

I also ask the commission to consider both what is listed and what is not. Chairez has shown NO expenditure for office space for his campaign headquarters. He has paid for phones and office supplies, but no expenditure for rent is listed. This could be a potentially huge illegal corporate contribution. I ask the commission to require Chairez to provide proof of who is paying for his headquarters.

I have included an itemization of Chairez's questionable contributions with numerical references to his own FEC reports. Also, I have included copies of recent newspaper articles regarding this very subject.

As a fundraiser, I work with FEC regulation everyday, I know the rules and Don Chairez knows the rules. To date Chairez has returned \$1050 in contributions, which exceeded the federal limits. FEC regulations are logical, reasonable, and easy to follow. Ignorance is NOT a valid excuse.

I feel that the fundraising practices of the Friends of Don Chairez for Congress committee is abhorrent. Congress has passed laws establishing the FEC to write regulations and regulate federal campaigns to level the playing field so that issues and character, not mere money, is what gets people elected. I can't believe a former judge would show such reckless disregard for federal law. Even more infuriating is that such a man wants to be a federal legislator.

I urge the commission to carefully and thoroughly investigate the *Friends of Don Chairez* for Congress committee. I believe that the several items I have listed are only the tip of the proverbial iceberg.



Finances criticized in House race

The latest round of sparring began after the Berkley camp sent out a news release earlier this week accusing Chairez of "campaign finance irregularities." Among the charges are that Chairez violated Federal Election Commission regulations by accepting donations designated for the primary election after Nevada's Sept. 1 primaries, and that several Chairez donors have exceeded contribution limits for the general-election cycle.

The allegations require an understanding of the FEC's somewhat abstruse guidelines. According to the commission, candidates can accept contributions for their primary bids up until the day of the primary election. If candidates receive donations earmarked for the primary after that date, the money can only be used to retire a campaign's debt from the primary election.

The FEC restricts contributions by individuals to \$1,000 and political action committees to \$5,000 for the primary election, and imposes the same ceiling for the general election.

Copies of FEC reports provided by the Berkley campaign show that Chairez received roughly \$20,000 in primary donations after Sept. 1.

But Chairez campaign manager Bob Spretnak said the Republican emerged from the primary \$36,000 in the hole, and that the \$20,000 has been used to cover the debt. The campaign is about \$2,000 shy of paying off the debt entirely, he added.









Spretnak also said that no individuals or PACs exceeded the general-election contribution limit because they designated a portion of the money sent after Sept. 1 for the primary election.

In dismissing the Berkley camp's charges as "nitpicky," Spretnak said the Democrat wants to steer voters away from comments she made last year suggesting that money buys political favors. Chairez has cited those remarks throughout his campaign in questioning Berkley's character.

"Her strategy has been to try to show that every candidate is as ethically-challenged as she is. She's trying to divert attention from her own ethical problems," Spretnak said.

Berkley spokesman Richard Urey portrayed the FEC reports as another example of Chairez's lax bookkeeping, noting Chairez's failure to pay \$2,000 in taxes on time in the mid-1980s. Urey pointed out that the FEC sent four letters to the Chairez campaign from August to October requesting amendments to his contribution and expenditure reports.

"If you can't take care of the business of basic campaign finance forms, it's fair to conclude you can't take care of the more complex business of federal legislation," he said.

Spretnak said Chairez has since complied with the FEC's requests. The filing of amended forms has become virtually routine in political campaigns, FEC spokesman Ian Stirton said.

"It's not unusual for a campaign to get a request for additional information. That's how this process works," he said.
