
To the Office of General Counsel:

This habitual act occurred beginning December 13, 2006 through April 14, 2008, as far as I can tell. I have not given anyone authority to sign my name for any reason whatsoever.


There are also letters sent to my attention, as the Treasurer for the Vernon Jones for Georgia campaign from the Federal Election Commission. These letters were sent to Post Office Box 361360, Decatur, GA 30036 which I am not associated with; therefore I had no idea that my name was being used.

I am requesting immediate action on this matter and would like my name removed or those documents amended to remove my name as the treasurer for the Vernon Jones for Georgia Campaign and any other documents where my signature may have been forged.
