MID-YEAR REPORTS OF NATIONAL PARTY COMMITTEES SHOW REPUBLICAN LEAD

WASHINGTON — The disparate financial condition of the national committees of the two major political parties is continuing, according to the latest reports filed with the Federal Election Commission.

The FEC's compilation of those figures reveals that the Republican party continued its commanding 5 to 1 lead in fundraising during the first six months of 1989, raising \$45 million to the Democrats \$9 million. As they begin the second half of the year, the Republican national committees have cash-on-hand that is more than three times that of the Democrats, with less than a half million dollar debt, compared to two-and-one-half million dollars owed by the Democrats.
