**FEC INDEX
OF

AS DISCLOSED ON REPORTS FILED AS OF OCTOBER 10, 1978**

This Index has been prepared from information contained in the FEC Disclosure Information Computer System, based upon reported activity as disclosed on reports filed as of October 10, 1978, in order to meet the statutory requirement that the Commission issue periodically on a timely pre-election basis, an index of independent expenditures on a candidate-by-candidate basis. (2 U.S.C. 434(e)(3))

All data in this Index is listed as reported by the individual, group, or political committee making the independent expenditures and is subject to change by amendment or FEC audit.

WHAT IS AN EXPENDITURE?

An independent expenditure is, "... an expenditure... for a communication expressly advocating the election or defeat of a clearly identified candidate which is not made with the cooperation or with the prior consent of, or in consultation with, or at the request or suggestion of, a candidate or any agent or authorized committee of such candidate." (11 CFR 109.1(a)).¹ [See 11 CFR 109 for applicable restrictions.]

NOTE: The Federal Election Campaign Act Amendments of 1974 established a \$1,000.00 limitation on independent expenditures. In its January 30, 1976 opinion, *Buckley v. Valeo*, however, the Supreme Court struck down limits on the amount of money which may be spent "independently" to advocate the election or defeat of candidates for federal office.

REPORTING OBLIGATIONS

The Federal Election Campaign Act requires that any "person" or political committee who makes qualified "independent expenditures" aggregating in excess of \$100 during a calendar year must file with the Commission a proper report disclosing all expenditures and itemizing each expenditure in excess of \$100. This itemization must include:

- o The identification of each person to whom the expenditure was made,
- o The amount and date of the expenditure,
- o The name of the candidate with respect to whom the expenditure was made,
- o The office the candidate seeks, and
- o Whether the expenditure was in support of or in opposition to that candidate.

The Commission has prepared two methods by which persons or political committees must report their independent expenditures:

- 1) **Any person**, other than a political committee must report on FEC Form 5 accompanied by a separate statement signed by the person making the expenditure so stating that it was not made in cooperation, consultation, or coordination with the candidate or his or her agent. This separate statement **must be notarized**. Persons must file only for reporting periods during which expenditures are made. The reports are not cumulative.
- 2) **A political committee** must report "independent expenditures" on FEC Schedule E which must be signed by the committee's treasurer and **must be notarized**. All "independent expenditures" must be reported quarterly and during the pre- and post-election periods for which the expenditure was made.²

INCLUDED IN THIS INDEX

1. Listing of candidates for the House and Senate for or against whom independent expenditures have been made.
 - (a) The office which the candidate is seeking
 - (b) The candidate's party
 - (c) In most cases, the election in which the candidate is running
 - (d) The candidate's assigned FEC Identification Number

2. Identification of persons (groups and political committees) making independent expenditures.
 - (a) The FEC assigned Identification Number of the person or political committee
 - (b) The connected organization, if any, of the political committee making the independent expenditure
 - (c) The report type on which the expenditure was disclosed
 - (d) The amount and type (for or against) of the expenditure
 - (e) The date of the expenditure or the coverage dates of the report in which the expenditures occurred
 - (f) The microfilm location of the report or expenditure, as reported
3. The total of independent expenditures for or against each candidate.

NOTE: In the case of an individual making an independent expenditure against a candidate, the amount will be designated by a negative sign (-) after the amount. In most cases, an expenditure against a candidate made by political committees is designated as "Ex Again."

4. This Index does not include expenditures for or against a candidate which may not qualify as "independent expenditures." These may be considered in-kind contributions to the candidate or, in the case of expenditures against a candidate, as in-kind contributions to the opposing candidate. (See 11 CFR 109.1(c)).
